The Scottish Ministers, in exercise of the powers conferred upon them by section 89(1) of the Welfare Reform and Pensions Act 1999(a), hereby make the following Order:

Citation, interpretation and extent

1. This Order may be cited as the Welfare Reform and Pensions Act 1999 (Scotland) (Commencement No. 8) Order 2000.
- (2) In this Order, “Act” means the Welfare Reform and Pensions Act 1999.
- (3) This Order extends to Scotland only.

Appointed day

2. The day appointed for the coming into force of—
 - (a) section 84(1) of the Act so far as relating to paragraph 10 of Schedule 12 to the Act; and
 - (b) paragraph 10 of Schedule 12 to the Act,is 1st December 2000.
