**CONTAMINATION OF FOOD**

**The Food Protection (Emergency Prohibitions)  
(Amnesic Shellfish Poisoning) (West Coast)  
Partial Revocation (No. 6) (Scotland) Order 2000**

*Coming into force in accordance with article 1*

The Scottish Ministers, in exercise of the powers conferred on them by section 1(1) and (2) and section 24(3) of the Food and Environment Protection Act 1985(1), and of all other powers enabling them in that behalf, hereby make the following Order:

**Citation and commencement**

**1.** This Order may be cited as the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) Partial Revocation (No. 6) (Scotland) Order 2000 and shall come into force at 1700 hours on 14th March 2000.

**Interpretation**

**2.** In this Order “the principal Order” means the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (Scotland) Order 1999(2).

**Partial Revocation of the principal Order**

**3.** The principal Order is revoked insofar as it designates any part of Areas 1 and 2 described in the Schedule to this Order being areas within the area bearing the letter A described in paragraph 1 of the Schedule to the principal Order.

## SCHEDULE

Article 3

### AREA 1

The area of sea lying below high water springs enclosed by a line starting at a point on the north shore of Skye at 57°31.9'N 6°30'W; then north to 57°45'N 6°30'W; then east to the mainland at 57°45'N 5°48.7'W; then south along the mainland shore to 57°30'N 5°52'W; then west to the east coast of Raasay at 57°30'N 5°59'W; then north, west and south to a point on the west coast of Raasay at 57°30'N 5°59.5'W; then west to a point on the east coast of Skye at 57°30'N 6°08.9'W; then north, west and south along the coast of Skye to the start point.

### AREA 2

The area of sea lying below high water springs enclosed by a line starting at a point on the south east coast of Skye at Leir Mhaodail at 57°01.2'N 6°W; then south to 57°N 6°W; then east to a point close to Mallaig at 57°N 5°50'W; then east and north along the mainland shore to Garbhan Cosach at 57°15'N 5°38.2'W; then west to a point on the east shore of Skye at 57°15'N 5°39'W; then south and west along the western shore of Skye to the start point.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order is the ninth partial revocation of the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (Scotland) Order 1999 ([S.S.I. 1999/26](#)) (“the principal Order”) which prohibited—

- (a) fishing for or taking scallops within the area designated in the Schedule to that Order (article 4 of the principal Order);
- (b) movement of such scallops out of that area (article 5 of the principal Order); and
- (c) landing, using in the preparation or processing for supply of food of, supplying and other specified activities in relation to, such scallops from the designated area (article 6 of the principal Order).

The effect of this Order is to remove the prohibitions in respect of the areas of sea designated in the Schedule to this Order, which form part of the area of sea designated as Area A in the Schedule to the principal Order.
