The Lords of Council and Session, under and by virtue of the powers conferred on them by section 40 of the Sheriff Courts (Scotland) Act 1907(a), section 6 of the Execution of Diligence (Scotland) Act 1926(b) and of all other powers enabling them in that behalf, do hereby enact and declare:—

Citation and commencement

- **1.**—(1) This Act of Sederunt may be cited as the Act of Sederunt (Fees of Sheriff Officers) 2001 and shall come into force on 1st January 2002.
 - (2) This Act of Sederunt shall be inserted in the Books of Sederunt.

Amendment of fees

- **2.**—(1) Subject to sub-paragraph (2) below, the Table of Fees in the Schedule to this Act of Sederunt shall be substituted for the Table in Schedule 1 to the Act of Sederunt (Fees of Sheriff Officers) 1994(**c**) and shall apply to work carried out by a sheriff officer on or after the date on which this Act of Sederunt comes into force.
- (2) Sub-paragraph (1) above does not affect the fees payable as respects any work so carried out before the date mentioned in that sub-paragraph.
