CONTAMINATION OF FOOD

The Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (No. 13) (Scotland) Order 2002

Made

15th October 2002

Coming into force in accordance with article 1(1)

Laid before the Scottish Parliament

17th October 2002

The Scottish Ministers, in exercise of the powers conferred by section 1(1) and (2) and section 24(3) of the Food and Environment Protection Act 1985(a) and of all other powers enabling them in that behalf, being of the opinion that there exist or may exist circumstances which are likely to create a hazard to human health through human consumption of food and that in consequence food which is derived or may be in the future derived from bivalve molluscs in the areas described in the following Order, is, or may be, or may become, unsuitable for human consumption, hereby make the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (No. 13) (Scotland) Order 2002 and shall come into force at 1600 hours on 15th October 2002.

(2) In this Order—

- (a) “scallops” means scallops of the class of *Pecten maximus*; and
- (b) “relevant time” means 0001 hours on 15th October 2002.

Designated circumstances

2. In the opinion of the Scottish Ministers, scallops in the areas designated in article 3 below may be affected by the toxin which causes amnesic shellfish poisoning in human beings and are likely to create a hazard to human health if they are consumed.

(a) 1985 c.48; section 1(1) and (2) were amended by section 51(2)(a) and (b) of the Food Safety Act 1990 (c.16); section 1(2) defines “designating authority”; section 1 was further amended by the Scotland Act 1998 (Modification of Functions) Order 1999 (S.I. 1999/1756), Schedule, paragraph 10(2) and (3), the Food Standards Act 1999 (c.28), Schedule 5, paragraph 6 and the Scotland Act 1998 (Consequential Modifications) Order 2000 (S.I. 2000/2040), Schedule, Part I, paragraph 12.

Designated areas

3. The areas described in the Schedule to this Order are hereby designated for the purposes of Part I of the Food and Environment Protection Act 1985.

Activity prohibited in the designated areas

4. No person shall fish for or take any scallops in the designated areas.

Prohibited movement of scallops

5. No person shall move any scallops out of the designated areas.

Restrictions

6. No person shall—
- (a) use any scallops taken out of the designated areas after the relevant time in the preparation or processing for supply of food and anything from which food could be derived;
 - (b) land any scallops which were in waters in the designated areas after the relevant time;
 - (c) supply, or have in possession for supply, any scallops which were in the designated areas after the relevant time;
 - (d) supply, or have in possession for supply, any food or anything from which food could be derived in the preparation or processing of which anything was used in contravention of paragraph (a) of this article; or
 - (e) feed to any creature a feeding stuff in the preparation or processing of which anything was used in contravention of paragraph (a) of this article.

SCHEDULE
THE DESIGNATED AREAS

Area 1

The area of sea below mean high water springs enclosed by a line starting from a point at 57°North latitude 6°30'West longitude; then north to 57°15'North latitude 6°30'West longitude; then east to a point on the Isle of Skye at 57°15'North latitude 6°25.6'West longitude; then south and east along the shoreline to 57°11.7'North latitude 6°West longitude; then south to a point on the Skye shoreline at 57°07.2'North latitude 6°West longitude; then south and east along the shoreline to Leir Mhaodail at 57°01.2'North latitude 6°West longitude; then south to 57°North latitude 6°West longitude; then west to a point on the east coast of Rhum at 57°North latitude 6°14.5'West longitude; then north, west and south along the shoreline to 57°North latitude 6°26.7'West longitude; then west to the point of beginning.

Area 2

The area of water below mean high water springs enclosed by a line starting from a point at 56°45'North latitude 6°30'West Longitude; then east to Sanna on the Scottish mainland at 56°45'North latitude 6°11.3'West longitude; then east and south along the mainland shore to 56°42'North latitude 6°West longitude; then south to Auliston Point at 56°39'North latitude 6°West longitude; then south along the shore to 56°37.4'North latitude 6°West longitude; then south to the north coast of Mull at 56°35'North latitude 6°West longitude; then west, south and east along the Mull shore to 56°30'North latitude 6°09'West longitude; then west to 56°30'North latitude 6°30'West longitude; then north to a point on the east coast of Coll at 56°37.4'North latitude 6°30'West longitude; then north and west along the shore of Coll to 56°41.2'North latitude 6°30'West; then north to the point of beginning.

Area 3

The area of water below mean high water springs enclosed by a line starting from a point at 56°North latitude 7°30'West longitude; then north to 58°15'North latitude 7°30'West longitude; then east to 58°15'North latitude 7°West longitude; then south to a point on the west coast of Lewis at 58°14'North latitude 7°West longitude; then south along the shoreline of Lewis to 58°North latitude 7°05.5'West longitude; then west to the point of beginning.

Area 4

The area of water below mean high water springs enclosed by a line starting from a point at 58°North latitude 7°30'West longitude; then east to a point on the shoreline of Harris at 58°North latitude 7°05'West longitude; then south along the shoreline to 57°57'North latitude 7°West longitude; then south to a point on the shoreline of Taransay 57°55.2'North latitude 7°West longitude; then east, south and west along the shoreline to 57°53.3'North latitude 7°West longitude; then south to a point on the shoreline of Harris at 57°51'North latitude 7°West longitude; then west and south along the shoreline to 57°45'North latitude 7°West longitude; then west to 57°45'North 7°30'West longitude then north to the point of beginning.

Area 5

The area of sea below mean high water springs enclosed by a line starting at 57°45'North latitude 7°30'West longitude; then east to 57°45'North latitude 7°West longitude; then south to 57°30'North latitude 7°West longitude; then west to a point on the east coast of Flodaigh Mor at 57°30'North latitude 7°8.8'West longitude; then north and west along the shoreline to 57°30'North latitude 7°9.8'West longitude; then west to a point on the east coast of Ronay at 57°30'North latitude 7°9.9' West longitude; then north and west long the shoreline to 57°30'North latitude 7°11.6'West longitude; then west to a point on the east coast of Grimsay at 57°30'North latitude 7°13.1'West longitude; then north and west along the shoreline to 57°30'North latitude 7°16.3'West longitude; then west to 57°30'North latitude 7°30'West longitude; then north to a point on the shoreline of North Uist at 57°35'North latitude 7°30'West; then east, north and west along the shoreline to 57°38.5'North latitude 7°30'West longitude; then north to the point of beginning.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order, which forms part of Scots law only, contains emergency prohibitions restricting various activities in order to prevent human consumption of food rendered unsuitable for that purpose by virtue of shellfish having been affected by the toxin which causes amnesic shellfish poisoning in human beings.

The Order designates five areas of sea off the west coast of Scotland within which taking scallops is prohibited (articles 3 and 4 and the Schedule). It prohibits the movement of scallops out of those areas (article 5). Other restrictions are imposed in relation to the use of any scallops taken from those areas (article 6).

It is an offence by virtue of section 1(6) of the Food and Environment Protection Act 1985 (“the Act”) as read with Schedule 1, paragraph 4 to the Act as inserted by paragraph 10(13) of the Schedule to the Scotland Act 1998 (Modification of Functions) Order 1999 (S.I. 1999/1756), to contravene any of the prohibitions contained in this Order anywhere in the United Kingdom or in United Kingdom waters.

Under section 21 of the Act the penalty for contravening an emergency prohibition is–

- (a) on summary conviction, a fine of an amount not exceeding the statutory maximum (at present £5,000);
- (b) on conviction on indictment, an unlimited fine, or imprisonment for a term of not more than two years, or both.

Powers of enforcement in relation to emergency prohibitions are conferred by section 4 of, and Schedule 2 to, the Act. Obstruction of enforcement officers is an offence under paragraph 10 of that Schedule.
