**The Borders and Dumfries and Galloway National  
Health Service Trusts (Dissolution) Order 2003**

*Made* - - - - *13th March 2003*

*Coming into force* - - *1st April 2003*

The Scottish Ministers, in exercise of the powers conferred by sections 12A(1) and 105(6) of and paragraph 25(1) of Schedule 7A to the National Health Service (Scotland) Act 1978(1) and of all other powers enabling them in that behalf, having received an application(2) from each of the National Health Service Trusts specified in Schedule 1 to this Order, and after completion of the consultation prescribed(3) under paragraph 25(3) of the said Schedule 7A, hereby make the following Order:

**Citation and commencement**

1. This Order may be cited as the Borders and Dumfries and Galloway National Health Service Trusts (Dissolution) Order 2003 and shall come into force on 1st April 2003.

**Dissolution of NHS Trusts**

2. The National Health Service Trusts specified in Schedule 1 to this Order are hereby dissolved.

**Revocation**

3. The Orders specified in Schedule 2 to this Order are hereby revoked.
