# The Police Grant (Scotland) Order 2005

Made	1st March 2005
Laid before the Scottish	
Parliament	3rd March 2005
Coming into force	1st April 2005

The Scottish Ministers in exercise of the powers conferred by section 32(3) and (5) of the Police (Scotland) Act 1967(1) and of all other powers enabling them in that behalf, hereby make the following Order:

#### Citation, commencement and interpretation

**1.**—(1) This Order may be cited as the Police Grant (Scotland) Order 2005 and shall come into force on 1st April 2005.

(2) In this Order-

"authority" means a police authority (not being a constituent authority) or a joint police board; "financial year 2005 2006" means the period of 12 months commencing on 1st April 2005; and

"police grant" means the grant made under section 32(1) of the Police (Scotland) Act 1967.

#### Aggregate amount of grants for financial year 2005-2006

**2.** The aggregate amount of police grant to be made for the financial year 2005 2006 shall be £518,930,000.

### Amount of grant to an authority for financial year 2005 2006

**3.** The amount of police grant to be made for the financial year 2005 2006 to each authority specified in column 1 of the Table below shall be the amount determined in relation to that authority which is set out in column 2 of that Table opposite to the name of that authority.

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order determines-

- (a) the aggregate amount of grants to be made under section 32(1) of the Police (Scotland) Act 1967 out of money from the Scottish Consolidated Fund for police purposes to all police authorities and joint police boards for the financial year 2005 2006 (article 2); and
- (b) the amount of such grants to be made to each police authority or joint police board (article 3).

The Order also sets out how and when the grant is payable (article 4).
