**The Mental Health (Form of Documents)  
(Scotland) Regulations 2005**

*Made* - - - - *12th September 2005*  
*Laid before the Scottish*  
*Parliament* - - - - *13th September 2005*  
*Coming into force* - - *5th October 2005*

The Scottish Ministers, in exercise of the powers conferred on them by section 325 of the Mental Health (Care and Treatment) (Scotland) Act 2003<sup>(1)</sup>, and of all other powers enabling them in that behalf, hereby make the following Regulations:

**Citation, commencement and interpretation**

1.—(1) These Regulations may be cited as the Mental Health (Form of Documents) (Scotland) Regulations 2005 and shall come into force on 5th October 2005.

(1) In these Regulations—

- (a) “the 2003 Act” means the Mental Health (Care and Treatment) (Scotland) Act 2003; and
- (b) any reference to a numbered section is a reference to the section bearing that number in the 2003 Act.

**Form of documents**

2. Any document required or authorised to be prepared by virtue of a section of the 2003 Act listed in column 1 of Schedule 1 shall contain the particulars set out in the corresponding form listed in column 2 of that Schedule and set out in Schedule 2 and shall be used in the circumstances specified in column 3 of Schedule 1.
