The Diseases of Animals (Approved Disinfectants) Amendment (No. 2) (Scotland) Order 2005

Made - - - - 18th November 2005

Coming into force - - 21st November 2005

The Scottish Ministers, in exercise of the powers conferred by sections 1, 7 and 23(f) and (g) of the Animal Health Act 1981(1), and of all other powers enabling them in that behalf, hereby make the following Order:

Title, commencement and extent

- 1.—(1) This Order may be cited as the Diseases of Animals (Approved Disinfectants) Amendment (No. 2) (Scotland) Order 2005 and shall come into force on 21st November 2005.
 - (2) This Order extends to Scotland only.

Amendments to the Diseases of Animals (Approved Disinfectants) Order 1978

- 2. The Diseases of Animals (Approved Disinfectants) Order 1978(2) is amended as follows—
 - (a) in article 6(2), for "28th February 2005" substitute "20th February 2006"(3);
 - (b) for Schedule 1 to the 1978 Order (approved disinfectants) substitute the Schedule set out in Schedule 1 to this Order; and
 - (c) for Schedule 2 to the 1978 Order (approved disinfectants subject to transitional provisions) substitute the Schedule set out in Schedule 2 to this Order.

- **3.**—(1) In article 2(1) of the Diseases of Animals (Approved Disinfectants) Amendment (Scotland) Order 2003(4), sub paragraphs (e) and (f) are revoked.
- (2) The Diseases of Animals (Approved Disinfectants) Amendment (Scotland) Order 2004(5) is revoked.
- (3) The Diseases of Animals (Approved Disinfectants) Amendment (Scotland) Order 2005(6) is revoked.
