## The National Health Service (Pharmaceutical Services) (Scotland) Amendment (No. 2) Regulations 2006

## Amendment of the National Health Service (Pharmaceutical Services) (Scotland) **Regulations 1995**

- 2. In regulation 2(1) (interpretation) of the National Health Service (Pharmaceutical Services) (Scotland) Regulations 1995(1)-
  - (a) for the definition of "independent nurse prescriber" (2) substitute—
    - ""independent nurse prescriber" means a person-
    - who is registered in the Nursing and Midwifery Register; and
    - against whose name is recorded in that register an annotation signifying that he or she is qualified to order drugs, medicines and appliances as a community practitioner nurse prescriber, a nurse independent prescriber or a nurse independent/supplementary prescriber;";
  - (b) for the definition of "nurses and midwives' professional register" (3) substitute—
    - ""Nursing and Midwifery Register" means the register maintained by the Nursing and Midwifery Council under article 5 of the Nursing and Midwifery Order 2001(4);"; and
  - (c) for the definition of "supplementary prescriber" (5) substitute—
    - ""supplementary prescriber" means a person whose name is registered in-
    - the Nursing and Midwifery Register;
    - the Register of Pharmaceutical Chemists maintained in pursuance of section 2(1) of the Pharmacy Act 1954(6);
    - the register maintained in pursuance of Articles 6 and 9 of the Pharmacy (Northern Ireland) Order 1976(7);
    - the part of the register maintained by the Health Professions Council in pursuance of article 5 of the Health Professions Order 2001(8) relating to
      - chiropodists and podiatrists;
      - (ii) physiotherapists; or
      - (iii) diagnostic or therapeutic radiographers; or
