The M8/A8 Trunk Road (Chapleton Street to Anderson Street, Port Glasgow)
(Temporary 40 mph speed limit) Order 2007

Coming into force

1st May 2007

The Scottish Ministers, in exercise of the powers conferred by section 14(1) and (4) as read with section 2(1) and (2) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling them in that behalf, being satisfied that the traffic on the length of road specified in the Schedule to this Order should be restricted as hereinafter provided because works are being or are proposed to be executed on or near the said length of road and having had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order, hereby make the following Order:

Citation, commencement and cessation

1. This Order may be cited as the M8/A8 Trunk Road (Chapleton Street to Anderson Street, Port Glasgow) (Temporary 40 mph speed limit) Order 2007 shall come into force on 1st May 2007 and shall cease to have effect at midnight on 31st October 2007.

Temporary speed restriction

2. No person shall use or permit the use of any vehicle on the length of road specified in the Schedule to this Order at a speed exceeding 40 mph when a speed restriction is identified as applying to a part or parts of that length of road by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations and General Directions 2002(b).

SCHEDULE

That length of the M8/A8 Edinburgh - Greenock Trunk Road being the unnamed section from opposite Chapleton Street to its junction with Anderson Street, Port Glasgow, a distance of 980 metres or thereby.
