**ROAD TRAFFIC**

The M74 Motorway (Junction 12, Millbank) (Temporary Prohibition of Traffic)  
Order 2007

*Made*

*11<sup>th</sup> May 2007*

*Coming into force*

*16<sup>th</sup> June 2007*

The Scottish Ministers, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling them in that behalf, being satisfied that the traffic on the length of road specified in the Schedule to this Order should be prohibited because works are being or are proposed to be executed on or near the said length of road, and being satisfied that there is an alternative route suitable for traffic which will be affected by this Order, hereby make the following Order:

**Citation, commencement and cessation**

1. This Order may be cited as the M74 Motorway (Junction 12, Millbank) (Temporary Prohibition of Traffic) Order 2007, shall come into force on 16<sup>th</sup> June 2007 and shall cease to have effect at midnight on 1<sup>st</sup> July 2007.

**Prohibition of use of vehicles**

2. Subject to Article 3 of this Order, no person shall use, or permit the use of, any vehicle on the length of road specified in the Schedule to this Order, when such prohibition is identified as applying to any part or parts of the said length of road by means of traffic signs as prescribed by the Traffic Signs Regulations and General Directions 2002(b).

### **Exemption for emergency and works vehicles**

3. No provision of this Order shall apply to a vehicle while being used in an emergency, for fire brigade, coastguard, ambulance or police purposes or a vehicle while being used for carrying out the works.

That length of the M74 Glasgow – Carlisle Motorway being the northbound off-slip road at Junction 12, Millbank to the A70 trunk road, a distance of 584 metres or thereby.
