ROAD TRAFFIC

The M90 Motorway (Junction 7 Milnathort) (Temporary Prohibition of Specified Turns) Order 2007

<i>Coming into force</i>	<i>27th June 2007</i>

The Scottish Ministers make the following Order in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) and of all other powers enabling them to do so.

In accordance with Section 14(1) of that Act, they are satisfied that the traffic on the length of road specified in Part 1 of the Schedule should be prohibited from making any turn specified in Part 2 of the Schedule because works are being or are proposed to be executed on or near the said length of road.

In accordance with Section 14(3) of that Act, they have regard to the existence of an alternative route suitable for traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the M90 Motorway (Junction 7 Milnathort) (Temporary Prohibition of Specified Turns) Order 2007, shall come into force on 27th June 2007 and shall cease to have effect at midnight on 4th July 2007.

Prohibition of use of vehicles

2. Subject to Articles 3 and 4 of this Order, no person shall use, or permit the use of, any vehicle on the length of road specified in Part 1 of the Schedule so as to make any turn specified in Part 2 of the Schedule when such prohibition is identified as applying to any part or parts of the said length of road by means of traffic signs as prescribed by the Traffic Signs Regulations and General Directions 2002(b).

Direction of Police Constable

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

Exemption for emergency and works vehicles

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or a vehicle being used for carrying out the works.

SCHEDULE

PART 1

That length of the M90/A90 Inverkeithing - Fraserburgh Trunk Road being the southbound carriageway from a point 961 metres north of its junction with the southbound off slip road to the M90/A90 Inverkeithing – Fraserburgh Junction 6 Kinross, northwards to a point 1.1 kilometres or thereby north of the M90/A90 Inverkeithing – Fraserburgh Junction 7 Milnathort , a distance of 1.79 kilometres or thereby.

PART 2

- 1) Left turns to the Junction 7 Milnathort southbound off slip road from the M90/A90 Inverkeithing – Fraserburgh Trunk Road southbound carriageway.

PRESS NOTICE

THE M90 MOTORWAY (JUNCTION 7 MILNATHORT) (TEMPORARY PROHIBITION OF SPECIFIED TURNS) ORDER 2007

The Scottish Ministers hereby give notice that on the 15th June 2007, they made the above Order temporarily prohibiting traffic on that length of the M90/A90 Inverkeithing – Fraserburgh Trunk Road being the southbound carriageway from a point 961 metres north of its junction with the southbound off slip road to the M90/A90 Inverkeithing – Fraserburgh Junction 6 Kinross, northwards to a point 1.1 kilometres or thereby north of the M90/A90 Inverkeithing – Fraserburgh Junction 7 Milnathort , a distance of 1.79 kilometres or thereby, from making the following turns:-.

- 1) Left turns to the Junction 7 Milnathort southbound off slip road from the M90/A90 Inverkeithing – Fraserburgh Trunk Road southbound carriageway.

The Order, which is required because works are being or are proposed to be executed on or near the said length of road to allow carriageway surface treatment works to take place, will be in operation from 27th June 2007 until midnight on 4th July 2007, but will only have effect in relation to such part or parts of the said length of road as are indicated by the appropriate traffic signs. The Order does not apply to works vehicles or vehicles being used in an emergency for fire brigade, coastguard, ambulance or police purposes or to acts done with the permission or upon the direction of a police constable in uniform. It is anticipated that the works will be carried out over five days during the above period.

ALTERNATIVE ROUTES
