**ROAD TRAFFIC**

The A82 Trunk Road (Strowanswell Road, Dumbarton)  
(Temporary Prohibition of Specified Turns) Order 2007

*Made*

*14<sup>th</sup> September 2007*

*Coming into force*

*24<sup>th</sup> September 2007*

The Scottish Ministers make the following Order in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984<sup>(a)</sup>, and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in Part 1 of the Schedule should be prohibited from making any turn specified in Part 2 of the Schedule because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act they are satisfied that there is an alternative route suitable for traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A82 Trunk Road (Strowanswell Road, Dumbarton) (Temporary Prohibition of Specified Turns) Order 2007 and shall come into force on 24th September 2007 and shall cease to have effect at midnight on 17<sup>th</sup> December 2007.

**Prohibition of use of vehicles**

2. Subject to Articles 3 and 4 of this Order, no person shall use, or permit the use of, any vehicle on the lengths of road specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule to this Order when such prohibition is identified as applying to any part or parts of the said lengths of road by means of traffic signs as prescribed by the Traffic Signs Regulations and General Directions 2002<sup>(b)</sup>.

### **Direction of Police Constable**

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

### **Exemption for emergency and works vehicles**

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, ambulance, coast guard or police purposes or a vehicle being used for carrying out the works.

## SCHEDULE

### Part 1

That length of the A82 Dalnotter – Inverness Trunk Road at its junction with Strowanswell Road, Dumbarton, a distance of 25 metres or thereby.

### Part 2

1. All Right turns from the A82 Dalnotter – Inverness Trunk Road northbound carriageway to Strowanswell Road, Dumbarton.
2. All Right turns from Strowanswell Road, Dumbarton to the northbound carriageway of the said A82 Dalnotter – Inverness Trunk Road.
