ROAD TRAFFIC

The A78 Trunk Road (Wemyss Bay) (30 mph and 40 mph Speed Limit) Order 2007

The Scottish Ministers, in exercise of the powers conferred by section 84(1)(a) as read with section 124(1)(d) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling them in that behalf, and having complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b), hereby make the following Order:

Citation and Commencement

1. This Order may be cited as the A78 Trunk Road (Wemyss Bay) (30 mph and 40 mph Speed Limit) Order 2007 and shall come into force on 16th February 2007.

Restriction of Speed

2. No person shall drive any motor vehicle at a speed exceeding 30 mph on the length of road specified in Part 1 of the Schedule to this Order.

3. No person shall drive any motor vehicle at a speed exceeding 40 mph on the length of road specified in Part 2 of the Schedule to this Order.

4. These restrictions shall apply only to the part or parts of the said lengths of road by means of traffic signs as prescribed by the Traffic Signs Regulations and General Directions 2002(c).

SCHEDULE

PART 1

30 MPH SPEED RESTRICTION

That length of the A78 Greenock – Prestwick Trunk Road at Wemyss Bay from a point 68 metres or thereby north of the extended centre line of Kishorn Road to the extended centre line of Station Road, a distance of 1310 metres or thereby.

PART 2

40 MPH SPEED RESTRICTION

That length of the A78 Greenock – Prestwick Trunk Road at Wemyss Bay from a point 178 metres or thereby north of the extended centre line of Ardgowan Road to a point 68 metres or thereby north of the extended centre line of Kishorn Road, a distance of 780 metres or thereby.
