#### Amendment of regulation 2

(e) after the definition of “Council Regulation 1251/1999” insert

““Council Regulation 146/2008” means Council Regulation (EC) No. 146/2008 amending Regulation (EC) No 1782/2003 establishing common rules for direct support schemes under the common agricultural policy and establishing certain support schemes for farmers and Regulation (EC) No 1698/2005 on support for rural development by the European Agricultural Fund for Rural Development (EAFRD);”.

## **Amendment of regulation 6**

2. Omit regulation 6 (10 month period), and insert–

### **“Date eligible land must be at farmer’s disposal**

**6.** For the purposes of Article 44(3) of Council Regulation 1782/2003 (declaration of parcels corresponding to the eligible hectare accompanying any payment entitlement), parcels must be at the farmer’s disposal on 15th May in the year of the aid application.”.
