**The Debt Arrangement Scheme (Scotland) Revocation
Regulations 2009**

The Scottish Ministers make the following Regulations in exercise of the powers conferred by sections 2(3), 4(5), 5(4), 6(1), 7 and 62(2) of the Debt Arrangement and Attachment (Scotland) Act 2002(a) and all other powers enabling them to do so.

Citation and commencement

1. These Regulations may be cited as the Debt Arrangement Scheme (Scotland) Revocation Regulations 2009 and come into force on 25th June 2009.

2. The Debt Arrangement Scheme (Scotland) Amendment Regulations 2009(b) are revoked.
