ROAD TRAFFIC

The M80/A80 Trunk Road (Hornshill to Haggs) (Temporary Prohibition of Traffic) Order 2009

<i>Made</i>	<i>24 November 2009</i>
<i>Coming into force</i>	<i>30 November 2009</i>

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 14(1) and (4), 2(1) and (2) and 4(1) of the Road Traffic Regulation Act 1984(a), and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the lengths of road specified in the Schedule should be prohibited because works are being or are proposed to be executed on or near the said lengths of road.

In accordance with section 14(3) of that Act, they are satisfied that there are alternative routes suitable for traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the M80/A80 Trunk Road (Hornshill to Haggs) (Temporary Prohibition of Traffic) Order 2009, comes into force on 30 November 2009 and ceases to have effect at midnight on 30 May 2011.

Prohibition of use of vehicles

2. Subject to article 3 of this Order, no person shall use, or permit the use of, any vehicle on the lengths of road specified in the Schedule, when such prohibition is identified as applying to any part or parts of the said lengths of road by means of one or more of the traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(b).

Exemption for emergency and works vehicles

3. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or a vehicle being used for carrying out the works.

3. That length of the M80/A80 Glasgow-Stirling Trunk Road being the northbound off slip road at the A80-Westfield Link Road, a distance of 140 metres or thereby.
4. That length of the M80/A80 Glasgow-Stirling Trunk Road being the northbound off slip road at the A8011 Cumbernauld, a distance of 803 metres or thereby.
5. That length of the M80/A80 Glasgow-Stirling Trunk Road being the northbound off slip road at Auchenkilns, a distance of 300 metres or thereby.
6. That length of the M80/A80 Glasgow-Stirling Trunk Road being the northbound on slip road at Auchenkilns, a distance of 386 metres or thereby.
7. That length of the M80/A80 Glasgow-Stirling Trunk Road being the northbound off slip road at Old Inns, a distance of 425 metres or thereby.
8. That length of the M80/A80 Glasgow-Stirling Trunk Road being the northbound on slip road at Old Inns, a distance of 440 metres or thereby.
9. That length of the M80/A80 Glasgow-Stirling Trunk Road being the northbound on slip road at Castlecary, a distance of 490 metres or thereby.
10. That length of the M80/A80 Glasgow-Stirling Trunk Road being the northbound off slip road at Junction 4 (Haggs), a distance of 120 metres or thereby.
11. That length of the M80/A80 Glasgow-Stirling Trunk Road being the northbound on slip road at Junction 4 (Haggs), a distance of 440 metres or thereby.
12. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound off slip road at Junction 4 (Haggs), a distance of 280 metres or thereby.
13. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound on slip road at Junction 4 (Haggs), a distance of 290 metres or thereby.
14. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound off slip road at Castlecary, a distance of 420 metres or thereby.
15. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound off slip road at Cumbernauld, a distance of 566 metres or thereby.
16. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound on slip road at Cumbernauld, a distance of 390 metres or thereby.
17. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound off slip road at Dullatur, a distance of 363 metres or thereby.
18. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound on slip road at Dullatur, a distance of 299 metres or thereby.
19. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound off slip road at Auchenkilns, a distance or 600 metres or thereby.
20. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound on slip road at Auchenkilns, a distance of 340 metres or thereby.

21. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound on slip road at Lowwoods, a distance of 386 metres or thereby.

22. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound off slip road at Mollinsburn, a distance of 220 metres or thereby.

23. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound on slip road at Mollinsburn, a distance of 187 metres or thereby.

24. That length of the M80/A80 Glasgow-Stirling Trunk Road being the southbound off slip road at the M73, a distance of 415 metres or thereby.

THE M80/A80 TRUNK ROAD (HORNSHILL TO HAGGS) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2009

The Scottish Ministers give notice that they have made the above Order temporarily prohibiting traffic on the following lengths of the M80/A80 Glasgow-Stirling Trunk Road:

1. the northbound off slip road at Hornshill, a distance of 921 metres or thereby.
2. the northbound on slip road at Hornshill, a distance of 574 metres or thereby.
3. the northbound off slip road at the A80-Westfield Link Road, a distance of 140 metres or thereby.
4. the northbound off slip road at the A8011 Cumbernauld, a distance of 803 metres or thereby.
5. the northbound off slip road at Auchenkilns, a distance of 300 metres or thereby.
6. the northbound on slip road at Auchenkilns, a distance of 386 metres or thereby.
7. the northbound off slip road at Old Inns, a distance of 425 metres or thereby.
8. the northbound on slip road at Old Inns, a distance of 440 metres or thereby.
9. the northbound on slip road at Castlecary, a distance of 490 metres or thereby.
10. the northbound off slip road at Junction 4 (Haggs), a distance of 120 metres or thereby.
11. the northbound on slip road at Junction 4 (Haggs), a distance of 440 metres or thereby.
12. the southbound off slip road at Junction 4 (Haggs), a distance of 280 metres or thereby.
13. the southbound on slip road at Junction 4 (Haggs), a distance of 290 metres or thereby.
14. the southbound off slip road at Castlecary, a distance of 420 metres or thereby.
15. the southbound off slip road at Cumbernauld, a distance of 566 metres or thereby.
16. the southbound on slip road at Cumbernauld, a distance of 390 metres or thereby.
17. the southbound off slip road at Dullatur, a distance of 363 metres or thereby.
18. the southbound on slip road at Dullatur, a distance of 299 metres or thereby.
19. the southbound off slip road at Auchenkilns, a distance of 600 metres or thereby.
20. the southbound on slip road at Auchenkilns, a distance of 340 metres or thereby.
21. the southbound on slip road at Lowwoods, a distance of 386 metres or thereby.
22. the southbound off slip road at Mollinsburn, a distance of 220 metres or thereby.
23. the southbound on slip road at Mollinsburn, a distance of 187 metres or thereby.
24. the southbound off slip road at the M73, a distance of 415 metres or thereby.

The Order, which is required because works are being or are proposed to be executed on or near the said lengths of road to allow the construction of the M80 Stepps to Haggs Upgrade to take place, will be in operation from 30 November 2009 until midnight on 30 May 2011, but will only have effect in relation to such lengths of road as are indicated by the appropriate traffic signs. The Order does not apply to vehicles being used in an emergency for fire brigade, coastguard, ambulance or police purposes, or vehicles being used to carry out the works.
