**The A956 (Aberdeen Western Peripheral Route) Trunk Road
Order 2010**

Approved by the Scottish Parliament

Made - - - - 14th January 2010

Laid before the Scottish Parliament 15th January 2010

Coming into force - - 31st March 2010

The Scottish Ministers make the following Order in exercise of the powers conferred by section 5(2) of the Roads (Scotland) Act 1984(a) and all other powers enabling them to do so.

In accordance with section 5(2) of that Act, they have taken into consideration the requirements of local and national planning, including the requirements of agriculture and industry and are satisfied as to expediency.

In accordance with section 20A(b) of that Act, they have determined that the project falls within Annex I to Council Directive 85/337/EEC(c), as relevantly amended by Council Directive 97/11/EC(d) and Council Directive 2003/35/EC(e), on the assessment of the effects of certain public and private projects on the environment.

In accordance with section 20A(2) of that Act, they have prepared an environmental statement and published notice of it on 11th September 2007, and have complied with all other provisions of section 20A of that Act.

This Order is made in accordance with the provisions of Parts I and III of Schedule 1(f) to that Act.

Citation and commencement

1. This Order may be cited as the A956 (Aberdeen Western Peripheral Route) Trunk Road Order 2010 and comes into force on the 28th day after the day on which it is approved by resolution of the Scottish Parliament.

Trunk road

2. The length of road which the Scottish Ministers propose to construct along the route described in the Schedule shall become trunk road on the date this Order comes into force.

SCHEDULE
TRUNK ROAD
INTERPRETATION

Article 2

In this Schedule—

“the plan” means the plan numbered RYC/G109/13/0713 entitled “The A956 (Aberdeen Western Peripheral Route) Trunk Road Order 2010”, signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF; and

“point 1” means the existing junction between Cove Road (U186K) and the Old Wellington Road (C8K), Aberdeen shown marked “point 1” on the plan.

THE ROUTE OF THE NEW TRUNK ROAD

From a point 585 metres or thereby west of point 1 in a generally east, north-easterly direction for a distance of 210 metres or thereby to a point 430 metres or thereby west, north-west of point 1, as shown by a heavy black line between points marked “point A” and “point B” on the plan.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order provides that the length of road described in the Schedule, shall become trunk road on the date this Order comes into force.

As such the roads authority for the length of road will be the Scottish Ministers.

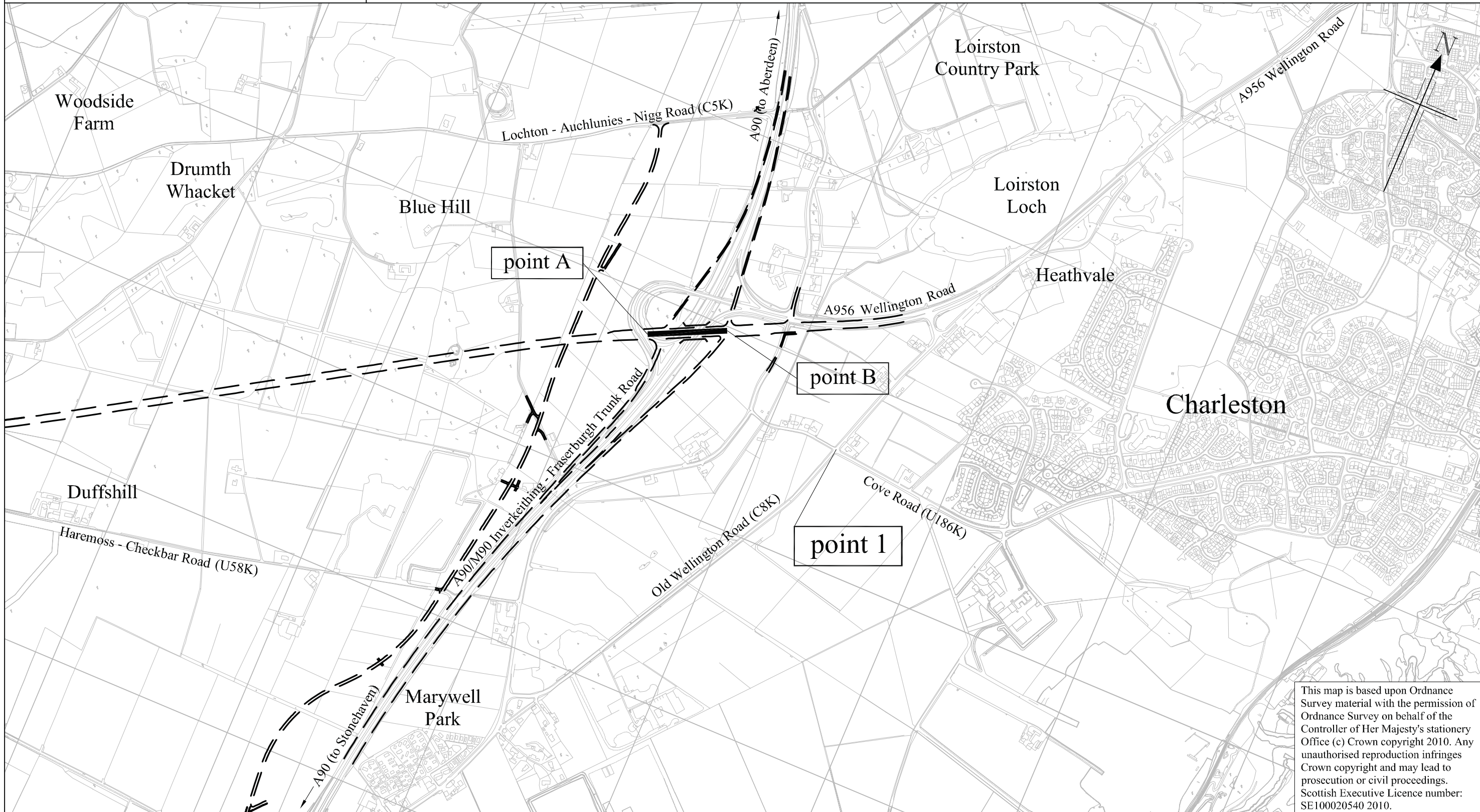

-  ASSOCIATED ABERDEEN WESTERN PERIPHERAL ROUTE ROAD PROPOSALS

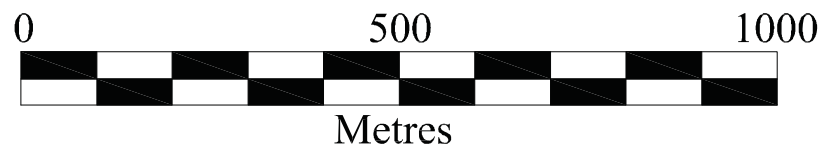
This plan shows the line of the new trunk road but does not represent the widths or levels of the proposed roads, or the land to be occupied by them.
