The Scottish Ministers make the following Regulations in exercise of their powers conferred by section 2(2) of the European Communities Act 1972(1).

Citation, commencement, interpretation and extent

- 1.—(1) These Regulations may be cited as the Public Contracts and Utilities Contracts (Scotland) Amendment Regulations 2012 and come into force on the 1st May 2012.
 - (2) In these Regulations—
 - (a) "Public Contracts Regulations" means the Public Contracts (Scotland) Regulations 2012(2); and
 - (b) "Utilities Contracts Regulations" means the Utilities Contracts (Scotland) Regulations 2012(3).
 - (3) These Regulations extend to Scotland only.

Amendment of the Public Contracts Regulations

- **2.**—(1) The Public Contracts Regulations are amended as follows.
- (2) In Schedule 1 (GPA Annex 1 Contracting Authorities)—

- (a) for "Scotland, General Register Office" substitute "Scotland, National Records of Scotland";
- (b) for "Crofters Commission" substitute "Crofting Commission";
- (c) after the entry for "Scottish Law Commission" insert "Common Services Agency";
- (d) for "Special Health Boards constituted under section 2 of the National Health Service (Scotland) Act 1978(4)" substitute "Health Boards and Special Health Boards constituted under section 2 of the National Health Service (Scotland) Act 1978";
- (e) before the entry for "the Office of the Accountant of Court" insert "Health Improvement Scotland"; and
- (f) omit "Scottish Record Office".

Amendment of the Utilities Contracts Regulations

- **3.**—(1) The Utilities Contracts Regulations are amended as follows.
- (2) In Schedule 5 (Consequential Amendments and Revocations)—
 - (a) in Part A, in the entry regarding S.S.I. 2008/376, in column 3, for "the Public Contracts (Scotland) Regulations 2006", substitute "the Utilities Contracts (Scotland) Regulations 2006"; and
 - (b) in Part B, in the entry regarding S.I. 2011/1848, in column 3, after "the Utilities Contracts (Scotland) Regulations" where it first appears, insert "2006".
