## The Housing (Scotland) Act 2006 (Repayment Charge and Discharge) Amendment Order 2015

The Scottish Ministers make the following Order in exercise of the powers conferred by section 174 of the Housing (Scotland) Act 2006(1) and section 102 of the Housing (Scotland) Act 2014(2) and all other powers enabling them to do so.

#### **Citation and commencement**

**1.** This Order may be cited as the Housing (Scotland) Act 2006 (Repayment Charge and Discharge) Amendment Order 2015 and comes into force on 11th May 2015.

## Amendment of the Housing (Scotland) Act 2006 (Repayment Charge and Discharge) Order 2007

**2.** In Schedule 1 to the Housing (Scotland) Act 2006 (Repayment Charge and Discharge) Order 2007(**3**) from "payable in thirty" to the end of that Schedule substitute—

In default of such payment each instalment toger respect of that instalment under section  $172(6A 2006(\mathbf{a}))$  is separately recoverable as a debt.
