**ROAD TRAFFIC**

**The M90/A90 Trunk Road (Maconochie Road, Fraserburgh)  
(30mph Speed Limit) Order 2015**

*Made* - - - - *17th June 2015*

*Coming into force* - - *24th June 2015*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 84(1)(a) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 84(2) of that Act(b), the Scottish Ministers have given public notice of their intention to make the following Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(c).

**Citation and commencement**

1. This Order may be cited as the M90/A90 Trunk Road (Maconochie Road, Fraserburgh) (30mph Speed Limit) Order 2015 and comes into force on 24th June 2015.

**Speed restriction**

2. No person may drive any motor vehicle at a speed exceeding 30 miles per hour on the length of road specified in the Schedule to this Order.

**Revocation**

3. The Aberdeen-Fraserburgh Trunk Road (A92) (Maconochie Road, Fraserburgh) (40mph Speed Limit) Order 1992(d) is revoked.

## **Exemption**

4. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011<sup>(a)</sup> when used in accordance with regulation 3(5) of those Regulations.

## SCHEDULE

Article 2

### SPECIFIED LENGTH OF ROAD

The M90/A90 Edinburgh - Fraserburgh Trunk Road from its junction with Links Road, Fraserburgh in a southerly direction on Maconochie Road to the north side of the roundabout with the B9033 South Harbour Road, a total distance of 935 metres or thereby.
