**ROAD TRAFFIC**

**The A78 Trunk Road (Largs) (Temporary Prohibition of Specified Turns) Order 2016**

*Made* - - - - 28th September 2016

*Coming into force* - - 7th October 2016

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A78 Trunk Road (Largs) (Temporary Prohibition of Specified Turns) Order 2016, comes into force on 7th October 2016 and ceases to have effect on 11th October 2016.

**Prohibition of specified turns**

2. No person may use, or permit the use of, any vehicle on the length of road specified in Part 1 of the schedule of this Order so as to make any turn specified in Part 2 of the schedule when a prohibition is identified as applying to that length of road by means of the traffic sign described in item 7 (diagram 612 – no right turn for vehicular traffic) and item 8 (diagram 613 – no left turn for vehicular traffic) of the sign table in Part 2 of schedule 3 of the Traffic Signs Regulations and General Directions 2016(b).

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

### **Exemptions**

**3.** No prohibition imposed by this Order applies to—

- (a) a vehicle while being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
- (b) a vehicle being used for carrying out the works.

## SCHEDULE

Article 2

### PART 1

#### SPECIFIED LENGTH OF ROAD

That length of the A78 Greenock – Prestwick Trunk Road known as Irvine Road, Largs from its junction with East Castle Avenue to its junction with Blackdales Avenue, a distance of 157 metres or thereby.

### PART 2

#### SPECIFIED TURNS

1. All right turns from the A78 to Charles Street, Largs.
2. All left turns from the A78 to Charles Street, Largs.
