The Utilities Contracts (Scotland) Regulations 2016

Made - - - 26th January 2016 Laid before the Scottish

Parliament - - - 28th January 2016

Coming into force in accordance with regulation 1

The Scottish Ministers make the following Regulations in exercise of the powers conferred by section 2(2) of, and paragraph 1A of Schedule 2 to, the European Communities Act 1972(1) and all other powers enabling them to do so.

These Regulations make provision for a purpose mentioned in that section and it appears to the Scottish Ministers that it is expedient for the following EU instruments to be construed as references to those EU instruments or provisions of those EU Instruments (as appropriate) as amended from time to time where they are expressly mentioned as such in these Regulations—

- (a) Council Regulation (EEC) No 2913/92 establishing the Community Customs Code(2);
- (b) Directive 1999/93/EC of the European Parliament and of the Council on a Community framework for electronic signatures(3);
- (c) Regulation (EC) No. 2195/2002 of the European Parliament and of the Council on the Common Procurement Vocabulary(4);
- (d) Directive 2004/39/EC of the European Parliament and of the Council on markets in financial instruments amending Council Directives 85/611/EEC and 93/6/EEC and Directive 2000/12/EC of the European Parliament and of the Council and repealing Council Directive 93/22/EEC(5);
- (e) Commission Decision 2009/767/EC setting out measures facilitating the use of procedures by electronic means through the points of single contact under Directive 2006/123/EC of the European Parliament and of the Council on services in the internal market (notified under document C(2009) 7806)(6);
