ROAD TRAFFIC

**The A887 and A82 Trunk Road (Invermoriston to Inverness)
(Temporary Prohibition on Use of Road) Order 2017**

Made - - - - *13th June 2017*

Coming into force - - *28th June 2017*

The Scottish Ministers make the following Order in exercise of the powers conferred by section 62(1) of the Roads (Scotland) Act 1984(a) and all other powers enabling them to do so.

In accordance with section 62(1) of that Act, they are of the opinion that considerations of public safety and convenience require that traffic should be temporarily prohibited on the lengths of road specified in the schedule while filming of the road takes place.

Citation, commencement and cessation

1. This Order may be cited as the A887 and A82 Trunk Road (Invermoriston to Inverness) (Temporary Prohibition on Use of Road) Order 2017, comes into force on 28th June 2017 and ceases to have effect on 4th July 2017.

Prohibition on use of road

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the schedule of this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 8 (diagram 7105 – position of barrier to mark length of road closed or to guide traffic past an obstruction) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016(b).

Exemption

3. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or

- (b) a vehicle being used in connection with the filming of the road; or
- (c) a vehicle being used in connection with the placing of the required signage.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

1. That length of the A887 Invermoriston – Moriston Trunk Road from its junction with the A82 Dalnottar – Inverness Trunk Road westwards to a point 150 metres or thereby west of that junction, a distance of 150 metres or thereby.
2. That length of the A82 Dalnottar – Inverness Trunk Road known as Glenurquhart Road, Inverness from a point about 100 metres or thereby southwest of its junction with Bught Drive to a point about 100 metres or thereby northeast of that junction with Bught Drive, Inverness, a distance of 200 metres or thereby.
