**ROAD TRAFFIC**

**The M876/A876 Trunk Road (Kincardine) (Temporary  
Prohibition of Specified Turns) Order 2017**

*Made* - - - - *8th February 2017*

*Coming into force* - - *17th February 2017*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the M876/A876 Trunk Road (Kincardine) (Temporary Prohibition of Specified Turns) Order 2017, comes into force on 17th February 2017 and ceases to have effect on 14th April 2017.

**Prohibition of specified turns**

2. No person may use, or permit the use of, any vehicle on the length of road specified in Part 1 of the schedule of this Order so as to make any turn specified in Part 2 of the schedule when a prohibition is identified as applying to that length of road by means of an appropriate traffic sign of the type described in item 7 (diagram 612 – no right turn for vehicular traffic) of the sign table in Part 2 of schedule 3 of the Traffic Signs Regulations and General Directions 2016(b).

### **Exemptions**

**3.** No prohibition imposed by this Order applies to—

- (a) a vehicle while being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
- (b) a vehicle being used for carrying out the works.

## SCHEDULE

Article 2

### PART 1

#### SPECIFIED LENGTH OF ROAD

That length of the M876/A876 Dennyloanhead – Kilbagie Roundabout Trunk Road, on the road known as the North Approach Road, from a point 390 metres or thereby south of its junction with the A977 Longannet Roundabout – Gartarry Roundabout Trunk Road southwards to its junction with the A985 Kincardine – Rosyth Trunk Road, a distance of 14 metres or thereby.

### PART 2

#### SPECIFIED TURNS

All right turns from the southbound M876/A876 Dennyloanhead – Kilbagie Roundabout Trunk Road to the westbound A985 Kincardine – Rosyth Trunk Road.
