**ROAD TRAFFIC**

**The A830 Trunk Road (Arisaig to Mallaig) (Temporary Prohibition On Use of Road and Temporary 30mph Speed Restriction) Order 2018**

*Made* - - - - *4th May 2018*

*Coming into force* - - *12th May 2018*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 16A of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 16A(2) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited for the purpose of facilitating the holding of a relevant event and enabling members of the public to watch that relevant event.

In accordance with section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for the event to be held otherwise than on a road.

In accordance with section 16A(8) of that Act, they have had regard to the safety and convenience of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A830 Trunk Road (Arisaig to Mallaig) (Temporary Prohibition On Use of Road and Temporary 30mph Speed Restriction) Order 2018, comes into force on 12th May 2018 and ceases to have effect on 13th May 2018

**Prohibition on use of vehicles**

2. No person may use or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the schedule of this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 8 (diagram 7105 - position of the barrier to mark length of road

closed or to guide traffic past an obstruction) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016<sup>(a)</sup>.

### **Speed restriction**

3. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of a length of road, specified in the schedule of this Order at a speed exceeding 30 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 1 (diagram 670 – maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016.

### **Exemptions**

4. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
- (b) a vehicle being used for facilitating the holding of the relevant event; or
- (c) anything done with the permission or upon the direction of a police constable in uniform.

## SCHEDULE

Articles 2 and 3

### SPECIFIED LENGTH OF ROAD

That length of the A830 Fort William – Mallaig Trunk Road from its junction with the access road to Arisaig House and Borrodale House, Druimindarroch, South of Mallaig in a generally northwesterly and northerly direction to its junction with Harbour Road Roundabout, Mallaig, a distance of 16 kilometres or thereby.
