Citation and commencement, etc.

- 1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Rules of the Court of Session 1994 Amendment) (Sanctions and Anti-Money Laundering) (No.2) 2019.
 - (2) It comes into force on 29th March 2019.
 - (3) A certified copy is to be inserted in the Books of Sederunt.

- **2.**—(1) The Act of Sederunt (Rules of the Court of Session 1994 Amendment) (Sanctions and Anti-Money Laundering) 2019(**3**) is amended in accordance with this paragraph.
 - (2) Before paragraph 3(1) (revocation) insert—
 - "(A1) Chapter 101 of the Rules of the Court of Session 1994 (terrorist asset-freezing)(4) is revoked.".
