8. In the Police and Criminal Evidence Act 1984 (Application to the Armed Forces) Order 2006(10) for "Royal Navy Regulating Branch" substitute "Royal Navy Police" in each of the following places—

- (a) Article 2(2);
- (b) in the definition of "service policeman" provided for in column 2 of Schedule 1 to that Order in relation to subsection (1) of section 65 of the Police and Criminal Evidence Act 1984(11); and
- (c) sections 63A(1B) and 65 of the Police and Criminal Evidence Act 1984, as set out with modifications in Schedule 3 to that Order.

Amendment of the Criminal Justice and Public Order Act 1994 (Application to the Armed Forces) Order 2006

9. EXPLANATORY NOTE

(This note is not part of the Order)

This Order makes minor changes to nine statutory instruments. The amendments provide for consequential changes in the legislation following the change of title of the Royal Navy Regulating Branch (sometimes referred to as the Royal Naval Regulating Branch) to that of the Royal Navy Police. Various amendments in Schedule 16 to the Armed Forces Act 2006 that provide for the change of name from the Royal Navy Regulating Branch to that of the Royal Navy Police in primary legislation have already been commenced, and this Order supplements those changes by changing the name in the subordinate legislation.
