The Secretary of State for Work and Pensions makes these Regulations in exercise of the powers conferred by section 8(1) of the European Union (Withdrawal) Act 2018(1).

Introduction

Citation and commencement

1. These Regulations may be cited as the Occupational and Personal Pension Schemes (Amendment etc.) (Northern Ireland) (EU Exit) Regulations 2018 and come into force on exit day.

PART 2

(2) Omit Part 16 (cross-border schemes).

Amendment of the Occupational Pension Schemes (Schemes that were Contracted-out) Regulations (Northern Ireland) 2016

32.—(1) The Occupational Pension Schemes (Schemes that were Contracted-out) Regulations (Northern Ireland) 2016(**51**) are amended as follows.

(2) In regulation 6(2), for "EEA states" substitute "United Kingdom".

PART 4

Revocation of secondary legislation

33. The Occupational Pension Schemes (Cross-border Activities) Regulations (Northern Ireland) 2005(**52**) are revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are made in exercise of the powers conferred by section 8(1) of the European Union (Withdrawal) Act 2018 (c. 16) in order to address failures of retained EU law to operate effectively and other deficiencies (in particular under paragraphs (a), (c), (d), (e) and (g) of subsection (2)) arising from the withdrawal of the UK from the European Union.

These Regulations amend legislation in the field of occupational and personal pension schemes in Northern Ireland. Part 2 amends Acts and Orders in Council, Part 3 amends secondary legislation and Part 4 revokes secondary legislation.

No impact assessment has been produced for this instrument as no, or no significant, impact on the private or voluntary sector is foreseen.
