EXITING THE EUROPEAN UNION

**The European Union (Withdrawal) Act 2018 (Exit Day)
(Amendment) Regulations 2019**

Made - - - -

Coming into force in accordance with regulation 1

The day on which the Treaties^(a) are to cease to apply to the United Kingdom in accordance with Article 50(3) of the Treaty on European Union is different from that specified in the definition of “exit day” in section 20(1) of the European Union (Withdrawal) Act 2018^(b).

The Secretary of State, in exercise of the powers conferred by section 20(4) of that Act, makes the following Regulations.

In accordance with paragraph 14 of Schedule 7 to that Act, a draft of this instrument has been laid before Parliament and approved by a resolution of each House of Parliament.

Citation and commencement

1. These Regulations may be cited as the European Union (Withdrawal) Act 2018 (Exit Day) (Amendment) Regulations 2019 and come into force immediately after they are made.

Amendment to the definition of “exit day”

2.—(1) Section 20 of the European Union (Withdrawal) Act 2018 (interpretation) is amended as follows.

(2) In subsection (1), in the definition of “exit day”, for “29 March 2019 at 11.00 p.m. (and” substitute—

“—

(a) if, in accordance with Article 1 of European Council Decision (EU) 2019/476 of 22 March 2019^(c), the period provided for in Article 50(3) of the Treaty on European Union is extended until 22 May 2019, 11.00 p.m. on that day, or

(b) if not, 11.00 p.m. on 12 April 2019,

(and”.

(a) “The Treaties” has the meaning given in section 20(5) of the European Union (Withdrawal) Act 2018 (c. 16).

(3) In subsection (2) for the words from “references”, where it first appears, to the end substitute—

“—

- (a) references to before, after or on exit day are to be read as references to before, after or at 11.00 p.m. on 22 May 2019 or (as the case may be) 12 April 2019, and
- (b) references to beginning with exit day are to be read as references to beginning with 11.00 p.m. on the day concerned.”.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the definition of “exit day” in the European Union (Withdrawal) Act 2018 (c. 16) (“the 2018 Act”) and come into force immediately after they are made.

On 29th March 2017, the Prime Minister gave notice of the intention of the United Kingdom to withdraw from the European Union in accordance with Article 50 of the Treaty on European Union and the European Union (Notification of Withdrawal) Act 2017 (c. 9). Where a Member State has given such notice, paragraph 3 of that Article provides that the Treaties of the European Union cease to apply to the Member State concerned from the date of entry into force of a withdrawal agreement or, failing that, two years after the notification, unless the European Council, in agreement with the Member State concerned, unanimously decides to extend this period. In consequence, the Treaties were due to cease to apply to the United Kingdom at 11.00 p.m. on 29th March 2019.

An extension to that period was agreed between the United Kingdom and the European Council on 22nd March 2019 (European Council Decision (EU) 2019/476, O.J. No. L 80 I, p. 1). As a result, the Treaties will instead cease to apply to the United Kingdom at 11.00 p.m. on 22nd May 2019 if the House of Commons approves the withdrawal agreement by 11.00 p.m. on 29th March 2019 (“the relevant time”). If the House of Commons does not give such approval by the relevant time, the Treaties will instead cease to apply at the earlier date of 11.00 p.m. on 12th April 2019.

Regulation 2 amends the definition of “exit day” in section 20(1) and (2) of the 2018 Act to ensure the day and time specified in that definition is 11.00 p.m. on 22nd May 2019 or 11.00 p.m. on 12th April 2019 depending on whether the House of Commons approves the withdrawal agreement by the relevant time. This reflects the new day and time that the Treaties will cease to apply to the United Kingdom in light of the extension.
