# NATIONAL SECURITY

The National Security Act 2023 (Consequential Amendments of Primary Legislation) Regulations 2023

# Citation, commencement and extent

**1.**—(1) These Regulations may be cited as the National Security Act 2023 (Consequential Amendments of Primary Legislation) Regulations 2023.

(2) These Regulations come into force on 20th December 2023.

(3) Subject to paragraph (4), these Regulations extend to England and Wales, Scotland and Northern Ireland.

(4) An amendment made by the Schedule has the same extent within the United Kingdom as the provision amended.

  - (c) after sub-paragraph (v), insert-
    - "(vi) paragraph 10 of Schedule 6 to the National Security Act 2023, or
    - (vii) paragraph 1 or 4 of Schedule 12 to that Act, or".

#### Public Services Ombudsman (Wales) Act 2019

**32.** In section 69(2)(g) of the Public Services Ombudsman (Wales) Act 2019(63), after "1989 (c. 6)" insert ", or under sections 1 to 4 or 18 of the National Security Act 2023 (c. 32)".

#### **Disclosure (Scotland) Act 2020**

**33.** In Schedule 2 to the Disclosure (Scotland) Act 2020(64), after paragraph 70, insert-*"National security* 

70A. An offence under sections 1 to 4, 12, 13, 17 or 18 of the National Security Act 2023.".

# Nationality and Borders Act 2022

**34.** In section 63(3) of the Nationality and Borders Act 2022(65), after paragraph (d), insert—

- "(da) the person is subject to a notice under Part 2 of the National Security Act 2023;
- (db) there are reasonable grounds to suspect that the person is or has been involved in foreign power threat activity within the meaning given by section 33 of that Act (whether or not the foreign power threat activity is attributable to the person being, or having been, a victim of slavery or human trafficking);".

These Regulations make various amendments of primary legislation in consequence of the enactment of the National Security Act 2023 (c. 32) ("the 2023 Act") and the repeal of the Official Secrets Acts 1911 (c. 28), 1920 (c. 75) and 1939 (c. 121).
