1963 CHAPTER XX

An Act to confirm a Provisional Order relating to the city of Leeds. [31st July 1963]

THEREAS under the provisions of the Public Health Act 1875 and the Public Health Act 1936 the Minister of Housing and Local Government has made a Provisional Order which needs confirmation by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

- 1. The order of the Minister of Housing and Local Government Confirmation which is set out in the schedule to this Act is hereby confirmed of order in and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Housing and Local Short title. Government Provisional Order Confirmation (Leeds) Act 1963.

SCHEDULE

CITY OF LEEDS

Provisional Order partially repealing a local Act

The Minister of Housing and Local Government, on the application of the council of the city of Leeds and in exercise of his powers under section 303 of the Public Health Act 1875, section 317 of the Public Health Act 1936 and of all other powers enabling him in that behalf, hereby orders as follows:—

Citation and commencement.

- 1. This order may be cited as the Leeds Order 1963 and shall come into operation on the date of the Act of Parliament confirming it.
- Interpretation.
- 2. In this order—
 - "the relevant building byelaw" means the building byelaw made by the lord mayor, aldermen and citizens of the city of Leeds, acting by the council of the city of Leeds on 6th March 1963 under section 61 of the Public Health Act 1936; and "the operative date" means the date on which the relevant building byelaw comes into operation, or the date on which this order comes into operation, whichever is the later.

Partial repeal of local Act.

3. Section 156 of the Leeds Corporation (Consolidation) Act 1905 (Height of rooms for occupation as dwelling or sleeping rooms) shall be repealed as from the operative date.
