to confirm a Provisional Order of the Minister of
Housing and Local Government relating to the borough
of King's Lynn. [25th July 1969]

WHEREAS under the provisions of the Public Health Act 1875 c. 55,
1875, the Public Health Act 1936 and the Food and 1936 c. 49.
Drugs Act 1955 the Minister of Housing and Local 1955 c. 16
Government has made the Provisional Order set forth in the (4 & 5 Eliz. 2).
schedule hereto which needs confirmation by Parliament:

Be it therefore enacted by the Queen's most Excellent Majesty,
and with the advice and consent of the Lords Spiritual and
temporal, and Commons, in this present Parliament assembled,
and by the authority of the same, as follows:—

1. The order of the Minister of Housing and Local Government Confirmation
which is set out in the schedule to this Act is hereby confirmed of order in

SCHEDULE

BOROUGH OF KING'S LYNN

PROVISIONAL ORDER AMENDING A LOCAL ACT
 AND A CONFIRMING ACT

The Minister of Housing and Local Government, on the application of the mayor, aldermen and burgesses of the borough of King's Lynn and in exercise of his powers under sections 297 and 303 of the Public Health Act 1875, section 317 of the Public Health Act 1936 and section 131 of the Food and Drugs Act 1955 and of all other powers enabling him in that behalf, hereby orders as follows:—

 (4 & 5 Eliz. 2).

Citation and commencement.

1. This order may be cited as the King's Lynn Order 1969, shall come into operation on the date of the Act of Parliament confirming it.

Interpretation.

2. In this order—

1859 c. xxxii.

“ the Act of 1859 ” means the King's Lynn Waterworks and Borough Improvement Act 1859;

1877 c. ccxxvii.

“ the order of 1877 ” means the provisional order for the borough as confirmed by the Local Government Board's Provisional Orders Confirmation (Caistor Union, &c.) Act 1877;

“ the borough ” means the borough of King's Lynn;

“ the Corporation ” means the mayor, aldermen and burgesses, the borough acting by the council; and

“ the Minister ” means the Minister of Housing and Local Government.

Stallages and tolls for markets and fairs.

3. The Corporation may, with the approval of the Minister, from time to time alter or add to the stallages and tolls in any of their market houses, market places or places for fairs as specified in Schedule 3 to the Act of 1859, and any such altered stallages and tolls shall from the date on which they come into operation be substituted for the corresponding stallages and tolls payable under the said schedule

Tolls for cattle market.

4. The Corporation may, with the approval of the Minister, from time to time alter or add to the tolls specified in Schedule 4 to the Act of 1859 as substituted under the order of 1877, and any altered tolls shall, as from the date on which they come into operation, be substituted for the corresponding tolls payable under the said schedule as so substituted.

Local inquiries.

5.—(1) The Minister may cause such local inquiry to be held as may consider necessary for the purpose of any of his functions under this order.

(2) Subsections (2) to (5) of section 290 of the Local Government Act 1933 (which relate to the giving of evidence at inquiries and to payment of costs) shall apply to inquiries held under this article.
