

CHAPTER cx.

An Act to confirm certain Provisional Orders made by the A.D. 1908. Board of Trade under the Electric Lighting Acts 1882 and 1888 relating to Bude Camberley and District East Barnet Valley Exeter (Extension) Frome (Amendment) Higham Ferrers Rushden and Wellingborough (Rural District) Mid-Durham Wealdstone Wisbech (Amendment) and Yardley (Amendment). [20th July 1906.]

HEREAS under the authority of the Electric Lighting Acts 45 & 46 Vict.

1882 and 1888 the Board of Trade have made the several c. 56. Provisional Orders set out in the schedule to this Act:

51 & 52 Vict. c. 12.

And whereas a Provisional Order made by the Board of Trade under the authority of the said Acts is not of any validity or force whatever until the confirmation thereof by Act of Parliament:

And whereas it is expedient that the several Provisional Orders made by the Board of Trade under the authority of the said Acts as set out in the schedule to this Act be confirmed by Act of Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. This Act may be cited as the Electric Lighting Orders Short title. Confirmation (No. 5) Act 1906.
- 2. The several Orders as amended and set out in the schedule Orders in to this Act shall be and the same are hereby confirmed and all schedule the provisions thereof in manner and form as they are set out

A.D. 1906. in the said schedule shall from and after the passing of this Act have full validity and effect.

For protection of Hertfordshire County Council.

- 3.—(1) Nothing in the East Barnet Valley Electric Lighting Order 1906 confirmed by this Act shall take away or abridge any power to repair open or break up any road or county bridge along or across which any pipe wire cable or electric main is laid or any other power vested in the Hertfordshire County Council (in this section called "the council") for any of the purposes for which the council is constituted but before commencing any work pursuant to such powers whereby any pipe wire cable or electric main will be interfered with they shall (except in case of emergency in which case no notice shall be necessary) give the Undertakers notice of their intention to commence such work specifying the time at which they will begin to do so such notice to be given three days at least before the commencement of the work and shall always complete such work with all reasonable expedition and cause as little damage or inconvenience to the Undertakers as circumstances permit.
- (2) The council shall not be liable to pay to the Undertakers any compensation for injury done to any pipes wires cables or electric mains by the execution of such works or for loss occasioned thereby or for the reasonable exercise of the powers so vested in them as aforesaid.
- (3) The council shall not execute such work so far as it immediately affects any pipe wire cable or electric main except under the superintendence of the Undertakers unless they refuse or neglect to give such superintendence at the time specified in the notice for the commencement of the work or discontinue the same during the progress of the work and they shall execute such work at their own expense and to the reasonable satisfaction of the Undertakers Provided that any additional expense imposed upon them by reason of the existence of any pipes wires cables or electric mains of the company in any road or place shall be borne by the company.
- (4) Any difference which may arise between the Undertakers and the council under this section shall be determined by arbitration.

For protection of Berkshire County Council.

4.—(1) Nothing in the Camberley and District Electric Lighting Order 1906 confirmed by this Act shall in any way limit or affect the powers of the Berkshire County Council to rebuild alter widen or repair the structure of any bridge upon

which any work by the Order authorised shall be constructed or A.D. 1906. impose upon the county council any liability which was not by law imposed upon them prior to the commencement of the Order.

- (2) If at any time the county council require to carry out works for rebuilding altering widening or repairing any bridge which might involve interference with any portion of the undertaking by the Order authorised they shall prior to the commencement of such work give the Undertakers one month's notice of their intention to carry out such works and if in order to avoid interruption to the supply by the Undertakers of electrical energy it is in the opinion of the county council necessary to temporarily remove the mains and other electrical appliances belonging to the Undertakers from such bridge then the Undertakers shall (and they are hereby authorised so to do) at their own expense temporarily carry their cables and wires across such bridge overhead or at the side thereof in such a manner as will not be a danger or inconvenience to the public or unreasonably interfere with the works to be carried out by the county council.
- (3) When the rebuilding altering widening or repairing of such bridge shall have been completed the Undertakers shall have the same rights and powers with regard to such bridge and its approaches as they had before the works were carried out.
- (4) If any dispute arises between the county council and the Undertakers with regard to this section the same shall be determined by an arbitrator to be appointed on the application of either party by the Board of Trade.
- 5.—(1) Nothing in the Camberley and District Electric For pro-Lighting Order 1906 confirmed by this Act shall in any way tection et limit or affect the powers of the Surrey County Council to County rebuild alter widen or repair the structure of any bridge upon Council, which any work by the Order authorised shall be constructed or impose upon the county council any liability which was not by law imposed upon them prior to the commencement of the Order.
- (2) If at any time the county council require to carry out works for rebuilding altering widening or repairing any bridge which might involve interference with any portion of the undertaking by the Order authorised they shall prior to the

A.D. 1906. commencement of such work give the Undertakers one month's notice of their intention to carry out such works and if in order to avoid interruption to the supply by the Undertakers of electrical energy it is in the opinion of the county council necessary to temporarily remove the mains and other electrical appliances belonging to the Undertakers from such bridge then the Undertakers shall (and they are hereby authorised so to do) at their own expense temporarily carry their cables and wires across such bridge overhead or at the side thereof in such a manner as will not be a danger or inconvenience to the public or unreasonably interfere with the works to be carried out by the county council.

- (3) When the rebuilding altering widening or repairing of such bridge shall have been completed the Undertakers shall have the same rights and powers with regard to such bridge and its approaches as they had before the works were carried out.
- (4) If any dispute arises between the county council and the Undertakers with regard to this section the same shall be determined by an arbitrator to be appointed on the application of either party by the Board of Trade.

For protection of Northamp. tonshire County Council.

- 6.—(1) Nothing in the Higham Ferrers Rushden and Wellingborough (Rural District) Electric Lighting Order 1906 confirmed by this Act shall in any way limit or affect the powers of the Northamptonshire County Council to rebuild alter widen or repair the structure of any bridge upon which any work by the Order authorised shall be constructed or impose upon the county council any liability which was not by law imposed upon them prior to the commencement of the Order.
- (2) If at any time the county council require to carry out works for rebuilding altering widening or repairing any bridge which might involve interference with any portion of the undertaking by the Order authorised they shall prior to the commencement of such work give the Undertakers one month's notice of their intention to carry out such works and if in order to avoid interruption to the supply by the Undertakers of electrical energy it is in the opinion of the county council necessary to temporarily remove the mains and other electrical appliances belonging to the Undertakers from such bridge then the Undertakers shall (and they are hereby authorised so to do) at their own expense temporarily carry their cables and wires across such bridge overhead or at the side thereof in such a manner as will not be a

danger or inconvenience to the public or unreasonably interfere A.D. 1906. with the works to be carried out by the county council.

- (3) When the rebuilding altering widening or repairing of such bridge shall have been completed the Undertakers shall have the same rights and powers with regard to such bridge and its approaches as they had before the works were carried out.
- (4) If any dispute arises between the county council and the Undertakers with regard to this section the same shall be determined by some one person to be agreed upon in writing between the county council and the Undertakers or failing agreement by an arbitrator to be appointed on the application of either party by the Board of Trade.
- 7.—(1) Notwithstanding anything in the provisions of the Powers unschedule to the Electric Lighting (Clauses) Act 1899 as incorporated der Higham with the Higham Ferrers Rushden and Wellingborough (Rural Rushden and District) Electric Lighting Order 1906 confirmed by this Act which Wellingprohibits the Undertakers under that Order from associating themselves with any company or person supplying energy under any District) licence Provisional Order or special Act and from laying down Lighting any electric lines or works outside the area of supply under that Order the Undertakers under that Order may (but subject save as aforesaid to the provisions of that Order) connect any generating station or electric lines within the area of supply Order 1900 under that Order with any generating station or electric lines for extension within the area of supply under the Wellingborough Electric of mains outside area of Lighting Order 1900 and the Undertakers under the last-mentioned supply. Order may notwithstanding any provisions contained in that Order so prohibiting them (but subject in all other respects to the provisions of that Order) connect any generating station or electric lines within the area of supply under that Order with any generating station or electric lines within the area of supply under the Higham Ferrers Rushden and Wellingborough (Rural District) Electric Lighting Order 1906 and the Undertakers under either of those Orders may use any generating station so connected for the generation of electrical energy to be supplied in either of those areas and subject as aforesaid may supply energy so generated in their respective areas of supply.
- (2) Nothing in this section shall exonerate the Undertakers under either of the said Orders from any indictment action or other proceeding for nuisance in the event of any nuisance being caused or permitted by them.

Ferrers borough (Rural Electric Order 1906 and Wellingborough Electric Lighting

For protection of Middlesex County Council.

- 8.—(1) Nothing in the Wealdstone Electric Lighting Order 1906 confirmed by this Act shall in any way limit or affect the powers of the Middlesex County Council to rebuild alter widen or repair the structure of any bridge upon which any work by the Order authorised shall be constructed or impose upon the county council any liability which was not by law imposed upon them prior to the commencement of the Order.
- (2) If at any time the county council require to carry out works for rebuilding altering widening or repairing any bridge which might involve interference with any portion of the undertaking by the Order authorised they shall prior to the commencement of such work give the Undertakers one month's notice of their intention to carry out such works and if in order to avoid interruption to the supply by the Undertakers of electrical energy it is in the opinion of the county council necessary to temporarily remove the mains and other electrical appliances belonging to the Undertakers from such bridge then the Undertakers shall (and they are hereby authorised so to do) at their own expense temporarily carry their cables and wires across such bridge overhead or at the side thereof in such a manner as will not be a danger or inconvenience to the public or unreasonably interfere with the works to be carried out by the county council.
- (3) When the rebuilding altering widening or repairing of such bridge shall have been completed the Undertakers shall have the same rights and powers with regard to such bridge and its approaches as they had before the works were carried out.
- (4) If any dispute arises between the county council and the Undertakers with regard to this section the same shall be determined by an arbitrator to be appointed on the application of either party by the Board of Trade.

BUDE ELECTRIC LIGHTING.

Bude.

Provisional Order granted by the Board of Trade under the Electric Lighting Acts 1882 and 1888 to Messrs. Christy Brothers and Middleton in respect of the Urban District of Stratton and Bude and parts of the Rural District of Stratton in the County of Cornwall.

Short title.

1. This Order may be cited as the Bude Electric Lighting Order 1906.

Incorporation of Electric Lighting (Clauses) Act 1899.

2. The provisions contained in the schedule to the Electric Lighting (Clauses) Act 1899 (with the exception of sections 83 and 84 of that schedule) are incorporated with and form part of this Order.

Undertakers.

3. The Undertakers for the purposes of this Order and within the meaning of section 2 of the schedule to the Electric Lighting (Clauses) Act 1899 are Frank Christy Leonard Fell Christy and William Middleton trading as Messrs. Christy Brothers and Middleton of Chelmsford Essex.

Area of supply.

4. The area of supply for the purposes of this Order and within the meaning of section 4 of the schedule to the Electric Lighting (Clauses) Act 1899 shall be the area which is described in the First Schedule to this Order and is more particularly delineated on the map deposited together with this Order at the Board of Trade by the Undertakers and signed by an assistant secretary to the Board of Trade.

Power to break up streets &c.

5. Subject to the provisions incorporated with this Order the Undertakers are specially authorised by this Order to break up the streets which are mentioned in the Second Schedule to this Order and the railway which is also mentioned in that schedule.

Compulsory works.

6. The street throughout which the Undertakers are to lay down suitable and sufficient distributing mains for the purposes of general supply within a period of two years after the commencement of this Order as mentioned in section 21 of the schedule to the Electric Lighting (Clauses) Act 1899 is that mentioned in the Third Schedule to this Order.

Maximum prices.

7. The maximum prices which may be charged by the Undertakers as mentioned in section 32 of the schedule to the Electric Lighting (Clauses) Act 1899 are those stated in the Fourth Schedule to this Order.

Deposit.

8. The sum to be deposited or secured in pursuance of section 5 of the schedule to the Electric Lighting (Clauses) Act 1899 is one hundred pounds in respect of the urban district of Stratton and Bude and one hundred pounds in respect of so much of the area of supply as is situate within the rural district of Stratton.

Restriction as to time for laying distributing mains. 9. The Undertakers shall not be entitled without the consent of the urban district council of Stratton and Bude to break up any street within so much of the area of supply under this Order as is comprised within

the urban district of Stratton and Bude for the purpose of laying down new distributing mains during the months of July August and September in any year.

A.D. 1906. Bude.

10. Nothing in this Order contained shall prejudice or affect any property rights powers authorities or privileges of His Royal Highness the Prince of Wales in right of his Duchy of Cornwall or of the possessor of the Duchy of Cornwall for the time being.

Saving for Duchy of Cornwall.

11.—(1) The powers given by this Order shall not be exercised unless within twelve months or such extended period not exceeding in the whole fifteen months as the Board of Trade allow after the passing of the Act taking is transconfirming this Order the Undertakers by deed to be approved by the registered Board of Trade transfer the undertaking to a limited company registered company. under the Companies Acts 1862 to 1900 formed for that purpose and approved by the Board of Trade.

Powers not to be exercised unless under-

- (2) Within that period the Undertakers may transfer and the company to whom the transfer is to be made may take a transfer of the undertaking with the consent of and on such terms and conditions as may be approved by the Board of Trade.
- (3) On any such transfer the rights powers authorities obligations and liabilities of the Undertakers shall be transferred to and may be exercised by and shall attach to the company to whom the transfer is made and that company shall subject to the provisions of this Order become the Undertakers for the purposes of this Order.
- (4) If the transfer directed by this Order has not been made before the expiration of the period limited in that behalf in this section the Board of Trade may revoke this Order upon the expiration of that period.
- 12.—(1) The urban district council of Stratton and Bude being Power of purthe local authority in respect of so much of the undertaking as is situate within their district may by twelve months' notice in writing expiring cit of Stratton at any time after the termination of twenty-one years from the commencement of this Order require the Undertakers to sell and thereupon the Undertakers shall sell to them as a going concern so much of the undertaking authorised by this Order as is within their district including all lands buildings works materials and plant suitable to and used by the Undertakers for the purposes of the undertaking within that part of the area of supply.

- (2) The price to be paid upon any such transfer shall be a sum equal to the fair market value of the portion of the undertaking purchased as a going concern regard being had to any loss occasioned by severance that sum to be determined in default of agreement by arbitration.
- (3) The Board of Trade may determine any question which arises in reference to the purchase which is not to be determined by arbitration and in default of agreement as to the date on which the transfer is to take effect may fix that date.

Bude.

- (4) From the date on which the purchase takes effect the portion of the undertaking purchased (including all such lands buildings works materials and plant as aforesaid) shall vest in the local authority freed from all debts mortgages or similar obligations of the Undertakers or attaching to the undertaking and the powers of the Undertakers in relation to the supply of electricity within that portion of the area of supply to which the transfer relates under this Order or the principal Act shall cease and determine and shall vest in the local authority purchasing who shall subject to the provisions of this Order become the Undertakers for the purposes of this Order within the area in respect of which the transfer is made.
- (5) The power of purchase given by this Order shall be in addition to and not in derogation of the power of any local authority to purchase the portion of the undertaking within their district under section 2 of the Electric Lighting Act 1888.

Commencement of Order. 13. Save as in this Order expressly provided this Order shall come into force upon the day when the transfer to a limited company directed by this Order takes effect and that day for the purposes of the Electric Lighting (Clauses) Act 1899 shall be the commencement of this Order.

AREA OF SUPPLY.

The urban district of Stratton and Bude as constituted at the commencement of this Order and the parishes of Poughill and Marhamchurch as so constituted and so much of the parish of Poundstock as so constituted as lies to the north of a line drawn from the sea at the centre of Wanson Mouth along the south side of the road leading past Lower and Higher Widemouth Copthorne and Box's Shop to Woolston Mill and the western boundary of the parish of Marhamchurch:

FOURTH SCHEDULE.

MAXIMUM PRICES.

In this schedule—

The expression "unit" shall mean the energy contained in a current of one thousand ampères flowing under an electro-motive force of one volt per hour.

SECTION 1.

Where the Undertakers charge any consumer by the actual amount of energy supplied to him they shall be entitled to charge him at the following rates per quarter:—

- (a) For power purposes for each unit threepence; and
- (b) For all other purposes for any amount up to twenty units ten shillings and for each unit over twenty units sixpence:

Bude.

Provided that if in any year during which the Undertakers are a limited company that company pay dividends exceeding five per cent. upon their capital then paid up the company shall in the twelve months succeeding the date upon which that dividend is paid allow a discount to every consumer upon the amount which the company would be entitled to charge to that consumer under the provisions of this schedule in respect of energy supplied to him during that period that discount to be of an amount equal to five per cent. for every one per cent. by which the dividend so paid exceeds five per cent. upon the paid-up capital.

SECTION 2.

Where the Undertakers charge any consumer by the electrical quantity contained in the supply given to him they shall be entitled to charge him according to the rates set forth in section 1 of this schedule the amount of energy supplied to him being taken to be the product of that electrical quantity and the declared pressure at the consumer's terminals that is to say such a constant pressure at those terminals as may be declared by the Undertakers under the Board of Trade regulations.

CAMBERLEY AND DISTRICT ELECTRIC LIGHTING.

Provisional Order granted by the Board of Trade under the Electric Lighting Acts 1882 and 1888 to the Camberley Electric Supply Company Limited in respect of the Urban District of Frimley in the County of Surrey and the Parishes of Sandhurst and Crowthorne in the Rural District of Easthampstead in the County of Berkshire.

Short title.

1. This Order may be cited as the Camberley and District Electric Lighting Order 1906.

Incorporation of Electric Lighting (Clauses) Act 1899.

2. The provisions contained in the schedule to the Electric Lighting (Clauses) Act 1899 (with the exception of sections 83 and 84 of that schedule) are incorporated with and form part of this Order.

Undertakers.

3. The Undertakers for the purposes of this Order and within the meaning of section 2 of the schedule to the Electric Lighting (Clauses) Act 1899 are the Camberley Electric Supply Company Limited being a company registered under the Companies Acts 1862 to 1900 with limited liability whose registered offices are situated at Moorgate Court Moorgate Place in the city of London.

Arca of supply.

4. The area of supply for the purposes of this Order and within the meaning of section 4 of the schedule to the Electric Lighting (Clauses) Act 1899 shall be the area which is described in the First Schedule to this Order

and is more particularly delineated on the map deposited together with this Order at the Board of Trade by the Undertakers and signed by an assistant secretary to the Board of Trade.

5. Subject to the provisions incorporated with this Order the Undertakers are specially authorised by this Order to break up the streets not repairable by the local authority which are mentioned in the Second Schedule to this Order and the railways which are also mentioned in that schedule.

Power to break up streets &c.

6. The streets and parts of streets throughout which the Undertakers Compulsory are to lay down suitable and sufficient distributing mains for the purposes of general supply within a period of two years after the commencement of this Order as mentioned in section 21 of the schedule to the Electric Lighting (Clauses) Act 1899 are those mentioned in the Third Schedule to this Order.

7. The maximum prices which may be charged by the Undertakers Maximum as mentioned in section 32 of the schedule to the Electric Lighting (Clauses) Act 1899 are those stated in the Fourth Schedule to this Order.

8. Notwithstanding anything contained in the Electric Lighting Acts 1882 and 1888 a person shall not be entitled to demand or to continue to receive from the Undertakers a supply of electrical energy to premises having a separate supply unless he has agreed to pay to the Undertakers supply. such minimum annual sum as will give to the Undertakers a reasonable return on the capital expenditure and will cover other standing charges incurred by the Undertakers to meet the possible maximum demand for those premises The sum to be so paid shall be determined in default of agreement by arbitration.

As to supply of electricity where consumer has separate

9. The sum to be deposited or secured in pursuance of section 5 of the Deposit. schedule to the Electric Lighting (Clauses) Act 1899 is one hundred pounds in respect of the urban district of Frimley and one hundred pounds in respect of the rural district of Easthampstead.

10.—(1) The urban district council of Frimley and the rural district Purchase by council of Easthampstead as the local authorities in respect of so much of the local authority. area of supply under this Order as is situate in their respective districts may by six months' notice in writing given by both councils at the expiration of a period of 21 28 or 35 years from the commencement of this Order require the Undertakers to sell and thereupon the Undertakers shall sell to each such council so much of the undertaking authorised by this Order as is situated in the area of that council (including all lands buildings works materials and plant of the Undertakers suitable to and used by them for the purposes of the undertaking within that area) upon the terms of payment by each local authority to the Undertakers of a sum equal to the fair market value as a going concern of the portion of the undertaking purchased by that authority that sum to be determined in default of agreement by arbitration Provided that nothing in this section shall compel the Undertakers to sell a part only of the undertaking authorised by this Order.

Camberley.

- (2) The Board of Trade may determine any question which arises with reference to the purchase which is not to be determined by arbitration and in default of agreement as to the date on which the purchase is to take effect may fix that date.
- (3) From the date on which the purchase takes effect the portion of the undertaking purchased by each authority shall vest in that authority freed from all debts mortgages or other similar obligations of the Undertakers or attaching to the undertaking and the powers of the Undertakers in relation to the supply of electricity within the area of supply under this Order or the principal Act shall cease and determine and shall vest in the local authorities respectively who shall subject to the provisions of this Order become the Undertakers for the purposes of this Order within their respective areas.
- (4) The special power of purchase given by this section shall be in addition to and not in derogation of the rights of the said local authorities to purchase under section 2 of the Electric Lighting Act 1888.

Saving for Commissioners of Woods. 11. Short and collective titles.

1. This Order may be cited as the Yardley Rural District Electric Lighting Order 1904 (Amendment) Order 1906 and the Yardley Rural District Electric Lighting Order 1904 (herein-after called "the principal Order") and this Order may be cited together as the Yardley Rural District Electric Lighting Orders 1904 and 1906.

Extension of time for compulsory works.

2. The date from which the periods of two years and eighteen months are to be reckoned for the purposes of section 21 of the schedule to the Electric Lighting (Clauses) Act 1899 as incorporated with the principal Order shall be the commencement of this Order.

Transfer of powers under Order of 1904.

3. At any time within twelve months or such extended period not exceeding in the whole fifteen months as the Board of Trade may allow after the commencement of this Order the Undertakers may with the consent of and upon such terms and conditions as may be approved by the Board of Trade by deed to be approved by that Board transfer the undertaking authorised by the principal Order as amended by this Order to the mayor aldermen and citizens of the city of Birmingham (herein-after called "the corporation") and on that transfer the rights powers authorities obligations and liabilities of the Undertakers in respect

of the undertaking authorised by that Order as so amended shall subject to such modifications and exceptions as may be specified in the deed be transferred to and may be exercised by and shall attach to the corporation and the corporation shall subject to the provisions of that Order as so amended and to such modifications and exceptions as aforesaid become the Undertakers for the purposes of that Order as so amended.
