CHAPTER ix.

An Act to confirm a Provisional Order of the A.D. 1937.

Minister of Health relating to the East

Hertfordshire Joint Hospital District.

[25th March 1937.]

WHEREAS under the provisions of the Public 38 & 39 Vict. Health Act 1875 the Minister of Health has c. 55. made a provisional order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The order of the Minister of Health which is Order in set out in the schedule to this Act is hereby confirmed schedule and shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (East Hertfordshire Joint Hospital District) Act 1937.

East Hertfordshire Order.

EAST HERTFORDSHIRE JOINT HOSPITAL DISTRICT.

Provisional order altering certain confirming Acts.

WHEREAS by virtue of the Hertford and Ware Joint Hospital Orders 1893 to 1896 (in this order called "the hospital orders") which were confirmed by Parliament as amended by the Hertford and Ware Joint Hospital Amendment Order 1935 the borough of Hertford the urban districts of Hoddesdon and Ware and the rural districts of Hertford and Ware constitute a united district called the Hertford and Ware joint hospital district of which the governing body is the Hertford and Ware joint hospital board (in this order called "the joint board") consisting of five ex-officio members and ten elective members representing the councils of the said borough and urban and rural districts;

And whereas it is expedient that the urban districts of Bishop's Stortford Cheshunt and Sawbridgeworth and the rural districts of Braughing and Hatfield (in this order called "the added districts") should be included in the united district aforesaid and that the hospital orders amended as aforesaid should be altered as in this order provided:

Now therefore the Minister of Health in pursuance of the powers given to him by section 297 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Date of operation.

1. This order shall come into operation on the first day of April nineteen hundred and thirty-seven:

Provided that sections 6 9 10 and 11 of this order shall come into operation on the date of the Act of Parliament confirming this order.

Extension of united district.

2. The Hertford and Ware joint hospital district shall be extended so as to include the added districts and subject to the provisions of this order references in the hospital orders to the

constituent districts shall be deemed to include the added districts and references in those orders to the constituent authorities shall be deemed to include the councils of the added districts.

3. The united district shall be re-named the East Hertford- Re-naming shire joint hospital district and the joint board shall hereafter of united be known as the East Hertfordshire joint hospital board and district. references to the united district and the joint board in the hospital orders shall be construed accordingly.

4. The joint board shall consist of ten ex-officio members Ex-officio and seventeen elective members and the ex-officio members shall and elective be the persons described in column 3 of the schedule to this order and the number of elective members to be elected by each of the constituent authorities shall be that set opposite the name of the constituent authority in column 4 of that schedule.

5. The hospital orders shall have effect as if the schedule Substitution to this order were substituted for the schedules to the Hertford of new and Ware Joint Hospital Order 1896.

6.—(1) The urban district council of Ware shall at a meeting Continuance to be held before the first day of April nineteen hundred and thirty-seven by a majority of votes or in the case of an equality members of of votes by the casting vote of the presiding chairman select from the elective members then representing the said urban district on the joint board one person who shall continue to be a member of the joint board until the day on which he would have retired from office if this order had not been made and the remaining member shall cease to hold office on the date aforesaid.

- (2) The rural district council of Hertford shall at a meeting to be held before the first day of April nineteen hundred and thirty-seven by a majority of votes or in the case of an equality of votes by the casting vote of the presiding chairman select from the elective members then representing the said rural district on the joint board one person who shall continue to be a member of the joint board until the day on which he would have retired from office if this order had not been made and the remaining member shall cease to hold office on the date aforesaid.
- (3) The rural district council of Ware shall at a meeting to be held before the first day of April nineteen hundred and thirty-seven by a majority of votes or in the case of an equality of votes by the casting vote of the presiding chairman select from the elective members then representing the said rural district on the joint board two persons who shall continue to be members of

Election of additional elective members.

the joint board until the day on which they would have retired from office if this order had not been made and the remaining member shall cease to hold office on the date aforesaid.

7. The provisions of article IX of the Hertford and Ware Joint Hospital Order 1893 as amended by article II of the Hertford and Ware Joint Hospital Order 1896 shall apply to the first election by the councils of the added districts of the elective members and to the election by the urban district council of Hoddesdon of one additional elective member to represent those councils on the joint board as if the elections related to the filling of vacancies occurring on the first day of April nineteen hundred and thirty-seven.

Expenses of joint board.

- 8. For paragraph (2) of article XVII of the Hertford and Ware Joint Hospital Order 1893 the following paragraph shall be substituted:—
 - "(2) To the common fund so far as the same is not provided under paragraph (1) of this article each of the constituent authorities shall make a contribution to meet the expenditure of the joint board in any year in the proportion which the rateable value of the constituent district appearing in the valuation list in force on the first day of April last preceding the date of the issue of the precept bears to the aggregate of the rateable values of all the constituent districts appearing in the valuation lists in force on that day."

Adjustment of property liabilities &c.

9. The provisions of section 151 (Financial adjustments) of the Local Government Act 1933 shall have effect in relation to this order as if the alteration of the united district effected by this order were an alteration of areas or authorities made by an order under Part VI of that Act.

10. The Minister of Health may hold any inquiry which he may deem necessary for the purposes of this order and section 290 of the Local Government Act 1933 shall apply as if the joint board were a local authority.

Short and collective titles.

11. This order may be cited as the East Hertfordshire Joint Hospital Order 1937 and the hospital orders the Hertford and Ware Joint Hospital Amendment Order 1935 and this order may be cited together as the East Hertfordshire Joint Hospital Orders 1893 to 1937.
