An Act to continue the Term and alter and enlarge the Powers of an Act of the Fortieth Year of His late Majesty's Reign, for repairing the Road leading from the Turnpike Road in Witney to the Road on Swerford Heath, and the Road leading from the Road from Woodstock to Birmingham, through Charlbury, to the Road from Chipping Norton to Burford, all in the County of Oxford.

[15th July 1820.]

HEREAS an Act was passed in the Fortieth Year of the Reign of His late Majesty King George the Third, intituled An Act for amending, altering, improving, and keep- 40 G. 3. c. 16. ing in Repair the Road leading from the Turnpike Road in Witney to the Turnpike Road on Swerford Heath, and also the Road leading from the Turnpike Road from Woodstock to Birmingham, through Charlbury, to the Turnpike Road from Chipping Norton to Burford, all in the County of Oxford: And whereas the Trustees appointed in or by virtue of the said Act have proceeded in the Execution thereof, and have borrowed a considerable Sum of Money upon the Credit of the Tolls thereby authorized to be collected, and which still remains [Local.] due

due and owing: And whereas the Money borrowed and due as aforesaid, cannot be paid off and discharged, and the said Road effectually amended and kept in Repair, unless the Term of the said Act be continued, and some of the Powers thereof altered, amended, and enlarged, and the Tolls increased: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lord's Spiritual and Temporal, and Commons, in this present Parlia-The said Act men't assembled, and by the Authority of the same, That the said recited Act passed in the Fortieth Year of the Reign of His late Majesty, and all and every the Authorities, Powers, Privileges, Provisoes, and Clauses therein contained respectively (except such of them as are by this Act varied, altered, or repealed), shall be and continue in full force, and be executed for and during the Term herein-after mentioned, in as full and ample Manner, and as effectually to all Intents and Purposes as if the said Act and all the Clauses, Powers, Authorities, Trusts, Provisions, Directions, Rules, Exemptions, Penalties, Forfeitures, Payments, Remedies, Articles, Matters, and Things whatsoever therein contained were repeated and re-enacted in the Body of this Act, for repairing, widening, altering, improving, and keeping in Repair the Road comprized in the said recited Act; but subject nevertheless to the Amendments and Alterations herein contained; and that this Act and the additional Term hereby granted shall be and are hereby declared to be subject and liable to the Payment of all Monies now due or owing on the Credit or on Account of the said recited Act, or that may be borrowed or become due on the Credit of the said recited Act and of this Act, and of all Interest due or to grow due for the same respectively.

Additional Trustees.

II. And be it further enacted, That all His Majesty's Justices of the Peace acting for the said County of Oxford, together with the Most Honourable George Spencer Churchill commonly called the Marquis of Blandford, the Right Honourable Edward Somerset commonly called Lord Edward Somerset, Sir John Reade Baronet, Sir Robert Bolton, Matthew Robinson Boulton, Ball, John Clinch, John Williams Clinch, James Clinch, Benjamin Churchill, Samuel Churchill, John Churchill, John Davis, John Early the younger, Nicholas Earle Clerk, Thomas Browne Evans, Samuel Churchill Field, Nicholas Marshall Hacker Clerk, Charles Leake, William Long, James Haughton Langston, Charles Brown Mostyn, Charles Mostyn, Phillimore Clerk, Richard Pickering Clerk, Thomas Perrott, Joseph Rutter, George North Robinson, William Henry Ashton Smith, George Turner Clerk, William Way Clerk, Whalley Clerk, being qualified according to the Direcand tion of this Act, and taking or subscribing the Oath or Affirmation of Qualification herein-after mentioned, shall be and they are hereby added to and joined with the surviving or continuing Trustees, named or appointed by or in pursuance of the said recited Act, for putting the said Act and this Act in Execution, and shall be and are hereby empowered to act in the Execution of the said recited Act and this Act, as fully and effectually, to all Intents and Purposes, as if they had been appointed Trustees in or by the said recited Act.

III. And be it further enacted, That it shall and may be lawful Power to for the said Trustees, or any Three or more of them, and they are hereby authorized and empowered, at any of their Meetings to be Trustees. holden in pursuance of this Act, from Time to Time, as Occasion may require, to elect any Number of Persons, not exceeding Ten in the whole, to be Trustees for the Purposes of this Act and the said recited Act, in addition to the Trustees hereby appointed; and such Trustees so elected, and being qualified according to the Directions of the said recited Act, shall be and are hereby invested with the same Powers and Authority for executing this and the said recited Act, as if they had been hereby nominated and appointed.

IV. And be it further enacted, That no Person shall be capable of Qualification acting as a Trustee in the Execution of the said recited Act and of Trustees. this Act, whilst he holds any Place of Profit, or be concerned or interested in any Contract or Contracts under the said Act and this Act, or either of them; nor in any Case where he shall be personally interested otherwise than as a Creditor; nor shall any Person be qualified to act as a Trustee, unless at the Time of his acting he shall be in his own Right, or in the Right of his Wife, in the actual Possession and Enjoyment or Receipt of the Rents and Profits issuing out of Freehold or Copyhold Lands, Tenements, or Hereditaments of the clear yearly Value of One hundred Pounds above Reprizes; or shall be Heir Apparent to some Person having such an Estate of the clear yearly Value of One hundred and fifty Pounds, or be possessed of a Personal Estate alone, or Real and Personal Estate together, to the Amount of Four thousand Pounds, nor (except in administering the Oath or Affirmation herein-after mentioned), until he shall have taken and subscribed before any Two or more of the said Trustees, an Oath (or being one of the People called Quakers), an Affirmation, in the Words or to the Effect following; (that is to say),

' A. B. do swear, [or, being one of the People called Quakers, Oath.

do solemnly affirm,] That I truly and bond fide am in my own * Right [or, in Right of my Wife,] in the actual Possession and En-

'ioyment or Receipt of the Rents and Profits issuing out of Freehold or Copyhold Lands, Tenements, or Hereditaments of the clear yearly Value of One hundred Pounds above Reprizes; [or,

'am possessed of a Personal Estate alone, or Real and Personal. Estate together, to the Amount of Four thousand Pounds, or, ' Tam Heir Apparent of A. B. who to the best of my Knowledge is

'possessed of a Real Estate in Lands, Tenements, or Hereditaments, of the clear yearly Value of One hundred and fifty Pounds.

So help me GOD.

And if any Person shall act contrary to the true Intent and Meaning hereof, every such Person shall for every such Offence forfeit and pay the Sum of Fifty Pounds to any Person who shall inform or sue for the same, to be recovered in any of His Majesty's Courts of Record at Westminster, by Action of Debt, or on the Case, or by Bill or Plaint, Suit or Information, wherein no Essoign, Protection, or Wager of Law, nor more than One Imparlance, shall be allowed; and the Person so prosecuted shall prove that he is so qualified, or otherwise shall pay the said Penalty, without any other Proof or Evidence on the Part of the Prosecutor than that such Person hath acted as a Trustee in the Execution of the said recited Act and this Act, or either of them, any thing in the said recited Act to the contrary hereof notwithstanding: Provided nevertheless, that all Acts and Proceedings of any Person or Persons acting as a Trustee or Trustees in the Execution of the said recited Act and this Act, or either of them, (although not duly qualified) previously to his or their being convicted of the said Offence, shall notwithstanding such Conviction, be as good, valid, and effectual as if such Person or Persons had been qualified according to the Directions of this · Act.

Three Trustees to be a Quorum.

V. And be it further enacted, That all Acts to be done relative to the Execution of the said recited Act and of this Act, or either of them, shall and may be done and executed by the Majority of the Trustees who shall be present at the respective Meetings to be holden in pursuance thereof respectively, the whole Number present of such Trustees not being less than Three; and all Acts, Proceedings, Matters, and Things so done, shall be as good, valid, and effectual as if the same had been done by all the Trustees named in or appointed under or by virtue of the said recited Act and this Act, or either of them.

Trustees and others not disqualified from being Witnesses.

VI. And be it further enacted, That the being a Trustee of the said Road, or a Mortgagee of the Tolls thereof, or being a Treasurer or Clerk or Surveyor under the said recited Act or this Act, or the being an Inhabitant of any Township, Parish, or Place, through which the said Road does or shall pass, shall not disqualify any Trustee or other such Persons as are herein-before described, from giving his Testimony or Evidence in any Suit, Prosecution, or other legal Proceedings, under the said recited Act or this Act, nor shall such Testimony or Evidence (for any of the Reasons aforesaid) be liable to be questioned or set aside.

Trustees not toadminister Oaths on verifying Officers Accounts.

VII. Provided always, and be it further enacted, That nothing in this Act shall extend or be construed to extend to authorize or empower the said Trustees, or any of them, to administer any Oath or Oaths to any Clerk, Treasurer, Collector of the Tolls, Surveyor, or other Officer or Officers now appointed or hereafter to be appointed under or by virtue of the said recited Act and this Act, or either of them, for the Purpose of verifying his or their Accounts.

Accounts to be kept of Receipts and Disburseto the Inspection of the Trustees and Creditors.

VIII. And be it further enacted, That the said Trustees shall and they are hereby required, from Time to Time and at all Times during the Continuance of this Act, to order and direct a Book or Books to be provided and kept by their Clerk for the Time being; in which shall be open Book or Books such Clerk shall enter or cause to be entered true and regular Accounts of all Sums of Money received, paid, laid out, and expended for or on account of the said Road, and of the several Articles, Matters, and Things for which such Sums of Money shall have been disbursed, laid out, and paid; which Book or Books shall, at all seasonable Times, be open to the Inspection of the said Trustees,

Trustees, or any Creditor or Creditors on the Tolls by the said Act granted, without Fee or Reward; and the said Trustees and Creditors shall and may take Copies of or Extracts from the said Book or Books, or any Part or Parts thereof, without paying any thing for the same; and in case the said Clerk shall refuse to permit or shall not permit the said Trustees, or such Creditors, to inspect such Book or Books, or take such Copies or Extracts as aforesaid, such Clerk shall forfeit and pay any Sum of Money not exceeding Five Pounds.

IX. Provided always, and be it further enacted, That it shall Clerk renot be lawful for the said Trustees to continue or appoint the Person who has been or may be appointed to act as their Clerk in the Execu- acting as Treasurer, tion of this Act or the said recited Act, or either of them, or the and vice Partner of any such Clerk, the Treasurer for the Purposes of the said versa. recited Act and this Act, or either of them, or to continue or appoint the Person who has been or may be appointed Treasurer, or the Partner of any such Treasurer, the Clerk to the said Trustees for executing the said Act and this Act, or either of them; and if any Person shall act in both the Capacities of Clerk and Treasurer for the Purposes of the said Act and this Act, or either of them, or if any Person being the Partner of any such Clerk shall act as Treasurer, or being the Partner of any such Treasurer shall act as Clerk in the Execution of the said Act and this Act, or either of them, every Person so offending shall for every such Offence forfeit and pay the Sum of Fifty Pounds to any Person or Persons who shall sue for the same, to be recovered in any of His Majesty's Courts of Record at Westminster, by Action of Debt, or on the Case, or by Bill, Suit, or Information, wherein no Essoign, Protection, or Wager of Law, or more than one Imparlance, shall be allowed.

X. And be it further enacted, That it shall be lawful for the said Power to Trustees, or any Three or more of them, to continue and use every or any of the Turnpikes already erected upon the said Roads, and from Time to Time to erect and set up such other Turnpike or Turn- and set up pikes, Toll Gate or Toll Gates, or Bars, in, upon, across, or on the others. Side or Sides of the said Roads, or any of them, or across any Lane or Way leading out of the same respectively, and such and so many Toll House or Toll Houses, Weighing Engine or Engines, with suitable Outbuildings thereto, and add, make, and take such Garden Spots and other Conveniences, not exceeding One Quarter of an Acre, to and for the Use and Occupancy thereof, as they shall think expedient.

XI. And be it further enacted, That from and after the Fourth Old Tolls Monday next after the passing of this Act, the Tolls now payable repealed and by virtue of the said recited Act shall be and the same are hereby declared to be repealed, and that from thenceforth it shall be lawful for the said Trustees, or any Person or Persons by virtue of this or the said recited Act to be appointed Collector or Collectors as aforesaid, to demand and take at each and every of the respective Turnpikes or Toll Gates erected or which shall be erected in, upon, or across the said Roads, and on every Day, (such Day to be com-[Local.]

puted from Twelve of the Clock at Night to Twelve of the Clock in the next succeeding Night), such Tolls as the said Trustees, or any Three or more of them at any public Meeting to be held for that Purpose, shall from Time to Time direct or appoint, not exceeding the several and respective Sums herein-after mentioned; (that is to say),

Tolls.

For every Horse or other Beast of Draught drawing any Carriage, a Sum not exceeding Eight-pence:

For every Horse or other Beast, not drawing, a Sum not exceeding

Two-pence:

For every Drove of Oxen, Cows, or Neat Cattle, a Sum not exceeding Two Shillings and Sixpence per Score; and so in Proportion for any greater or less Number: And

For every Drove of Calves, Pigs, Sheep, or Lambs, a Sum not exceeding One Shilling and Three-pence per Score; and so in Propor-

tion for any greater or less Number.

And the said respective Tolls shall be demanded and taken before any Horse or Horses, or other Beast or Cattle, or any Carriage whatsoever, be permitted to pass through any such Turnpike or Toll Gate.

Repealing

XII. And whereas it is by the said recited Act enacted, that no Person shall be subject or liable to pay any of the Tolls hereby granted more than once in one Day, to be computed from Twelve of the Clock at Night to Twelve of the Clock the succeeding Night, for passing and repassing any Time or Times with the same Horse, Cattle, Beast, or Carriage, through all or any Gate or Turnpike Gates, or Turnpikes, to be erected upon or at or on the Sides of the said Roads, such Person producing a Ticket denoting that the respective Toll hath been paid on that Day, which Ticket the Collectors of the Tolls are thereby required to deliver gratis, if demanded, on Receipt of such Toll: And whereas it is expedient that the said Clause should be repealed; be it therefore further enacted, That the said Clause shall be and the same is hereby declared to be repealed and null and void to all Intents and Purposes whatsoever.

Limiting the whole Number of Tolls to be taken on the Road.

XIII. And be it further enacted, That the Number of Tolls following, and no more, shall or may be demanded or taken at the said Gates, for or in respect of the same Horse, or Horses, Beast, Cattle and Carriage in any one Day, to be computed from Twelve of the Clock at Night to Twelve of the Clock the succeeding Night; (that is to say), Two Tolls, and no more, for passing and repassing through all the Gates on that Part of the said Road between the Turnpike Road on Swerford Heath and Chalbury Market House; Two Tolls, and no more, for passing and repassing through all the Gates of the Road between the said Market House and Witney; Two Tolls, and no more, for passing and repassing through all the Gates between the Chipping Norton and Burford Turnpike Road and Charlbury Market House aforesaid; and Two Tolls, and no more, for passing and repassing through all the Gates between

between the said Market House and the Turnpike Road from Woodstock to Birmingham.

XIV. Provided always, and be it further enacted, That no Toll shall be demanded or taken for any Horse or Horses, or other Beast or Exemptions Cattle, or for any Waggon, Wain, Cart, or other Carriage employed in carrying or conveying, or going empty to fetch, carry, or convey, or returning empty from carrying or conveying, having been employed only in carrying or conveying, on the same Day, any Stones, Bricks, Timber, Wood, Gravel, or other Materials for making or repairing the said Road, or any Bridge or Bridges thereon, or any of the Roads in the Townships or Parishes in which any Part of the said Road lies; or with Seed for seeding the Ground, or Hay, Turnips, Straw, or Corn in the Straw only, not sold or disposed of, but passing to be laid up or placed in the Houses, Barns, Outhouses, or Yards, or on the Lands of the Owners thereof; or for any Horse, Beast or other Cattle of Carriage employed in carrying or conveying, or going empty to fetch, carry, or convey, or returning empty from carrying or conveying, having been employed only in carrying or conveying, on the same Day, any Ploughs, Harrows, or Implements of Husbandry, or any Mould, Dung, Compost or Manure, (Lime only excepted) employed in Husbandry, for manuring or improving Land, or any other Thing employed in the Management of any Farm or Eands; or for any Horses or other Beasts going to or returning from Pasture or Watering Place, or going to be or returning from being shoed or farried; or from any Person or Persons going to or returning from his, her, or their proper Parochial Church or Chapel, or from any Person or Persons going to or returning from his, her, or their usual Place of religious Worship tolerated by Law, on Sundays, or any other Day on which Divine Service is ordered by Authority to be celebrated, or going to or returning from attending the Funeral of any Person who shall die and be buried in any of the Parishes in which the said Road lies; or from any Clergyman going to visit or returning from visiting any sick Person, or on other his Parochial or Ministerial Duty; or for any Horses or Carriages of whatever Description employed or to be employed in conveying the Mails of Letters and Expresses under the Authority of His Majestys-Postmaster General, either when employed in conveying, fetching, or guarding such Mails or Expresses, or in returning back from conveying or guarding the same; or for any Horse or Carriage attending His Majesty or any of the Royal Family; or for the Horse or Horses of any Officers or Soldiers on their March or on Duty 5 or for any Horse or Horses or other Beast, or any Cart, Carriage, or Waggon employed in carrying or conveying, or returning therefrom, having been employed only in carrying or conveying the Arms or Baggage of any such Officers or Soldiers; or in carrying or conveying any sick, wounded, or disabled Officers or Soldiers; or for any Waggon, Wain, Cart, or other Carriage whatsoever, or the Horse or Horses or other Cattle drawing the same, which shall be employed in conveying any Ordnance, or Barrack, or Commissariat, or other public Stores belonging to His Majesty, or for the Use of His Majesty's Forces, or returning from having been so employed; or for any Horse, Mare, or Gelding furnished by or for any Person belong-

from Toll:

ing to any Corps of Yeomanry or Volunteer Cavalry or Infantry, and rode by him in going to or returning from any Place appointed for and on the Days of Exercise, Inspection, or Review, provided that such Person shall be dressed in the Uniform of his Corps, and shall be equipped with and have his Arms, Furniture, and Accoutrements, according to the Regulations of such Corps, at the Time of claiming the Exemption; or for Horses, Carts, or Waggons travelling with Vagrants sent by legal Passes, or returning after having been so employed; or for any Horses, Coaches, or other Carriages going to or returning from any Election of a Knight or Knights of the Shire to serve in Parliament for the said County of Oxford, on the Day or Days of such Election, or the Day before or Day after such Election shall begin or be concluded; and if any Person shall by any fraudulent or collusive Means whatsoever claim or take the Benefit of any of the Exemptions aforesaid, not being entitled to the same, every such Person shall forfeit and pay for every such Offence any Sum not exceeding Five Pounds, One Moiety whereof shall be paid to the Informer, and the other Moiety shall be applied to the Purposes of the said recited Act and this Act.

Owners or Drivers of Waggons in King's Service, not subject to Penalties for Overweight.

XV. And be it further enacted, That no Person owning or driving, or causing to be driven, any Waggon, Wain, Cart, or other Carriage provided for the Service of His Majesty's Forces, or conveying any Ordnance, Barrack, or Commissariat, or other Public Stores of or belonging to His Majesty, or for the Use of His Majesty's Forces, shall be subject to any Penalty or Forfeiture for Overweight in any such Waggon, Wain, Cart or other Carriage, or for being drawn by any Number of Horses or Oxen; but it shall be lawful for any Owner or Driver of any such Waggon, Wain, Cart or other Carriage, to put any Number of Horses or Oxen to any such Waggon, Wain, Cart or other Carriage; any thing in any Act or Acts of Parliament relating to Highways or Turnpike Roads, or in this Act contained to the contrary notwithstanding.

Abatement of Toll in certain Cases.

XVI. And be it further enacted, That all Waggons, Carts and other Carriages having the Wheels of the Widths and Descriptions, and the Axletrees fixed as mentioned and set forth in and by an Act passed in the Fifty-fifth Year of the Reign of His late Majesty King George the Third, intituled An Act to enable the Trustees of Turnpike Roads to abate the Tolls on Carriages, and to allow of their carrying extra Weights in certain Cases, shall be allowed an Abatement of One-fourth Part of the Tolls by the said recited Act granted.

Trustees to have a Bid-ding when Tolls are put up to Auction.

XVII. And be it further enacted, That when the Tolls payable at any Turnpike or Toll Gate or Gates on the said Road shall be put up to be let to farm, the said Trustees may, if they think fit, appoint some Person to bid for the same, to the Intent that such Tolls may not be let for less than an adequate Value.

Tickets to be provided denoting Payment of Tolls.

XVIII. And be it further enacted, That upon Payment of the Tolls by this Act granted, the Collector or Receiver thereof shall and he is hereby required to deliver gratis to the Person paying such Toll, a Note

a Note or Ticket denoting such Payment, and which Note or Ticket shall be provided by the said Trustees, and there shall be printed and specified thereon the Name or Names of the Gate or Gates freed by such Payment.

XIX. And be it further enacted, That if any Dispute shall happen about the Amount of Tolls due, or the Charges of keeping any concerning Distress, it shall be lawful for the Collector or Person so distraining Tolls. to retain such Distress, or the Money arising from the Sale thereof, (as the Case may happen), until the Amount of the Tolls, or the Charges of the Distress and Sale, and of keeping the Distress, (as the Case may happen), be ascertained by some Justice of the Peace for the County or Place wherein the Cause of Dispute shall arise, who, upon Application made to him for that Purpose, shall examine the Matter by Oath of the Parties or other Witness or Witnesses (which Oath such Justice is hereby authorized and empowered to administer), and shall determine the Amount of the Tolls due, and shall award such Costs and Charges to either Party as to the said Justice shall appear right and proper; all which Costs and Charges shall and may be levied and recovered, in case of Nonpayment thereof forthwith, by Distress and Sale of the Goods and Chattels of the Person or Persons liable to pay the same, by Warrant under the Hand and Seal of such Justice, rendering the Overplus (if any) on Demand, after deducting the Costs and Charges of making such Distress and Sale, to the Person or Persons whose Goods and Chattels shall have been so distrained and sold.

For settling Disputes

XX. And be it further enacted, That if any Mortgagee or Mort- An Action of gagees or Assignee of the said Tolls, Toll Gates, Bars, Chains, Toll Ejectment Houses, and Buildings, shall seek to obtain the Possession of the ported by said Toll Gates, Bars, Chains, Toll Houses, and Buildings, in order One Mortto pay himself, herself, or themselves the Principal Money and gagee. Interest, or any Part thereof, due to him, her, or them, it shall be competent for him, her, or them, as Lessor or Lessors of the Plaintiff, and upon his, her, or their Demise only, and without uniting in such Demise the other Mortgagees of such Tolls and Premises, to obtain such Possession; but such Person or Persons who shall obtain the Possession thereof, shall not apply the Tolls which may consequently be received by him, her, or them, to his, her, or their own exclusive Use and Benefit, but to and for the Use and Benefit of all the Mortgagees of the said Tolls, Toll Gates, Buildings and Premises, pari passu, and in proportion to the several Sums which may be due to them as such Mortgagees or Assignees.

XXI. And be it further enacted, That all and every Toll Collector Toll Collecappointed either by the said Trustees, or by any Lessee or Lessees tors to put up under them, to collect the Tolls payable at any Turnpike or Toll their Names. Gate to be continued or erected by virtue of the said recited Act and this Act, or either of them, upon the said Roads, shall and he is hereby required to place his Christian and Surname, painted on a Board in legible Characters, in the Front or on some other conspicuous Part of the Toll House or Toll Gate, immediately upon coming on Duty, each of the Letters of such Name to be at least [Local.]

One Inch in Length, and of a Breadth in proportion, and painted either in White Letters on a Black Ground, or Black Letters on a White Ground, and shall continue the same so placed during the whole Time he shall be upon such Duty; and if any Collector of the said Tolls shall not place such Board as aforesaid, and keep the same there during the Time aforesaid, or shall demand or take a greater or less Toll from any Person or Persons than he shall be authorized to do by virtue of the Powers of the said recited Act and this Act, or either of them, or shall demand or take a Toll from any Person or Persons who shall be exempt from the Payment thereof, and claim such Exemption, or shall refuse to permit or suffer, or shall in anywise hinder any Person or Persons from reading such Christian or Surname, or shall refuse to tell his Christian or Surname to any Person or Persons who shall demand the same, on having paid the said Tolls or any of them, or shall give a false Name or Names on such Demand, or shall refuse or neglect to deliver a Ticket gratis, denoting the Payment of the Tolls, and naming and specifying the Gate or several Gates freed by such Payment, or shall make use of any scurrilous or blasphemous Language to any Person or Persons travelling upon the said Road, or shall without sufficient Cause detain or delay any Person or Persons travelling thereon, then and in every such Case, évery such Collector shall forfeit and pay any Sum not exceeding Forty Shillings for every such Offence, as the Justice or Justices before whom the Information shall be laid shall adjudge; and such Penalty shall be levied, recovered, paid, and applied in such and the same Manner as other Penalties are by the said recited Act or this Act, or either of them, directed to be levied, recovered, paid, and applied.

Treasurer, Clerk, or Surveyor, by their Order yearly to adjudge and determine what Part or Proportion of the Statute Work shall every Year be done upon the said Road by the Inhabitants of the respective Parishes or Places in which the said Road lies, and also what Proportion of the Money received by the Surveyor or Surveyors of the Highways of every such Parish or Place, in lieu of or as a Composition for such Statute Work as aforesaid, shall be by him, her, or them paid to the said Trustees or to their Treasurer; and in order thereunto it shall be lawful for such Justices from Time to Time to summon the Surveyor or Surveyors of the Highways for every such Parish or Place, to bring in Lists before such Justice or Justices, at some Place to be expressed in such Summons, within Ten Days after the serving of such Summons, of the Names of the several Persons who within such Parish or Place are by Law subject and liable to do Statute Work for that Year, or to the Payment of any Money in lieu of or as a Composition for such Statute Work, distinguishing the Nature of the Work to be done, whether with Teams or Draughts or otherwise, and also the Amount of the respective Sums to be paid; which Lists of Names shall be made in such Manner, and under such Regulations and Restrictions as are or may be directed by any Law or Statute in force or effect for the Repairs of the public Highways; and out of such Lists the said Justices shall and may allot, appoint, and order such and so many of the Persons who shall appear to be subject and liable to do Statute Work as aforesaid, to do such Number of Days Statute Work in every Year upon the said Road as to the said Justices shall seem reasonable; and the same shall be done on such Days, and at such Times (not being Hay-time or Harvest), and in such Parts of the said Road as the said Trustees, or any Three or more of them, or their Surveyor or Surveyors, shall from Time to Time order, direct, or appoint; and the said Justices shall and may order and direct the Persons who by such Lists shall be subject and liable to the Payment of any Money in lieu of or as a Composition for Statute Work as aforesaid, to pay such Proportion thereof as the said Justices shall think proper, to the Surveyor or Surveyors of such Parish, Township, or Place respectively, to be by him, her, or them paid over to the said Trustees, or their Treasurer or Surveyor. at such Time or Times as the said Justices shall direct; and in default of Payment thereof, the same shall and may be recovered by Distress and Sale of the Goods and Chattels of the respective Persons liable to the Payment thereof, in like Manner as any Penalty is by the said Act authorized or directed to be recovered; and each and every Person who shall neglect or refuse to do such Statute Work as aforesaid, after Notice in Writing given to or left for him, her, or them, at his, her, or their last or usual Place or Places of Abode for that Purpose, by any Surveyor to the said Trustees, shall for every Day of his, her, or their Default, or the Default of any Labourer or Labourers, Team or Teams, Draught or Draughts, Horse or Horses, Beast or Beasts to be provided by him, her, or them, be subject and liable to such Fines, Penalties, and Forfeitures as such Person or Persons may be subject or liable to by any Law or Statute now in force or effect for the Repair of the public Highways; and if any Person who shall come to work as a Labourer, or who shall be sent with any Team or Draught to work on the said Road, shall be found

idle or negligent by any Surveyor to the said Trustees, such Surveyor is hereby empowered to remove and dismiss the Person who shall be found idle or negligent as aforesaid; and in that Case every such Person employing or sending such Labourer shall be subject and liable to the respective Forfeitures and Payments as aforesaid, in such and the same Manner as if he had neglected or refused to come, or such Team or Draught had not been sent to work on the said Road; all which Forfeituges shall be paid to the Treasurers of the said Trustees, and applied towards amending the said Road; and in case the Surveyor or Surveyors of the Highways for any of the said Parishes or Places shall refuse or wilfully neglect to give in any such Lists as aforesaid, or shall knowingly or wilfully give in false and imperfect Lists, or shall refuse or neglect to collect or pay over such Composition Money, or any Part thereof, in Manner aforesaid, every such Surveyor so offending shall for every such Offence forfeit and pay any Sum not exceeeding Forty Shillings, to be levied, recovered, paid, and applied in such and the same Manner as Penalties are by the said recited Act directed to be levied, recovered, paid, and applied.

XXXVI. And whereas it is by the said recited Act enacted, that Trustees not where the Course of any Part of the said Road should be diverted compelled to from the old Line of Road, or a new Road made (except any Open Road in the Common Field Land or Common or Waste Ground), the Trustees Hamlet of should and were thereby required to cause good and sufficient Crawley. Mounds, Rails, and Fences to be made, in an husband-like Manner, on both Sides of such new Road where necessary: And whereas Part of the Road directed to be made and repaired by the said Act leads along the old Highway or Road, through and over a certain Common Field and Waste Lands in the Hamlet of Crawley, in the Parish of Witney aforesaid, called Crawley Field, and from the Village of Crawley to the Road at White Oak Green, near a House there called The Bird-in-hand leading to Ramsden, in the said Act mentioned, and Part of the Common Field and Waste Lands hath, for the Convenience of Occupation, been inclosed or divided, but the same has not been inclosed or divided under or by virtue of any Act or Acts of Parliament, and for the Purposes of the said recited Act were and are Common Field; be it therefore enacted, That nothing in the said recited Act enacted shall extend or be construed to extend to compel or require the said Trustees to mound off or fence the said Road, or any Part thereof, within the said Hamlet or Liberty of Crawley.

XXXVII. And be it further enacted, That it shall not be lawful in altering for the said Trustees, in diverting, turning, or altering the Course or Path of any Part of the said Road, to deviate more than One hundred Yards from the present Line or Course of the said Road, Trustees not (unless such new Line or Course shall be along any public Road or Highway) without the Consent in Writing of the Owners or reputed Owners and Occupiers for the Time being of the Lands or Grounds which may be affected by any such Diversion or Alteration.

Houses, &c. XXXVIII. And be it further, enacted, That nothing in this or, the said recited Act, or either of them, contained, shall extend or be construed to extend to authorize the said Trustees, in diverting or altering the Line of the said Road, to take or pull down any Dwel-, ling House or other Building, or to take in or make use of any Orchard, Garden, Yard, Park, Paddock, planted Walk or Avenue to a House, or any inclosed Ground planted and set apart as a Nursery for Trees, or any Part thereof respectively, without the Consent in Writing of the Owner or Proprietor thereof first had and obtained.

For paying the Expences of this Act.

XXXIX. And be it further enacted, That all the Costs, Charges, and Expences incident to and attending the obtaining and passing of this Act, together with lawful Interest from the Time of advancing the same until Payment thereof, shall be paid and discharged by the said Trustees, or any Three or more of them, out of the Monies already collected or received, or out of the first. Monies to be collected or received by virtue of the said recited Act or this Act, or either of them, in preference to all other Payments whatsoever.

Public Act.

XL. And be it further enacted, That this Act shall be deemed and taken to be a Public Act; and shall be judicially taken Notice of as such by all Judges, Justices, and others, without being specially pleaded.

Continuance of Act.

XLI. And be it further enacted, That this Act shall commence and take effect from the passing thereof; and that the said recited Act (subject to the Alterations and Amendments herein contained) and this Act shall continue and be in force and be executed for and during the Residue now to come and unexpired of the Term granted by the said recited Act, and from the Expiration thereof, for and during the further Term of Twenty-one Years, and from thence to the End of the then next Session of Parliament.
