# Cap. cxxxiii.

An Act for more effectually repairing and improving the Road from Reading in the County of Berks to Hatfield in the County of Hertford, and also the Road leading out of the said Road at Marlow to or near the Thirty Mile Stone in the Turnpike Road from Maidenhead to Reading.

[19th June 1829.]

HEREAS an Act was passed in the Eighth Year of the Reign of His late Majesty King George the Third, intituled An Act for repairing, widening, turning, and altering 8 G.3. c.50. the Road leading from Reading in the County of Berks, through Henley in the County of Oxford, and Great Marlow, Chepping Wycombe, Agmondesham, and Cheynes, in the County of Bucks, and Rickmansworth, Watford, and Saint Alban's, to Hatfield, in the County of Hertford; and also the Road leading out of the said Road at Marlow, over Great Marlow Bridge, through Bysham, to or near the Thirty Mile Stone in the Turnpike Road leading from Maidenhead to Reading: And whereas an Act was passed in the Twenty-seventh Year of the Reign of His said late Majesty King George the Third, intituled An 27G.3.c.81. Act for continuing the Term and varying the Powers of an Act of the Eighth Year of the Reign of His present Majesty, for repairing, widening, turning, and altering the Road leading from Reading in the County of Berks, through Henley in the County of Oxford, and Great [Local.] 38 B ~ Marlow,

Marlow, Chipping Wycombe, Agmondesham, and Cheynes, in the County of Bucks, and Rickmansworth, Watford, and Saint Alban's, to Hatfield; in the County of Hertford; and also the Road leading out of the said Road at Marlow, over Great Marlow Bridge, through Bysham, to or near the Thirty Mile Stone in the Turnpike Road leading from Maidenhead to Reading: And whereas an Act was passed in the Forty-ninth Year of the Reign of His said late Majesty King George 49 G. 3. c. 97. the Third, intituled An Act to continue the Term and enlarge the Powers of Two Acts of His present Majesty, for repairing the Road leading from Reading in the County of Berks, through Henley in the County of Oxford, and Great Marlow, to Hatfield in the County of Hertford; and also the Road leading out of the said Road at Marlow, over Great Marlow Bridge, through Bysham, to or near the Thirty Mile Stone in the Road leading from Maidenhead to Reading aforesaid: And whereas the Trustees acting under and by virtue of the said recited Acts have proceeded to put the same into execution, and have borrowed several considerable Sums of Money on the Credit of the several Tolls or Duties granted by the said recited Acts, Part of which still remain due and owing, and cannot be repaid, nor can the said Roads be effectually amended, widened, altered, improved, and kept in repair, unless the Term granted and continued by the said recited Acts be further continued; and it would be more convenient to the said Trustees, and beneficial to the said Roads, if the said recited Acts were repealed, and if further and more effectual Provisions were granted instead thereof: And whereas the making and maintaining of the several Diversions or new Lines of Road hereinafter mentioned would be very advantageous and convenient to the Public; and it is expedient that the same, when made, should be placed under the Care and Management of the Trustees for executing this Act, and form Part of the Roads to be repaired and maintained by them; but the Purposes aforesaid cannot be effected without the Aid and Authority of Parliament: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That on the Recited Acts. Second Tuesday after the passing of this Act the said recited Acts, respectively passed in the Eighth, Twenty-seventh, and Forty-ninth Years of the Reign of His said late Majesty King George the Third, shall be and the same are hereby declared to be repealed, and null and void to all Intents and Purposes whatsoever.

II. And be it further enacted, That this Act shall thereupon commence and take effect, and shall be put in execution for and during the Term herein-after mentioned, for the Purpose of more effectually repairing the repairing, widening, altering, diverting, improving, and keeping in Roads herein repair the Road leading from the North End of Caversham Bridge in the County of Oxford, being the Extremity of the Borough of Reading aforesaid, to the Three Horse Shoes Public House in the Town of Henley-upon-Thames in the County of Oxford aforesaid, and from the Henley and Dorchester Turnpike Road, near the Bell Inn, unto the South-west Corner of a Barn in the Occupation of Thomas Wethered Esquire, at the West Entrance of the Borough of Great Marlow

This Act to commence and be put in force for described.

Marlow in the said County of Bucks, and also the Road leading from the South End of Great Marlow Bridge, to or near the Thirty Mile Stone in the Turnpike Road leading from Maidenhead to Reading aforesaid, and also the Road leading from the Turnpike Gate at the North End of Chapel Street in the Borough of Great Marlow aforesaid, to a certain Bridge contiguous to a certain House or Farm called Lokes, at the South End of Saint Mary's Street in the Borough of Chepping Wycombe in the said County of Bucks, and from the Northeast Corner of a House in the Occupation of Sarah Bates Widow, at the North End of Crendon Lane in the said Borough of Chepping Wycombe, to the North-west Corner of a Garden Wall in the Occupation of James Bricknell, at the North Entrance of the Town of Amersham otherwise Agmondesham in the said County of Bucks, and from the Turnpike Road at the East End of the said Town of Amersham otherwise Agmondesham; to the South-east Corner of a Dwelling House in the Occupation of Samuel Norcott, situate at the Entrance of the Town of Rickmansworth in the County of Hertford, and from the North-west Corner of a Dwelling House in the Occupation of Job Woodman Esquire, situate at the North End of the said Town of Rickmansworth, to the West Corner of a Dwelling House in the Occupation of John Wellingham, at the Commencement of Holywell Hill or Holywell Street in the Borough of Saint Alban in the said County of Hertford, and from the Peacock Public House at the End of Cock Lane, in the Borough of Saint Alban aforesaid, to the Boundary of the Parish of *Hatfield* in the said County of *Hertford*.

III. Provided always, and be it further enacted, That it shall not No Money be lawful for the said Trustees to apply, expend, or appropriate any of the Tolls hereby granted, or any of the Monies now borrowed or hereafter to be borrowed upon the Credit thereof, in paving, lighting, watching, repairing, amending, or improving any of the Roads, Streets, Footways, or Pavements within any or either of the said Towns of Henley-upon-Thames, Great Marlow, Chepping Wycombe, Amersham otherwise Agmondesham, Rickmansworth, or Saint Alban.

IV. And be it further enacted, That all Arrears of Tolls or Rents and other Monies due to, and all other Property, Real or Personal, and all Choses in and Rights of Action, either at Law or in Equity, vested in vested in the Trustees acting in the Execution of the said former Trustees Acts or any of them, shall immediately on the passing of this Act be under this vested in the Trustees acting in the Execution of this Act.

VI. And be it further enacted, That it shall be lawful for the said Trustees may Trustees and they are hereby authorized and empowered, at any be appointed. General Meeting from Time to Time to be held for that Purpose, to elect and appoint any Number of Persons, not exceeding Six in the whole, to be Trustees for executing this Act, in addition to the Trustees herein named and appointed, and such additional Trustees, so elected and appointed, being duly qualified, shall be and they are hereby invested with the same Powers and Authorities for executing this Act as if they had been named in and appointed by this Act.

Division of Roads into Districts.

VII. And whereas in consequence of the great Extent of the said Road it is expedient and necessary that the same should be divided into Districts; be it therefore further enacted, That the Roads hereby directed to be repaired shall be divided into Three separate Districts or Divisions; and that so much and such Part of the Roads hereby directed to be repaired as lies between the North End of Caversham Bridge

Bridge aforesaid, and the South-west Corner of a Barn in the Occupation of Thomas Wethered Esquire, at the West Entrance of the Borough of Great Marlow in the County of Bucks, and also the Road leading from the South End of Great Marlow Bridge to the Thirty Mile Stone in the Turnpike Road leading from Maidenhead to Reading aforesaid, shall be and be called the First District of the said Roads; and that so much and such Part of the Roads hereby directed to be repaired as lies between the Turnpike Gate at the North End of Chapel Street in the Borough of Great Marlow aforesaid, and the South-east Corner of a Dwelling House in the Occupation of Samuel Norcott, situate at the Entrance of the Town of Rickmansworth in the County of *Hertford*, shall be and be called the Second District of the said Roads; and that so much and such Part of the Roads hereby directed to be repaired as lies between the North-west Corner of a Dwelling House in the Occupation of Job Woodman Esquire, situate at the North End of the said Town of Rickmansworth, and the Boundary of the Parish of Hatfield in the said County of Hertford, shall be and be called the Third District of the said Roads.

VIII. And be it further enacted, That the said Trustees for all the Time and said Districts, or any Five or more of them, shall hold their First Place of First General Meeting at Great Marlow, or at some other convenient Place Trustees. upon or near to the said Road, on the Second Saturday next after the Commencement of this Act, or as soon after as conveniently may be, and shall then and there proceed in the Execution of this Act; and the said Trustees shall and they are hereby required afterwards to hold Two General Meetings in every Year, (that is to say,) one on the Third Saturday in the Month of May, at Great Marlow aforesaid, and the other on the First Tuesday in the Month of October, at Saint Albans.

IX. And be it further enacted, That the said Trustees, or any Five Two General or more of them, shall at such General Meetings declare in Writing Meetings to what Sum or Sums of Money shall be annually or otherwise laid out be held in each Year. and expended in the repairing and improving the Roads within the said respective Districts or Divisions, and other the Purposes relating thereto; and the said Trustees, or any Five or more of them, shall order and cause the said Sum or Sums of Money to be paid by their Treasurer or Treasurers to the respective Treasurer or Treasurers for the District or Division where the same is to be laid out and expended: Provided always, that it shall not be lawful for the said Trustees at any of their said Meetings to order or direct a larger Sum of Money to be laid out and expended in the repairing the Roads within any of the said Districts respectively than shall be collected at the Turnpikes or Toll Gates within such District, or received as Composition for Statute Duty.

X. And be it further enacted, That the said Trustees, or any Three District or more of them, shall from Time to Time meet in their respective Districts or Divisions for the Purposes of this Act, and shall at such Meetings order and direct in what Manner the Sum or Sums of Money apportioned by the General Meetings to be laid out and expended in the repairing and improving the Roads within the respective Districts

Meetings of the Trustees

tricts or Divisions, and other the Purposes relating thereto, shall from Time to Time be laid out and applied.

Meetings may be adjourned by the Clerk in case a suffiof Trustees do not attend.

XI. And be it further enacted, That if it shall happen that there shall not appear at any such General or District or Division Meeting respectively a sufficient Number of Trustees to act or adjourn, the Clerk to the General Meetings, if such Default shall happen at a cientNumber General Meeting, and the District Clerk if at a District Meeting, shall adjourn the said Meeting, and appoint the said Trustees to meet at the Place where the last Meeting was appointed to be held, on some Day within One Calendar Month next after the Day on which such last Meeting was appointed to be held, and shall cause Notice to be affixed on all the Turnpikes which shall be then erected on the said Roads in case such Default of a General Meeting shall happen, and if such Default of a District or Division Meeting shall happen, then on all the Turnpikes which shall be then erected within the District or Division where such Default shall happen; and Three Trustees present at any Meeting shall be sufficient for the Purpose of Adjournment only.

Old Officers, except the Treasurer, to continue until removed.

XII. Provided always, and be it further enacted, That each and every Clerk, Collector, Surveyor, and other Officer (except the Treasurer), appointed under and by virtue of the said recited Acts hereby repealed, shall hold and enjoy such their several and respective Offices and Employments until he or they shall be removed therefrom by the Trustees for executing this Act, at a General Meeting or District Meeting, as the Case may be; and each and every such Clerk, Collector, Surveyor, and other Officer shall have the like Powers and Authorities for the Purposes of this Act, and for carrying the same into execution, and shall be subject to the like Pains and Penalties, and to the like Power of Removal, and to the like Rules and Regulations, in all respects whatsoever, as if he or they had been nominated and appointed by virtue of this Act.

Power to continue and erect Toll Gates, &c.

XIII. And be it further enacted, That it shall and may be lawful for the said Trustees to continue the Toll Gates or Turnpikes, Side Gates, Bars, Chains, and Toll Houses, now standing and being in, upon, or across the said Road, or on the Sides thereof, and to remove the same or any of them, and also to erect and set up or build, or cause to be erected, set up, or built, in lieu thereof and in addition thereto, upon, in, or across the said Road, or any Part thereof, or upon the Sides thereof, when and where and as they shall judge necessary, any Gates, Turnpikes, Side Gates, Side Bars, Chains, or Weighing Machines, and also One or more Toll House or Toll Houses, with Outhouses and Conveniences suitable thereto, at or near to each Gate, Bar, Chain, or Weighing Machine, and to take in and inclose on the Sides of the said Roads suitable Garden Spots for the same respectively, not exceeding One Eighth Part of a Statute Acre each, as they shall think necessary, and from Time to Time to take down and remove or alter or discontinue the same or any of them, as they the said Trustees shall think proper, and direct or appoint: Provided always, that no Turnpike or Toll Gate shall be taken down or removed by Order

Order of such Trustees, unless such Order be made by a Majority of the Trustees present at some General Meeting, at which Seven Trustees at the least shall be present, nor unless Fourteen Days Notice of such Meeting, and of the Intention to propose the taking down or removing such Toll Gate or Turnpike, shall be affixed on the said Toll Gates or Turnpikes then erected on the said Road, signed by the Clerk or Clerks to such Trustees, or by any Three or more of the said Trustees, and also inserted Twice in some Newspaper generally circulated in the said Counties of Berks, Bucks, Oxford, and Hertford.

XIV. And be it further enacted, That it shall be lawful for the Power to said Trustees, or such Person or Persons as shall be by them ap- take Tolls. pointed, to demand, receive, and take, at the Turnpikes or Toll. Gates, Side Bars or Chains, now erected and to be continued or hereafter to be erected by virtue of this Act, the several Tolls and Duties herein-after mentioned; (that is to say,)

For every Horse or Beast of Draught drawing any Coach, Chariot, Tolls. Landau, Berlin, Barouche, Chaise, Calash, Curricle, Hearse, or Chair, the Sum of Four-pence:

For every Horse or Beast of Draught drawing any Waggon, Wain, Drag, Cart, or other such like Carriage, with Fellies or Rollers of the Breadth or Gauge of Six Inches at the least, or with Axletrees of different Length, rolling Six Inches at the least on each Side, the Sum of Three-pence:

For every Horse or Beast of Draught drawing any Waggon, Wain, Drag, Cart, or other such like Carriage with Four Wheels, having the Fellies of the Wheels thereof of the Breadth or Gauge of Four Inches and a Half, the Sum of Four-pence:

For every Horse or Beast of Draught drawing any Waggon, Wain, Cart, or other such like Carriage, having the Fellies of the Wheels thereof of less Breadth or Gauge than Four Inches and a Half, the Sum of Four-pence Halfpenny:

For every Horse, Mule, or Ass, laden or unladen, and not drawing, the Sum of One Penny:

For every Drove of Oxen or Neat Cattle, the Sum of Ten-pence per Score, and so in proportion for any less Number:

And for every Drove of Calves, Hogs, Sheep, or Lambs, the Sum of Five-pence per Score, and so in proportion for any less Number.

XV. Provided also, and be it further enacted, That if any Person Tolls to be shall have paid the Toll hereby authorized to be taken for the passing paid but once of any Horse or Horses, Cattle, Beast, Carriage or Carriages, through a Day for any of the Turnpikes, Toll Gates, Side Gates or Bars, continued or to be erected by virtue of this Act, the same Horse or Horses, Cattle, through the Beast, Carriage or Carriages, shall, upon a Ticket denoting the Pay- same Gate. ment thereof on that Day being produced, be permitted to pass and repass Toll-free (except as herein-after particularly mentioned) through the same Toll Gate, Turnpike, Side Gate or Bar, and also through such other Gate or Gates (if any) as the Ticket for such Payment shall free, at any Time during the same Day, such Day to be computed from Twelve of the Clock at Night to Twelve of the  $oxed{Local.}$ Clock

passing and repassing

Clock in the next succeeding Night; any thing herein contained to the contrary thereof in anywise notwithstanding.

Limiting the Number of Tolls to be taken.

XVI. And be it further enacted, That no more than One full Toll shall be demanded or taken for or in respect of the same Horses, Beasts, or Cattle, except as herein-after mentioned, for passing on the same Day (such Day to be computed as aforesaid) through all or any of the Toll Gates, Turnpikes, or Side Gates along the whole Line of the said Roads.

Horses, &c. drawing different Wag-gons, &c. to pay each Time of passing.

XVII. Provided also, and be it further enacted, That the said Tolls shall be payable at the said Turnpikes, Toll Gates, and Side Gates already erected on the said Roads, and hereafter to be erected, in respect of Horses or other Beasts of Draught drawing any Waggon, Wain, Cart, or such like Carriage, for every Time during the same Day that any such Horse, Ass, or other Beast of Draught shall pass through either of the said Turnpikes, Toll Gates, or Side Gates, drawing any other Waggon, Wain, Cart, or such like Carriage than that which such Horse or other Beast of Draught was employed in drawing on any former Occasion during the same Day on which Toll shall have been paid.

Tolls on Stage Coaches and Post Chaises.

XVIII. Provided always, and be it further enacted, That for and in respect of all Horses or Beasts drawing any Stage Coach, Waggon, Van, Caravan, or other Stage Carriage carrying Passengers or Goods for Payment, Hire, or Reward, for which Toll shall have been paid, and which shall return on the same Day through the same Turnpike or Toll Gate, the Tolls hereby made payable shall be paid for repassing through such Toll Gate, in like Manner as if no Toll had been paid, and the Tolls thereby made payable shall be paid for or in respect of all Horses or other Beasts drawing any Post Chaise or other Carriage travelling for Hire, for every Time of passing or repassing through the Turnpikes or Toll Gates or Side Bars already erected or to be erected, on the same Day, as often as a fresh Hiring thereof shall take place.

Fractional
Parts of a
Halfpenny
in Tolls.

XIX. And be it further enacted, That in all Cases where there shall be a fractional Part of a Halfpenny in the Calculation of the Amount of the Tolls hereby granted and authorized to be taken, or any of them, the Sum of One Halfpenny shall be demanded and taken in lieu of such fractional Part.

For vacating the present Leases of Tolls.

XX. And be it further enacted, That all Demises or Leases of the Tolls arising on the said Roads by this Act authorized to be repaired, and all Bonds or other Securities which shall have been given for Payment of the Rents reserved by such Leases respectively, and for the Performance of the Covenants and Agreements in such Leases contained on the respective Lessee's Part, shall respectively, at Twelve of the Clock at Noon on the First Day of July next, cease and determine, in the same Manner as if such Leases, Bonds, or other Securities had expired by Effluxion of Time, save as to the Obligations, Covenants, or Agreements for Payment of Rent and Performance of

Covenants in such Leases, Bonds, or other Securities, on the respective Lessee's or Obligor's Part to be observed and performed, and then remaining due and undischarged,

XXI. And be it further enacted, That in case any Lessee or Differences Lessees of the said Tolls shall claim to be entitled to any Compen- on vacating sation or Satisfaction for or on account of such Determination of his, Leases how to be settled. her, or their Lease or Leases as aforesaid, then if the said Trustees and such Lessee or Lessees cannot agree as to the Amount of such Compensation or Satisfaction, such Lessee or Lessees may sue for and recover the same by Action of Debt or on the Case in any of His Majesty's Courts of Record at Westminster, or the same shall be referred to the Award and Determination of One Person to be chosen by or on behalf of the said Trustees, and One Person by such Lessee or Lessees, and such Two Persons, or an Umpire to be by them chosen in case of Difference, shall finally settle and determine the same.

XXII. And whereas it frequently happens that Carts drawn by One One Horse Horse passing along the said Roads carry a greater Weight than is by Carts may be Law allowed for Carts drawn by Two or more Horses; be it there- weighed. fore further enacted, That all Carts passing along the said Roads drawn by One Horse only shall and may be weighed at any Weighing Machine to be erected on the said Roads, and the like additional Tolls demanded, received, and recovered for the Overweight thereof as are by Law payable in respect of the Overweight of Carts drawn by Two or more Horses; and all the Powers, Regulations, and Penalties now in force relating to the weighing of Waggons, Carts, and other Carriages drawn by more than One Horse, shall be applicable to Carts passing on the said Roads drawn by One Horse only, and to the Drivers, Masters, and Owners thereof.

XXIII. And be it further enacted, That if any Person or Persons Penalty for shall hang or put or place out any Linen or other Clothes on any hanging out Line, Bank, Rail, or Fence adjoining the said Roads, or shall hang on the Sides or put or place any Hook or Hooks, or other Thing or Things, to, of the Roads. from, or in any House, Shop, or Place adjoining or being near to the said Roads, so as to project into the said Roads, or be an Annoyance to any Persons or Cattle passing thereon, or prevent the free and safe Use of the whole Breadth of the said Roads, every Person offending in any of the Cases aforesaid shall forfeit and pay a Sum not exceeding Forty Shillings for every Offence; and such Penalty shall be levied and recovered (together with the necessary Costs and Charges of levying the same) by the same Ways and Means as any Penalty or Forfeiture for any Nuisance committed in or upon any Turnpike Road may by Law be levied or recovered; and one Moiety of such Penalty shall be paid to the Informer, and the other Moiety thereof shall be paid to the Treasurer to the said Trustees, and be applied and disposed of for the Purposes of this Act.

Clothes, &c.

XXIV. And be it further enacted, That in all Places throughout the said Roads hereby directed to be repaired, where any Entrance Fields, &c. to shall be from the said Roads to any Field, Garden, Yard, or other hard Mate-Land rials.

Entrances to

Land or Ground, or to any Buildings, from the said Roads or any Part thereof, such Entrance shall be properly covered with Stone, Gravel, or other hard Materials, and a proper Culvert or Drain made, by or at the Expence of the Proprietor or Occupier of such Field, Garden, Yard, Land, Ground, or Building, so that such Road may not be injured by the Stoppage or Running of Water, or by Carriages or Horses passing to or from the same by such Entrance; and in case such Proprietor or Occupier shall neglect to cover with proper Materials such Entrance, or to make such Culvert or Drain, or to put and keep the same respectively in proper Order, for the Space of One Calendar Month after Notice in Writing given to such Proprietor or Occupier, or left for him or her at his or her usual or last Place of Residence, by the Surveyor or Surveyors to the said Trustees, or other Person or Persons appointed by them, requiring such Proprietor or Occupier so to make or repair the same, then it shall be lawful for the said Trustees, or their Surveyor or Surveyors, or any other Person or Persons acting by or under their Authority, to cover such Entrance with Stone, Gravel, or other hard Materials, and to make such Culvert or Drain, or to repair the same respectively, as the Case may be; and the Expences thereof shall be reimbursed and paid to the said Trustees by such Proprietor or Occupier, as the Case may be; and in case of Nonpayment of such Expences within Fourteen Days after the same shall have been demanded by or on behalf of the said Trustees, then such Expences shall and may be recovered, together with the Costs and Charges attending the recovering the same, by Distress and Sale of the Goods and Chattels of such Proprietor or Occupier, by Warrant under the Hand and Seal or Hands and Seals of any Justice or Justices of the Peace for the County, Borough, or separate Jurisdiction within which such Default in Payment shall be made, or for the County, Borough, or separate Jurisdiction within which the Goods and Chattels of such Proprietor or Occupier shall be or be situate; and which Warrant of Distress any such Justice or Justices is or are hereby authorized and empowered to grant, on Proof made before him or them on Oath of such Expence having been incurred, and of such Notice having been given as aforesaid; and any Overplus shall be returned, on Demand, to the Person or Persons whose Goods and Chattels shall have been so distrained and sold.

Trustees to make and set out Roads.

XXV. And be it further enacted, That it shall be lawful for the said Trustees, and they are hereby authorized and empowered, to divert and turn certain Parts of the said Roads herein-before described, according to the Map or Plan herein-after referred to, in such Manner as to them shall seem right and proper.

Map or Plan deposited at the Clerk of the Peace to be open to Inspection, and Roads to be made according thereto.

XXVI. And whereas a Map or Plan describing the Line of the the Office of Parts of the said Roads so proposed to be diverted, turned, and widened, and the Messuages or Tenements, Lands and Hereditaments, through or over which the same are to be made and carried, together with a Book of Reference containing a List of the Names of the Owners and Occupiers of such Messuages or Tenements, Lands and Hereditaments, have been deposited at the Office of the Clerk of the Peace of the Liberty of Saint Alban, in which Liberty the Parishes

Parishes of Rickmansworth and Watford are situate; be it therefore further enacted, That the said Map or Plan and the Book of Reference shall remain in the Custody of the said Clerk of the Peace, to the end that all Persons may at all seasonable Times have Liberty to inspect and peruse the same, and to take Copies or Extracts thereof, at their Will and Pleasure, paying the said Clerk of the Peace the Sum of One Shilling for every such Inspection, and at the Rate of Sixpence for every One hundred Words of such Copies or Extracts of the said Map or Plan and Book of Reference; and the said Trustees in making the said Roads shall not deviate more than One hundred Yards from the Line described in the said Map or Plan, without the Consent in Writing of the Person or Persons, Bodies Politic, Corporate, or Collegiate, through whose Messuages or Tenements, Lands and Hereditaments, such Deviation shall be made.

XXVII. Provided always, and be it further enacted, That it shall Lands be lawful for the said Trustees to make the said Roads into, through, across, or over the several Messuages or Tenements, Lands and Here- be used notditaments, of any Person or Persons who is or are or may be Owner or Owners of Messuages or Tenements, Lands and Hereditaments, Errors in the over which the same is or are set out and described in the said Map Books of Reand Plan as aforesaid, although the Name or Names of such Person or Persons may happen to be omitted or mis-stated in the said Book of Reference, in case it shall appear to any Two or more Justices of the Peace for the said Liberty of Saint Alban, and be certified by Writing under their Hands, that such Error or Omission proceeded from Mistake.

XXVIII. And whereas, for the Purpose of making, widening, alter- Trustees ing, diverting, and otherwise improving the Roads comprised in this Act, or some of them, it will be necessary to purchase, take, and use, among other Messuages or Tenements, Lands and Hereditaments,) ings. the several Messuages or Tenements, Buildings, Gardens, Yards, Paddocks, Plantations, and other Premises specified or mentioned in the Schedule to this Act; be it therefore enacted, That it shall be lawful for the said Trustees, and they are hereby authorized and empowered, for any of the Purposes aforesaid, to purchase, take, and use all or any of the Messuages or Tenements, Houses, Buildings, Gardens, Yards, Paddocks, Plantations, and other Premises mentioned in the Schedule to this Act, or such Part or Parts thereof as to the said Trustees shall seem necessary, and to pull down such Buildings or any Part thereof, and to lay the Site or Sites thereof into the said Roads; but full and ample Compensation shall be made to the several Parties interested therein for the same, and for the Damage they shall sustain thereby.

XXIX. Provided always, and be it further enacted, That if the said Power to Trustees shall not within the Space of Five Years from the Commence-purchase to ment of this Act agree for, or cause to be valued and paid for, the several Houses, Buildings, Gardens, Yards, Paddocks, Plantations, and Five Years. other Tenements and Premises which they are hereby empowered to purchase as aforesaid, or so much thereof as they shall deem necessary or proper for the Purposes of this Act, then and from thenceforth [Local.]

Application of Money in hand and of the Tolls and Money to be borrowed.

XXX. And be it further enacted, That out of the Money already received or borrowed by virtue of the said recited Acts hereby repealed, and out of the Money which shall or may arise or be received from the Tolls by this Act granted, the said Trustees shall in the first place pay and discharge all the Costs and Charges incident to and attending the obtaining and passing of this Act, together with lawful Interest of any Money to be borrowed for Payment of such Costs and Expences from the Time of advancing the same to the Time of the Payment thereof; and the Remainder of all such Monies already received, arising, or to be borrowed on the Credit of the said Tolls on the said Roads, shall be applied in keeping down the Interest of the Principal Monies advanced or borrowed on the Credit of the Tolls collected or arising from or payable on account of the said Roads, and which may hereafter be borrowed on the Credit of this Act, or of the Tolls to arise from or to be collected on or to be paid in respect of the said Roads, and in erecting Turnpikes and Toll Houses on the said Roads, and in amending, altering, turning, widening, improving, and keeping in repair the said Roads, and otherwise in putting this Act into execution, and in repaying the Principal Monies already borrowed on the Credit of the Tolls collected on or arising from or payable in respect of the said Roads, and the Principal Monies which may hereafter be borrowed by virtue of this Act.

Public Act.

XXXI. And be it further enacted, That this Act shall be deemed and taken to be a Public Act; and shall be judiciously taken notice of as such by all Judges, Justices, and others, without being specially pleaded.

Commencement and **Duration** of this Act.

XXXII. And be it further enacted, That this Act shall commence and take effect on the Second Tuesday after the passing thereof, and shall continue and be in force for and during the Term of Thirty-one Years, and from thence to the End of the then next Session of Parliament.
