## *Cap. lxxxix.*

An Act for more effectually amending the Road from *Oldham* in the County of *Lancaster* to *Ripponden* in the County of *York*, and other Roads in the same Counties; and for making and maintaining a new Branch to communicate therewith.  
[22d *May* 1829.]

**W**HEREAS an Act was passed in the Fifty-second Year of the Reign of His late Majesty King *George* the Third, intituled *An Act for amending the Roads from Oldham in the County of Lancaster to Ripponden in the County of York, and from Denshaw to Brownhill, and from Grains to Delph, all within Saddleworth in the said County of York*: And whereas the Trustees appointed in or by virtue of the said recited Act of the Fifty-second Year of the Reign of His late Majesty King *George* the Third have proceeded to put the same into execution, and have made considerable Progress in repairing and improving the Roads therein mentioned: And whereas the making and maintaining of a new Branch of Road from the said Road, commencing at or near *Spaw Bridge* on or near *Booth Dean* in the Township of *Rishworth* in the Parish of *Halifax* in the said County of *York*, and passing through the said Township of *Rishworth*, and the Townships of *Butterworth* and *Castleton* in the Parish of *Rochdale* in the County of *Lancaster*,

and terminating at or near the Market Town of *Rochdale* in the said County of *Lancaster*, and from or near a Place called *Plumb House*, in the said Township of *Butterworth*, on the Southerly Side of the Fence to the River *Beal*, to *Fir Grove* in the same Township, to join the *Hollinwood* and *Littleborough* Turnpike Road there, would be of great Advantage and Convenience to the Owners and Occupiers of Lands in the Neighbourhood of the said Roads, and would also be of great public Utility: And whereas it would be more convenient if the said recited Act of the Fifty-second Year of the Reign of His late Majesty King *George* the Third was repealed, and further, better, and more effectual Powers granted, as well for the making and maintaining, diverting, widening, and improving of the new Branch of Road herein-before mentioned, as for repairing, widening, diverting, and improving the present Roads included and comprised in the same Act; but the beneficial Purposes aforesaid cannot be effected without the Aid and Authority of Parliament: May it therefore please Your Majesty that it may be enacted; and be it enacted by the King's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, That from and after the passing of this Act the said recited Act of the Fifty-second Year of the Reign of His said late Majesty King *George* the Third shall be and the same is hereby declared to be repealed.

Recited Act repealed.

This Act to be put in execution for repairing the Roads herein described.

II. And be it further enacted, That this Act shall be put in execution for and during the Term herein-after mentioned, as well for the Purpose from Time to Time of repairing, widening, altering, diverting, and improving the Roads from *Oldham* in the County of *Lancaster* to *Ripponden* in the County of *York*, and from *Denshaw* to *Brownhill*, and from *Grains* to *Delph*, all within *Saddleworth* in the said County of *York*, as also for the Purpose of making and from Time to Time repairing, widening, altering, and improving a new Branch of Road from the said present Road, commencing at or near *Spaw Bridge* on or near *Booth Dean* in the Township of *Rishworth* in the Parish of *Halifax* in the County of *York*, and passing through the said Township of *Rishworth*, and the Townships of *Butterworth* and *Castleton* in the Parish of *Rochdale* in the County of *Lancaster*, and terminating at or near *Summer Castle* in or near the Market Town of *Rochdale* aforesaid, and from or near a Place called *Plumb House*, in the said Township of *Butterworth*, on the Southerly Side of the Fence to the River *Beal*, to *Fir Grove* in the same Township, to join the *Hollinwood* and *Littleborough* Turnpike Road there.

IV. And be it further enacted, That it shall and may be lawful for the said Trustees and they are hereby authorized and empowered, from Time to Time, at any of their Meetings, to elect and appoint any Number of Persons, being duly qualified to act as Trustees of Turnpike Roads, (not exceeding Five in the whole in addition to the Number of Trustees herein named and appointed,) to be Trustees for the Purposes of this Act; and such Persons so elected and appointed shall be Trustees for the Purposes of this Act, and they are hereby invested with the same Powers and Authorities for executing this Act as if they had been herein named.

First Meet-

V. And be it further enacted, That for putting this Act into execution the said Trustees shall meet at the *Junction Inn in Saddleworth* aforesaid, or at some other convenient Place near to the said Roads, on the Third *Wednesday in August* next after the passing of this Act, or as soon after as conveniently may be, for the Purpose of proceeding

proceeding to execute this Act, and shall and may then and from Time to Time after adjourn to and meet at such Time and Times and such Place or Places in the Neighbourhood of the said Roads as they shall think proper.

VI. And be it further enacted, That the respective Sums herein-  
after mentioned shall or may be demanded and taken for Tolls; (that  
is to say,) Tolls.

For every Horse or other Beast drawing any Coach, Chaise, Chariot, Hearse, Curricule, Gig, Caravan, Van, or other such like Carriage, the Sum of Four-pence:

For every Horse or other Beast drawing any Waggon or other such Carriage upon Three or Four Wheels of the Breadth of Six Inches or upwards at the Bottom or Soles thereof, the Sum of Four-pence; of a less Breadth than Six Inches and not less than Four and a Half Inches, the Sum of Eight-pence; and of a less Breadth than Four and a Half Inches, the Sum of One Shilling:

For every Horse or other Beast drawing any Cart or other such Carriage with Two Wheels of the Breadth of Six Inches or upwards at the Bottom or Soles thereof, the Sum of Four-pence; of a less Breadth than Six Inches and not less than Four and a Half Inches, the Sum of Five-pence; and of a less Breadth than Four and a Half Inches, the Sum of Sixpence:

For every Horse, Mule, or Ass, laden or unladen, and not drawing, the Sum of Three Halfpence:

For every Drove of Oxen, Cows, or Neat Cattle, *per* Score, the Sum of Ten-pence, and so in proportion for any greater or less Number: And for every Drove of Calves, Pigs, Sheep, or Lambs, *per* Score, the Sum of Five-pence, and so in proportion for any greater or less Number.

VII. Provided always, and be it further enacted, That when the full Toll shall have been paid for or in respect of any Horse or other Beast passing through any of the Toll Gates or Turnpikes, Side Gates or Side Bars or Chains, erected or to be erected on the said Roads or Branch herein-before mentioned, and hereby authorized to be made, such Horse or other Beast shall (on a Ticket being produced denoting such Payment) be permitted to go and return Twice over through the same Toll Gates or Turnpikes, Side Gates or Side Bars or Chains, Toll-free the same Day; but if any such Horse or other Beast shall pass or go a Fifth Time on the same Day through all or any of the said Toll Gates or Turnpikes, Side Gates, Side Bars, or Chains, then and in such Case a new Toll shall be demanded and taken for the same, and so *toties quoties* for every Fifth Time of passing. Tolls to be paid but Once for passing and repassing on same Day.

VIII. And be it further enacted, That it shall not be lawful for the said Trustees, or any Person appointed or continued Collector of the Tolls mentioned in this Act, to demand and take the respective Sums or Tolls aforesaid at more than Six Gates in any One Day in respect of the same Horse, Beast, or Cattle passing and repassing in the same Day through all the Toll Gates, Turnpikes, and Side Gates along the whole Line of the said Roads or Branch. Limiting the Number of Payments on the whole Line of Road.

IX. Provided also, and be it further enacted, That the Tolls payable for or in respect of Horses or Beasts drawing any Stage Coach, Diligence, Van, Caravan, Stage Waggon, or other Stage Carriage conveying Passengers or Goods for Pay or Reward, shall be payable and paid every Time of passing or repassing along the said Roads or Branch or any of them.

X. Provided also, and be it further enacted, That the Tolls payable for or in respect of Horses or Beasts let out to Hire, and drawing any Post Chaise or other Carriage, shall be payable and paid every Time of passing along the said Roads or Branch or any of them, whenever any new Hiring thereof shall take place.

XI. And be it further enacted, That out of the Tolls and other Monies collected or received under or by virtue of the said recited Act hereby repealed, or out of the Tolls and other Monies arising under or by virtue of this Act, the said Trustees shall, in the first place, pay and discharge the Costs, Charges, and Expences incurred in, about, and relating to the obtaining and passing of this Act; and then the Remainder of all such Monies shall (after Payment of the necessary Expences from Time to Time of erecting or repairing Toll Gates, Toll Houses, Milestones, or Posts, or Fences, and for Books, Advertisements, Salaries of Officers, and other Expences incidental to the Execution of this Act,) be applied, in the first place, in keeping down the Interest of the whole Monies now borrowed and due or hereafter to be borrowed or grow due upon the Credit of the said Tolls, as well now in arrear as herein-after to grow due, to be paid to all the respective Creditors equally and without Preference, and after Payment thereof, in repairing, widening, altering, diverting, and otherwise improving the Roads included in the said recited Act hereby repealed, and in making, repairing, altering, widening, diverting, and improving the said Branch herein-before mentioned, and in repaying the Principal Monies which have been heretofore borrowed or advanced on the Credit of the Tolls arising on the said Roads, and the Principal Monies which may be hereafter borrowed or advanced on the Credit of the Tolls arising under or by virtue of this Act, and in otherwise putting this Act into execution.

XII. Provided always, and be it further enacted, That no Money arising from any of the Tolls mentioned in this Act shall be applied in or towards the Repair of any Branch Road comprised in this Act, unless some Toll Gate, Toll Bar, or Turnpike shall be erected and continued upon such Branch Road; nor unless the Tolls herein mentioned shall be demanded and taken thereat: Provided also, that no more Money shall be expended by the said Trustees in or towards the Repair of any such Branch Road than shall be collected thereon.

XIII. And be it further enacted, That it shall be lawful for the said Trustees and they are hereby authorized and empowered to, set out and make the said Extension or new Branch of Road from *Booth Dean* to *Rochdale* aforesaid, and from or near *Plumb House*, on the Southerly Side of the Fence to the River *Beal*, to *Fir Grove*, aforesaid, according

according to the Lines described in the Map or Plan herein-after mentioned, and for such Purpose also to take and use the Buildings, Gardens, and Premises described in the Schedule to this Act annexed; any thing in any Law or Statute relating to Turnpike Roads contained to the contrary notwithstanding: Provided always, that it shall not be lawful for the said Trustees to commence or make any Part of so much of the Line of Road between *Booth Dean* and *Rochdale* as lies between a Field numbered (17) in the Book of Reference herein-after mentioned, and the Town of *Rochdale*, without the Consent first had and obtained of *Richard Greaves Townley* Esquire, the Owner of the major Part of the Lands and Grounds situate between the said Field and *Rochdale* aforesaid, or the Consent of the Person or Persons being Owner or Owners for the Time being of the major Part of the said Lands and Grounds now belonging to the said *Richard Greaves Townley*, situate between the same Field and *Rochdale* aforesaid.

XIV. And whereas a Map or Plan, describing the Lines of the said intended Branch, and the Lands through or over which the same is; or are to be carried or made, together with a Book of Reference containing a List of the Names of the Owners and Occupiers of such Lands, have been deposited in the Office of the Clerk of the Parliaments; be it therefore enacted, That the said Trustees in making the said Branch shall not deviate more than One hundred Yards from the Lines described in the said Map or Plan, without the Consent in Writing of the Person or Persons, or Party or Parties, or Body or Bodies Politic, Corporate, or Collegiate, through whose Land such Deviation shall be made; and the said Map or Plan and Book of Reference shall remain in the Custody of the Clerk of the Parliaments; and the same, or any Copy or Copies thereof, certified by the Clerk of the Parliaments to be a true Copy or true Copies thereof, shall and is and are hereby declared to be good Evidence, and shall be admitted as such by all Judges, Justices, and others, in all Courts of Law and elsewhere.

XV. Provided always, and be it further enacted, That it shall be lawful for the said Trustees to make the said Branch into, through, across, or over the several Lands, Hereditaments, or Premises of any Person or Persons who is or are or may be Owner or Owners or reputed Owner or Owners of Lands or Premises over which the same is or are set out and described in the said Map or Plan or Schedule to this Act as aforesaid, although such Lands, Hereditaments, or Premises, or the Name or Names of such Person or Persons, may happen to be erroneously described, or omitted or mis-stated, in the said Map or Plan or Book of Reference, in case it shall appear to any Two or more Justices of the Peace for the said Riding or County, and be certified by Writing under their Hands, that such Error or Omission proceeded from Mistake, or was not wilful.

Lands marked in the Plan may be used notwithstanding Errors in the Book of Reference.

XVI. Provided always, and be it further enacted, That the Powers and Authorities given by this Act shall not extend or be construed to extend to empower or authorize the said Trustees to take, pull down,

down, injure, or damage any Dwelling House or other Building, or to take in or make use of any Curtilage, Orchard, Garden, Yard, Park, Paddock, Lawn, Shrubbery, planted Walk or Avenue to a House, or any inclosed Ground planted or set apart as a Nursery for Trees, or any Part thereof respectively, without the Consent in Writing of the Owner or Proprietor thereof or other Person interested therein first had and obtained, except such as are mentioned in the Schedule to this Act annexed.

XVII. Provided also, and be it further enacted, That in case the said Trustees shall not purchase the Buildings, Lands, Tenements, and Hereditaments mentioned in the Schedule to this Act annexed, within the Space of Five Years from the passing of this Act, all the Powers granted by this Act for the purchasing, taking, or using the same, or such of them as shall not then have been purchased, shall cease and determine, save and except with the Consent of the Owners or Proprietors thereof for the Time being.

XVIII. And whereas it will be necessary to make the said intended new Branch of Road from *Booth Dean* to *Rochdale* over and across the *Rochdale* Canal in the Township of *Butterworth* in the said County of *Lancaster*; be it therefore enacted, That the said Trustees shall and they are hereby required, by and out of the Tolls, Funds, or Monies to be received or raised by virtue of this Act, to erect and build a good, firm, and substantial Bridge of Stone or Brick, or both, over and across the said Canal, and the Towing Path and Banks thereof, at the Point or Place denoted or shown upon or in the Map or Plan and Book of Reference deposited with the Clerk of the Peace for the said County of *Lancaster*, with proper and convenient Approaches to and from the same; and the Arch or Span of the said intended Bridge shall not be less than Thirty-six Feet (clear) between the Side Walls or Abutments thereof; and the under Side of the Key Stone in, or the Crown of the Arch of, the said Bridge, shall not be less than Twelve Feet in Height above the Top-water Level of the said Canal where such Bridge shall be erected or built; and the Springers of the same Bridge shall not be less than Nine Feet in Height above the Top-water Level of the said Canal there; and the Surface of the said Bridge shall be so made or completed that the Ascent of the Road over the said Bridge shall not exceed One Foot in Thirteen Feet, and the Fence on each Side of such Bridge shall not be less than Four Feet above the Surface of the Road; and the said Trustees shall at all Times for ever after such Bridge shall have been erected or built in manner aforesaid keep the same Bridge, or any future Bridge to be erected in lieu thereof, (and which shall be composed of the like Materials, and be of the like Dimensions and Capacity as are herein-before directed,) in good, perfect, and complete Repair.

XIX. Provided always, and be it further enacted, That the said Trustees shall give Fourteen Days previous Notice in Writing to the said Company of Proprietors, or to their Treasurer, Clerk, Engineer, or Agent for the Time being, when it shall be necessary, for the Pur-  
poses



poses of this Act, to alter the Course of or to draw off the Water in the said Canal; and shall not, in and by the Execution or Exercise of all or any of the Powers or Authorities hereby given or granted, do or occasion any Obstruction, Damage, or Injury to the said Canal, or to any of the Works of or belonging thereto, or to any Boats, Barges, or other Vessels navigating therein, or obstruct, prejudice, prevent, or hinder the full and free Use and Enjoyment of the said Canal, and the Cuts or Branches communicating therewith, and the Towing Paths, Wharfs, or other Works belonging thereto, save only such as shall be unavoidable, in the erecting or repairing the said Bridge.

XX. And be it further enacted, That this Act shall be deemed Public Act. and taken to be a Public Act, and shall be judicially taken notice of as such by all Judges, Justices, and others, without being specially pleaded.

XXI. And be it further enacted, That this Act shall commence Term of Act. and take effect from the passing thereof, and shall continue and be in force for Thirty-one Years, and from thence to the End of the then next Session of Parliament.
