## CHAPTER xxvi.

An Act to confirm a Provisional Order of the A.D. 1932.

Minister of Health relating to the borough of

Northampton.

[16th June 1932.]

WHEREAS under the provisions of the Public 38 & 39 Vict. Health Act 1875 the Minister of Health has c. 55. made a provisional order which needs confirmation by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Order of the Minister of Health which is set Order in out in the schedule to this Act is hereby confirmed and schedule shall have full validity and force.
- 2. This Act may be cited as the Ministry of Health Short title. Provisional Order Confirmation (Northampton) Act 1932.

## SCHEDULE.

## BOROUGH OF NORTHAMPTON.

Northampton Order.

Provisional Order altering certain local Acts.

WHEREAS the borough of Northampton is an urban district of which the mayor aldermen and burgesses acting by the council (in this order called "the corporation") are the urban authority for the purposes of the Public Health Act 1875 and the Northampton Corporation Water Act 1913 as amended by the Northampton Corporation Act 1922 is in force in the borough;

And whereas section 6 of the Act of 1913 authorised the corporation to make and maintain an impounding reservoir called Work No. 1 for the supply by them of water and by section 16 of that Act as amended by section 18 of the Act of 1922 a period of nineteen years from the fourth day of July nineteen hundred and thirteen was limited for the completion of that work;

And whereas the corporation have applied to the Minister of Health for the issue of a provisional order to amend the local Acts in the manner following:

Now therefore the Minister of Health in pursuance of the powers given to him by section 303 of the Public Health Act 1875 and of all other powers enabling him in that behalf hereby orders as follows:—

Short title and commencement. 1. This order may be cited as the Northampton Order 1932 and shall come into operation on the date of the Act of Parliament confirming it.

Interpretation.

## 2. In this order—

- "the Act of 1913" means the Northampton Corporation Water Act 1913;
- "the Act of 1922" means the Northampton Corporation Act 1922; and

"Work No. 1" means the work so numbered which is described in and authorised by section 6 of the Act of 1913.

3. Section 18 of the Act of 1922 so far as it relates to Work No. 1 shall have effect as if the words "nineteen years" had been inserted therein instead of the words "nine years."
