

### CHAPTER xxvi.

An Act to confirm a Provisional Order under the Land A.D. 1913. Drainage Act 1861 in the matter of a proposed drainage district in the Parishes of Holme St. Cuthbert Allonby and West Newton in the County of Cumberland.

[4th July 1913.]

WHEREAS the Board of Agriculture and Fisheries have made the Provisional Order set forth in the schedule hereto under the provisions of the Land Drainage Act 1861: 24 & 25 Vict. c. 133.

And whereas it is requisite that the said Order should be confirmed by Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. The Order as set out in the schedule hereto shall be and Order in schedule the same is hereby confirmed and all the provisions thereof shall confirmed. have full validity and force.
- 2. This Act may be cited as the Land Drainage (Holme Short title. St. Cuthbert) Provisional Order Confirmation Act 1913.

## LAND DRAINAGE ACT 1861.

#### PROVISIONAL ORDER.

In the matter of a proposed Drainage District in the Parishes of Holme St. Cuthbert Allonby and West Newton in the County of Cumberland.

- 1. The Board of Agriculture and Fisheries in pursuance of the powers vested in them by the Land Drainage Act 1861 and the Board of Agriculture and Fisheries Acts 1889 to 1909 do by this Provisional Order constitute the lands shown on a plan sealed by the Board and therein coloured pink a separate drainage district under the Land Drainage Act 1861.
  - 2. And they do further by this their Provisional Order make the following regulations with respect to the Drainage Board (that is to say):—
    - (A) The Drainage Board for the said district shall consist of twelve members:
    - (B) The following persons shall be members of the first Drainage Board:—

Joseph Smith Atkinson of Abbey Cowper Abbey Town in the county of Cumberland;

Thomas Barnes Carr of New House Silloth in the said county;

Joseph William Hayton of 9 Bank Street Carlisle in the said county;

Joseph Holliday of Holme View St. James' Road Carlisle aforesaid;

William Bell Maxwell of The Laurels Norfolk Road Carlisle aforesaid;

John Birbeck Paisley of Moss Side Kirkbride in the said county;

Stanley Dickinson Stanley-Dodgson of Somerset House A.D. 1913. Whitehaven in the said county;

John Williamson of Allonby in the said county;

Jonathan Williamson of Dockrayrigg House Wigton in the said county;

Thomas Williamson of Dubmill Allonby aforesaid; and William Fletcher Wilson of The Gale Abbey Town aforesaid:

- (c) The first meeting of the Drainage Board shall be summoned by a notice under the hands of any two or more members of the Drainage Board which shall be published in some newspaper circulating extensively in the said district and shall be posted at the principal entrance doors of the places of public worship in the said parishes of Holme St. Cuthbert Allonby and West Newton at least fourteen days before the day of meeting:
- (D) The qualification of subsequent members of the Drainage Board shall be as follows:—
  - (1) Six members shall be (A) proprietors each of not less than ten acres of land within the said district or (B) agents of proprietors each of not less than ten acres of land within the said district each of such agents acting under a written appointment and his principal not being a member of the Board;
  - (2) Six members shall be occupying tenants yearly or otherwise each of not less than twenty acres of land within the said district:

Provided that in the event of any deficiency in number in either class viz.—(1) proprietors or agents or (2) tenants qualified as aforesaid and willing to act as members such deficiency shall be made up by the election of persons qualified to act as members of the other class:

- (E) The members of the first Drainage Board shall vacate their offices on the first Thursday in September in the year following that in which this Provisional Order shall have been confirmed by Parliament:
- (F) The electors for members of the Drainage Board shall be the persons who were during the year immediately preceding such election liable to be rated to any drainage rate of the

said district leviable by the Drainage Board and have paid all such rates (if any) levied and due from them at the time of such election.
