

CHAPTER clxxv.

An Act to confirm certain Provisional Orders made by the A.D. 1914. Board of Trade under the Electric Lighting Acts 1882 to 1909 relating to Castlebar Lurgan and Waterford.

[7th August 1914.]

WHEREAS under the authority of the Electric Lighting Acts 1882 to 1909 the Board of Trade have made the several Provisional Orders set out in the schedule to this Act:

And whereas a Provisional Order made by the Board of ⁹ Edw. 7. Trade under the authority of the said Acts is not of any validity or force whatever until the confirmation thereof by Act of Parliament:

And whereas it is expedient that the several Provisional Orders made by the Board of Trade under the authority of the said Acts as set out in the schedule to this Act be confirmed by Act of Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. This Act may be cited as the Electric Lighting Orders Short title. Confirmation (No. 5) Act 1914.
- 2. The several Orders as amended and set out in the schedule Orders in to this Act are hereby confirmed and the same shall from and confirmed. after the passing of this Act have full validity and effect.

- 1. This Order may be cited as the Castlebar Electric Lighting Short title. Order 1914.
- 2. The provisions contained in the schedule to the Electric Incorporation Lighting (Clauses) Act 1899 (with the exception of section 83 of that Lighting schedule) are incorporated with and form part of this Order.

(Clauses) Act 1899.

3. The Undertakers for the purposes of this Order and within Undertakers. the meaning of section 2 of the schedule to the Electric Lighting (Clauses) Act 1899 are Messrs. J. Bourke and Sons electrical engineers of Ellison Street Castlebar in the county of Mayo.

4. The area of supply for the purposes of this Order and within Area of the meaning of section 4 of the schedule to the Electric Lighting supply. (Clauses) Act 1899 shall be the area which is described in the First Schedule to this Order and is more particularly delineated on the map deposited together with this Order at the Board of Trade by the Undertakers and signed by an assistant secretary to the Board of Trade.

5.—(1) The powers given by this Order shall not be exercised Powers not unless within twelve months or such extended period not exceeding in to be exercised unless the whole eighteen months as the Board of Trade may allow after the passing of the Act confirming this Order the Undertakers transfer the undertaking to a company to be registered under the Companies Acts tered com-1908 and 1913.

- (2) Within that period the Undertakers may transfer and the company to whom the transfer is to be made may take a transfer of the undertaking with the consent of and on such terms and conditions as may be approved by the Board of Trade by deed approved by that Board.
- (3) On such transfer the rights powers authorities obligations and liabilities of the Undertakers in respect of the undertaking shall be transferred to and may be exercised by and shall attach to the company to whom the transfer is made and that company shall subject to the provisions of this Order become the Undertakers for the purposes of this Order.
- (4) If the transfer has not been made before the expiration of the period limited in that behalf the Board of Trade may revoke this Order upon the expiration of that period.

Maximum prices.

7. The maximum prices which may be charged by the Undertakers as mentioned in section 32 of the schedule to the Electric Lighting (Clauses) Act 1899 are those stated in the Third Schedule to this Order.

Deposit.

8. The sum to be deposited or secured in pursuance of section 5 of the schedule to the Electric Lighting (Clauses) Act 1899 is one hundred pounds.

Commencement of Order. 9. Except for the purpose of enabling the said transfer to be made this Order shall not come into force until the day when the transfer takes effect and that day shall be the commencement of this Order.

Revision of price so as to balance revenue and expenditure.

- 8.—(1) The Undertakers shall so soon as the annual statement of accounts of the undertaking under this Order has been filled up in the form prescribed by the Board of Trade under the Electric Lighting Act 1882 publish in a newspaper circulating in the urban district a notification that such statement of accounts has been filled up and that copies of it can be obtained at the offices of the Undertakers at a price not exceeding one shilling a copy and such publication shall be in addition to and not in substitution for any publication prescribed by the Board of Trade under the Electric Lighting Act 1882.
- (2) The Undertakers shall on the expiration of the fifth complete financial year after they have commenced to supply electrical energy under this Order and on the expiration of each third succeeding year reconsider and if necessary revise and thereafter maintain the scales of prices charged for electrical energy under this Order so that so far as is reasonably practicable no contribution from the rates of the urban district will be required for the purpose of defraying the future expenses of the said undertaking during the next three years Provided nevertheless that—
 - (a) The prices to be charged shall not exceed the maximum prices which may be charged under this Order:
 - (b) The scales of prices so reconsidered and revised may be from time to time in like manner reconsidered and revised by the Undertakers.

 - (a) In respect of energy used by the Undertakers for street lighting or other lighting purpose a charge at any higher rate than that made to consumers using energy for lighting for the like hours of supply; or
 - (b) In respect of energy used by the Undertakers for any other purpose in connexion with their powers and duties as a local or sanitary authority a charge at any higher rate than that made to consumers using energy for similar purposes and for like hours of supply.
- 9. This Order shall come into force upon the day when the Act Commence-confirming this Order is passed and that day shall be the commence-ment of Order.

3. The Undertakers for the purposes of this Order and within the Undertakers. meaning of section 2 of the schedule to the Electric Lighting (Clauses) Act 1899 are the mayor aldermen and burgesses of the county borough of Waterford.

4. The area of supply for the purposes of this Order and within Area of the meaning of section 4 of the schedule to the Electric Lighting supply. (Clauses) Act 1899 shall be the area which is described in the First Schedule to this Order and is more particularly delineated on the map deposited together with this Order at the Board of Trade by the Undertakers and signed by an assistant secretary to the Board of Trade.

5.—(1) Subject to the provisions of this Order the Undertakers Purchase and may enter upon and take all or any part of the lands described in Part 1. of the Second Schedule to this Order and delineated on the plan ting station. deposited together with this Order at the Board of Trade.

- (2) For the purpose of the acquisition of the said lands the provisions of the Lands Clauses Acts which relate to the purchase and taking of lands otherwise than by agreement and to the entry upon lands by the promoters of the undertaking are incorporated with this Order.
- (3) The Undertakers after they shall have acquired the said lands may use the same for the purposes of the undertaking authorised by this Order and may thereon erect construct maintain use and work a station or stations together with all such buildings engines batteries dynamos accumulators and other plant machinery apparatus works and conveniences as may be necessary or suitable for generating electricity for the purpose of giving a supply under this Order.
- (4) The Undertakers may also on the expiration or sooner determination of a certain indenture of lease dated the twelfth day of January one thousand eight hundred and twenty-eight and made between the Undertakers of the one part and Mathew Poole and John Harris of the other part use the land described in Part II. of the

Period for compulsory purchase of land.

6. The powers of the Undertakers for the compulsory purchase of land for the purposes of this Order shall cease after the expiration of five years from the commencement of this Order.

Power to break up railway. 7. Subject to the provisions incorporated with this Order the Undertakers are specially authorised by this Order to break up the railway mentioned in the Third Schedule to this Order.

Works across River Suir. 8. The Undertakers may erect lay down and maintain electric mains and works across the River Suir under and upon the bed and foreshores thereof Provided that Section 14 of the Schedule to the Electric Lighting (Clauses) Act 1899 incorporated with this Order shall as regards the Postmaster-General apply to such electric mains and works as if the said river were a street within the meaning of the said Section.

Compulsory works.

9. The streets throughout which the Undertakers are to lay down suitable and sufficient distributing mains for the purposes of general supply within a period of two years after the commencement of this Order as mentioned in section 21 of the schedule to the Electric Lighting (Clauses) Act 1899 are those mentioned in the Fourth Schedule to this Order.

- (2) The Undertakers shall on the expiration of the fifth complete financial year after they have commenced to supply electrical energy under this Order and on the expiration of each third succeeding year reconsider and if necessary revise and thereafter maintain the scales of prices charged for electrical energy under this Order so that so far as is reasonably practicable no contribution from the rates of the borough will be required for the purpose of defraying the future expenses of

 - (a) In respect of energy used by the Undertakers for street lighting or other lighting purpose a charge at any higher rate than that made to consumers using energy for lighting for the like hours of supply; or
 - (b) In respect of energy used by the Undertakers for any other purpose in connexion with their powers and duties as a local or sanitary authority a charge at any higher rate than that made to consumers using energy for similar purposes and for like hours of supply.

12. If the Undertakers obtain the consent of the Board of Trade Supply to under subsection (1) of section 5 of the Electric Lighting Act 1909 to railways for incidental the supply by them within their area of supply of electricity for the purposes. purposes of haulage or traction on any railway situate partly within and partly without that area or for the purposes of lighting vehicles used on any such railway they may so supply electricity to be used for purposes incidental to the working or lighting of such railway other than the purposes aforesaid.

13. This Order shall come into force upon the day when the Act Commenceconfirming this Order is passed and that day shall be the commence-ment of ment of this Order.
