

CHAPTER xxxi.

An Act to confirm certain Provisional Orders made by the A.D. 1917.

Board of Trade under the Electric Lighting Acts 1882
to 1909 relating to Epsom Rural District (Extension)
Featherstone Garforth Horbury Otley Penistone and Rawdon.

[2nd August 1917.]

WHEREAS under the authority of the Electric Lighting 45 & 46 Vict. Acts 1882 to 1909 the Board of Trade have made the c. 56. 51 & 52 Vict. several Provisional Orders set out in the schedule to this Act: c. 12. 9 Edw. 7.

And whereas a Provisional Order made by the Board of c. 34. Trade under the authority of the said Acts is not of any validity or force whatever until the confirmation thereof by Act of Parliament:

And whereas it is expedient that the several Provisional Orders made by the Board of Trade under the authority of the said Acts as set out in the schedule to this Act be confirmed by Act of Parliament:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:—

- 1. This Act may be cited as the Electric Lighting Orders Short title. Confirmation Act 1917.
- 2. The several Orders as amended and set out in the schedule Orders in to this Act are hereby confirmed and the same shall from and schedule after the passing and subject to the provisions of this Act have full validity and effect.

For protection of West Riding County Council.

- 3.—(1) Nothing in the Featherstone Electric Lighting Order 1917 the Garforth Electric Lighting Order 1917 the Horbury Electric Lighting Order 1917 the Otley Electric Lighting Order 1917 or the Rawdon Electric Lighting Order 1917 confirmed by this Act shall in any way limit or affect the powers of the county council of the West Riding of Yorkshire (in this section referred to as "the county council") to rebuild alter widen or repair the structure of any bridge upon which any work by any of the said Orders authorised shall be constructed or impose upon the county council any liability which was not by law imposed upon them prior to the commencement of the said Orders.
- (2) If at any time the county council require to carry out works for rebuilding altering widening or repairing any bridge which might involve interference with any portion of the undertakings by any of the said Orders authorised they shall prior to the commencement of such works give the Undertakers one month's notice of their intention to carry out such works and if in order to avoid interruption to the supply by the Undertakers of electrical energy it is in the opinion of the county council necessary to temporarily remove the mains and other electrical appliances belonging to the Undertakers from such bridge then the Undertakers shall (and they are hereby authorised so to do) at their own expense temporarily carry their cables and wires across such bridge overhead or at the side thereof in such a manner as will not be a danger or inconvenience to the public or unreasonably interfere with the works to be carried out by the county council.
- (3) When the rebuilding altering widening or repairing of such bridge shall have been completed the Undertakers shall have the same rights and powers with regard to such bridge and its approaches as they had before the works were carried out.
- (4) If any dispute arises between the county council and the Undertakers with regard to this section the same shall be determined by an arbitrator to be appointed on the application of either party by the Board of Trade.

Provisional Order granted by the Board of Trade under the Electric Lighting Acts 1882 to 1909 to the South Metropolitan Electric Tramways and Lighting Company Limited in respect of the Parishes of Cuddington and Ewell in the Rural District of Epsom in the County of Surrey.

Short and collective titles.

1. This Order may be cited as the Epsom Rural District Electric Lighting (Extension) Order 1917 and the Epsom Rural District (Cheam) Electric Lighting Order 1904 (hereinafter called "the principal Order") and this Order may be cited together as the Epsom Rural District Electric Lighting Orders 1904 and 1917.

Undertakers.

2. The Undertakers for the purposes of the principal Order and this Order and within the meaning of section 2 of the schedule to the Electric Lighting (Clauses) Act 1899 are the South Metropolitan Electric Tramways and Lighting Company Limited whose registered office is at Electric Railway House Broadway Westminster and which was formerly called the County of Surrey Electrical Power Distribution Company Limited.

Added area of supply.

3. Subject to the provisions incorporated with the principal Order there shall be added to the area of supply for the purposes of the principal Order the area (hereinafter called "the added area") which is described in the First Schedule to this Order and is more particularly delineated on the map deposited at the Board of Trade by the Undertakers and signed by an assistant secretary to the Board of Trade.

Provisions as to application of Electric Lighting Acts.

4. In the application within the added area of the provisions of the schedule to the Electric Lighting (Clauses) Act 1899 as incorporated with the principal Order the expression "the commencement of the Special Order" where used in the schedule shall mean the commencement of this Order and in the application of section 2 of the Electric Lighting Act 1888 to the undertaking of the Undertakers within the added area the expression "the date of the passing of the Act confirming such Provisional Order" shall mean the commencement of this Order.

Compulsory works.

5. The streets and parts of streets within the added area throughout which the Undertakers are to lay down suitable and sufficient distributing mains for the purposes of general supply within a period of two years after the commencement of this Order as mentioned in section 21 of the schedule to the Electric Lighting (Clauses) Act 1899 are those mentioned in the Second Schedule to this Order.

6. Subject to the provisions incorporated with the principal Order the Undertakers are specially authorised to break up the parts of streets not repairable by the local authority within the added area which are mentioned in the Third Schedule to this Order.

If the Undertakers obtain the consent of the Board of Trade Supply to under subsection (1) of section 5 of the Electric Lighting Act 1909 to railways &c. the supply by them within their area of supply of electricity for the purposes. purposes of haulage or traction on any railway tramway or canal situate partly within and partly without that area or for the purposes of lighting vehicles and vessels used on any such railway tramway or canal they may so supply electricity to be used for purposes incidental to the working or lighting of such railway tramway or canal other than the purposes aforesaid.

- (3) From the date on which the purchase takes effect the undertaking shall vest in the council freed from all debts mortgages or other similar obligations of the Undertakers or attaching to the undertaking and the powers of the Undertakers in relation to the supply of electricity

5. Subject to the provisions incorporated with this Order the Undertakers are specially authorised by this Order to break up the streets not repairable by the local authority which are mentioned in the Second Schedule to this Order.

Compulsory works.

6. The streets and parts of streets throughout which the Undertakers are to lay down suitable and sufficient distributing mains for the purposes of general supply within a period of two years after the commencement of this Order as mentioned in section 21 of the schedule to the Electric Lighting (Clauses) Act 1899 are those mentioned in the Third Schedule to this Order.

- (2) The amount to be paid on any such purchase shall be determined in default of agreement by arbitration The Board of Trade may determine any other question which arises with reference to the purchase and in default of agreement as to the date on which the purchase is to take effect may fix that date.
- (3) From the date on which the purchase takes effect the undertaking shall vest in the council freed from all debts mortgages or other similar obligations of the Undertakers or attaching to the undertaking and the powers of the Undertakers in relation to the supply of electricity within the district under this Order or the principal Act shall absolutely cease and determine and shall vest in the council.
- (4) The power of purchase given by this section shall be in addition to and not in derogation of the power of the council to purchase under section 2 of the Electric Lighting Act 1888 as a local authority within the meaning of that section.
