An Act for the more easy and speedy Recovery of Small Debts within the Town of Warrington, and several other Places adjacent thereto, in the Counties of Lancaster and Chester.

[29th July 1839.]

HEREAS the Township of Warrington in the County of Lancaster, and the several Townships or Places of Cuerdley, Penketh, Great Sankey, Burtonwood, Newton-in-Mackerfield, Haydock, Golborne, Kenyon, Southworth-with-Croft, Winwickwith-Hulme, Houghton-with-Middleton and Arbury, Poulton-with-Fearnhead, Woolston-with-Martinscroft, and Rixton-with-Glazebrook, in the said County of Lancaster, and Lymm, Thelwall, Grappenhall, Latchford, Appleton, Higher Walton, and Lower Walton, in the County of Chester, being severally situate near or adjoining the said Township of Warrington, and within the Distance of Six Miles or thereabouts therefrom, are very populous, and there are many considerable Manufactories and Collieries in some of the Townships or Places aforesaid which employ great Numbers of People, who, along with divers other Persons residing or trading therein, contract Small Debts which in the whole amount yearly to a very large Sum of [Local.]Money,

Money, and although many of such Debtors are well able to pay their respective Debts, they often refuse to pay the same, by reason of which their respective Creditors are either obliged to forego their respective Debts, or for the Recovery thereof to incur an Expence sometimes far exceeding and in all Cases disproportionate to the Sums in dispute: And whereas it would be a great Benefit to the Inhabitants of the several Townships or Places before mentioned, and tend much to the Support and Protection of useful Credit within the same, if an easy and speedy Method of recovering Small Debts within the said Townships and Places were provided, and to be established and held at the Town of Warrington aforesaid; but inasmuch as the same cannot be effected without the Aid and Authority of Parliament, May it therefore please Your Majesty that may be enacted; and be it enacted by the Queen's most Excellent Majesty, by and with the Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, Constitution and by the Authority of the same, That the Judge and his Successors, of the Court. to be appointed as herein-after mentioned, are hereby constituted a Court of Justice for the Recovery of Small Debts within the several Townships or Places aforesaid, by the Name of the "Warrington Court of Requests."

Judge of the Court to be appointed.

II. And be it enacted, That it shall be lawful for the Lord Chancellor, Lord Keeper or Lords Commissioners of the Great Seal of that Part of the United Kingdom of Great Britain and Ireland called England, for the Time being, at any Time after the passing of this Act, and from Time to Time when and as any Judge to be appointed under this Act shall die, resign, or be removed, to appoint any Person to be Judge of the said Court who either shall have been called to the Bar and shall have practised as a Barrister for at least Seven Years, or who shall be an Attorney of one of Her Majesty's Superior Courts of Common Law at Westminster, and shall have been certified by Three or more Judges of the said Superior Courts to the Lord Chancellor, Lord Keeper or Lords Commissioners of the Great Seal, for the Time being, as a fit Person to be appointed Judge of the said Court; and it shall be lawful for the Lord Chancellor, Lord Keeper or Lords Commissioners of the Great Seal, for the Time being, if he or they shall think fit, to remove any Judge of the said Court for Misbehaviour, or upon a Petition to be preferred to him or them for that Purpose by the Justices of the County of Lancaster acting in and for the Hundred of West Derby in the said County, in Quarter Sessions assembled, or by Three Justices of the said County residing within the Townships or Places aforesaid, or some of them; and every such Judge shall be entitled to hold his Office during his good Behaviour therein, or until he shall die, resign, or be so removed.

Where and when Courts shall be holden.

III. And be it enacted, That at some convenient Place within the Borough of Warrington the said Court shall be holden under the Authority of this Act, at such Times as the said Judge shall appoint, but so that the Intervals shall, between the holding of any Two such Courts, be in no Case more than Two Months.

IV. And be it enacted, That in case of the Illness or unavoidable In case of Absence of the Judge of the said Court it shall be lawful for such Judge to appoint some other Person, being a Barrister of Seven Years standing, or an Attorney of one of Her Majesty's Superior Courts at Deputy. Westminster who has been in practice Seven Years at the least, to act as his Deputy during such Illness or unavoidable Absence; and every Person so appointed shall, during the Time for which he shall be so appointed, have the same Power of deciding, determining, pronouncing Judgment, making Orders, and issuing Executions, in any Actions brought before him in the said Court, as the Judge by whom he shall have been so appointed.

V. And be it enacted, That the said Justices of the Peace acting in Appointment and for the Hundred of West Derby in the said County of Lancaster, in Quarter Sessions assembled, shall from Time to Time, with the other Offi-Approbation of the Judge of the said Court for the Time being, appoint a fit Person, being an Attorney of one of Her Majesty's Superior Courts of Law at Westminster, to be Clerk of the said Court, who shall not be the Judge nor the Partner of the Judge of the said Court; and the said Justices may remove such Clerk upon sufficient Cause, to be allowed by the Lord Chancellor, Lord Keeper or Lords Commissioners of the Great Seal, and appoint another Person in his Room; and the Judge of the said Court for the Time being shall from Time to Time appoint, and at Pleasure may remove, the Bailiffs and inferior Officers of the said Court: Provided always, that in case Twenty-one Days shall intervene between the passing of this Act, or between the Death, Removal, or Resignation of any Clerk of the said Court, and the then next General Quarter Sessions of the Peace in and for the Hundred of West Derby in the County Palatine of Lancaster, it shall be lawful for the Justices acting in Petty Sessions at Warrington aforesaid, and they are hereby required, from Time to Time to appoint (with the Approbation of the Judge of the said Court) some fit Person, qualified as aforesaid, to be Clerk of the said Court until the Appointment of a Clerk by the said Court of Quarter Sessions as aforesaid.

VI. And be it enacted, That in case of the Illness or unavoid- Clerk may able Absence of the said Clerk it shall be lawful for the said Clerk appoint a (with the Approbation of the Judge) to appoint from Time to Time a Deputy. Deputy, being an Attorney of one of the Superior Courts at Westminster, to act for him in the Office of Clerk of the said Court during such Illness or during such unavoidable Absence, and to remove such Deputy at his Pleasure; and such Deputy, during the Time for which he shall be so appointed, shall have the like Powers as if he were Clerk of the said Court for the Time being.

VII. And be it enacted, That the said Justices of the said Justices to Hundred of West Derby, in Quarter Sessions assembled, shall appoint a appoint a fit Person to be Treasurer of the said Court, who shall Treasurer. not be a Judge, Clerk, or other Officer of the Court; and such Justices may remove any such Treasurer, if they shall see Occasion so to do, and appoint another Person in his Room: Provided always, that Notice of the Intention to propose that any Treasurer be removed

removed shall be given at the Sessions before that at which the Motion for his Removal shall be made.

Clerk and Treasurer not to be the same Person.

VIII. Provided always, and be it enacted, That it shall not be lawful for the Clerk of the said Court, or the Partner of such Clerk, or any Person in the Service or Employ of such Clerk or of his Partner, to act as Treasurer for the Purposes of this Act, nor for the Treasurer of the said Court, nor the Partner of such Treasurer, or any Person in the Service or Employ of such Treasurer or of his Partner, to act as Clerk of the said Court; and if any Person shall accept both the Offices of Clerk and Treasurer for the Purposes of this Act, or if any Person, being the Partner of any such Clerk, or a Person in the Service or Employ of any such Clerk or of his Partner, shall accept the Office of Treasurer, or shall act as Deputy of the Treasurer, or in any Manner officiate for the Treasurer, or being the Partner of any such Treasurer, or a Person in the Service or Employ of any such Treasurer or of his Partner. shall accept the Office of Clerk in the Execution of this Act, or shall act as Deputy of such Clerk, or in any Manner officiate for such Clerk, every such Person so offending shall for every such Offence forfeit and pay the Sum of Fifty Pounds to any Person who shall sue for the same, in any of Her Majesty's Courts of Record at Westminster, by Action of Debt or on the Case, or by Bill, Suit, or Information, wherein no Essoign or Protection shall be allowed.

Upon the Removal of any Treasurer his Successor may sue for any Balance remaining in his Hands.

IX. And be it enacted, That if any Person, having resigned or having been removed from the Office of Treasurer of the said Court. shall neglect, within Twenty-one Days after Notice, to account for and pay to the Treasurer of the said Court for the Time being. or to such Person as he shall appoint to receive the same, all such Sums of Money as shall remain in his Hands applicable to the Purposes of this Act, it shall be lawful for the Treasurer of the said Court for the Time being, by his Name and Description of Office, to sue for and recover the same from such Person, with full Costs, Charges, and Expences of and attending the Action, in any of Her Majesty's Courts of Record at Westminster, by Action of Debt, in which Action it shall be sufficient for such Treasurer to declare as for Money had and received to the Use of such Treasurer for the Purposes of this Act; and the Court in which the Action shall be brought may, at the Instance of either of the Parties, refer the Account in dispute, in a summary Manner, to be audited by any Officer of the Court or other fit Person, who may examine both Plaintiff and Defendant upon Oath (which Oath the said Referee shall have Power to administer); and upon the Report of the Referee, unless either of the Parties shall show good Cause to the contrary, the Court may make a Rule either for the Payment of such Sum as upon the Report shall appear to be due, or for staying the Proceedings in the Action, and upon such Terms and Conditions as to the Court shall appear reasonable, or the Court may order Judgment to be entered up by Confession for such Sum as upon the Report shall appear to be due.

X. And be it enacted, That in case of the Death of any Person Mode of Produring the Time that he shall be holding the Office of Treasurer, against the or after he shall have resigned or been removed from such Office, Representathe Treasurer for the Time being may, by his Name and Description tives of a of Office, sue for and recover from the Executors and Administrators of such Person deceased all such Sums of Money as shall have been remaining in his Hands applicable to the Purposes of this Act, by an Action of Debt in any of Her Majesty's Courts of Record at Westminster, in which Action it shall be sufficient for the Plaintiff to declare that the Deceased was indebted to the Plaintiff for Money had and received to his Use for the Purposes of this Act, or that the Deceased died possessed of Money had and received for the Purposes of this Act, whereby an Action hath accrued to the Plaintiff to demand and have the same from such Executors or Administrators; and the like Action may be brought against any Executors or Administrators of Executors or Administrators; and in all such Actions the Defendant or Defendants may plead in like Manner, and avail themselves of the like Matters in defence, as in any Action founded upon simple Contracts of the original Testator or Intestate; and the Court may refer the Account in dispute to be audited by any Officer or Person, and may proceed upon the Report of such Referee in like Manner as is herein-before mentioned.

XI. And be it enacted, That the Clerk of the Court shall issue Duties of the all Summonses, Warrants, Precepts, and Writs of Execution, and Clerk and register all Orders and Judgments of the said Court, and keep an Bailiffs. Account of all such Summonses, Executions, and other Processes of the Court, and shall take charge of and keep an Account of all Court Fees and Fines payable or paid into Court, and of all Suitors Money paid into and out of Court, and shall enter an Account of all such Fees, Fines, and Monies in a Book to be kept by him for the Purpose, which Book shall be open to the Inspection of all Parties desirous of inspecting the same, on Payment of One Shilling for each such Inspection; and the Bailiffs of the said Court shall serve all such Summonses, and execute all such Orders, Warrants, Precepts, and Writs; and a List of the Names and Places of Abode of every Bailiff appointed to execute the Processes of the Court shall be put up in a conspicuous Place in the Court and in the Clerk's Office.

XII. And be it enacted, That the Treasurer of the said Court Treasurer to shall from Time to Time, quarterly or oftener, audit or settle the audit the Accounts of the said Clerk and other Officers of the said Court, and Accounts. receive the Balance of such Monies as such Clerk and other Officers may have received under this Act, belonging to the Suitors of the said Court, or applicable to the General Fund herein-after mentioned, and shall make all such Payments as it shall be requisite to make in accordance with the Provisions of this Act, and for carrying the same into effect.

XIII. And be it enacted, That the Treasurer, and also every Treasurer Clerk, Bailiff, and Officer of the said Court, who shall receive any and Officers Monies in the Execution of their Duty, shall give Security for such Security. [Local.] 27 P Sum

Sum and in such Manner and Form as the Justices of the said Hundred of West Derby in Quarter Sessions assembled shall see Reason to direct, for the due Performance of their several Offices, and for the due Payment of all Monies received by them under any Provision of this Act.

For paying Expences of Act and providing Court House.

XIV. And be it enacted, That the Treasurer of the said Court shall, as soon as conveniently may be, pay off and discharge the Costs and Expences attending the passing and Execution of this Act, and shall, when requisite, under the Direction of the Justices of the said Hundred of West Derby in Quarter Sessions assembled, provide suitable Buildings, with all necessary Appurtenances, for holding the said Court therein under the Authority of this Act, and for the Offices necessary for carrying on the Business of the said Court; and all Lands, Tenements, and Hereditaments belonging to the said Court shall vest in the Treasurer for the Time being, and in his Successors in that Office, in Trust for the Purposes of this Act; and for the Purpose of defraying the Expences of this Act, and providing any Buildings, Lands, or Hereditaments for the Purposes aforesaid, it shall be lawful for the said Treasurer to borrow and take up at Interest such Sums of Money as he shall find to be necessary, the Amount thereof and Rate of Interest thereon in each Case being first allowed by the Justices of the said Hundred of West Derby in Quarter Sessions assembled; and the Treasurer may enter into and execute such Securities as may be required for securing Repayment of the Sums borrowed, with Interest for the same, out of the General Fund herein-after mentioned, and shall enter in a Book to be kept for that Purpose the Names of the several Persons by whom any Sum shall be advanced for the Purpose aforesaid, in the Order in which each Sum shall be advanced, and every such Sum shall be paid off in the same Order.

General Fund.

XV. And be it enacted, That for raising a Fund for paying off the Costs and Expences of this Act, and providing a Court House or Offices, and any Money borrowed for the Purposes aforesaid, and the Interest due in respect thereof, the Clerk of the said Court shall demand and receive, from the Plaintiff in every Suit brought in the said Court, a Sum of Money after the Rate of One Shilling in the Pound on the Amount of the Debt claimed, which Sum shall be paid in all Cases by the Plaintiff upon Suit brought in the Court; and the Clerk of the Court shall keep an Account of all the Sums so raised, and shall pay over the same to the Treasurer of the said Court, and the Amount thereof shall accumulate, and form a Fund to be called "The General Fund of the Warrington Court of Requests," and shall be applied, in the first place, in Payment of all Costs, Charges, and Expences of preparing and passing this Act, and, subject thereto, and in providing the said Court House and Offices, and in Payment of the Money borrowed for the Purposes aforesaid, and the Interest thereof, in such Manner as the Judge of the said Court shall direct.

Clerk to have charge of the Court.

XVI. And be it enacted, That the Clerk of the said Court shall have the Care of the Court House and Offices of the said Court, and shall

shall appoint and have Power to dismiss the necessary Servants for taking charge of such Court House and Offices, and shall, with the Approbation of the said Judge, make all necessary Contracts or otherwise provide for repairing and furnishing, and for cleaning, lighting, and warming, the Courts, Buildings, and Offices thereunto belonging, and for supplying the said Courts and Offices with Books and Stationery, and all other Necessaries for holding the said Courts, and the Expences thereby incurred shall be paid out of the said General Fund.

XVII. And be it enacted, That there shall be payable to the Fees to be Judge of the said Court, and to the Clerk and Bailiffs thereof, on taken accordevery Proceeding in the said Court, such Fees as are set down ing to the in the Schedule to this Act annexed, or as shall be from Time to Time directed to be taken by the Justices of the said Hundred of West Derby in Quarter Sessions assembled, and none other; and a Table of such Fees shall be hung up in some conspicuous Place in the said Court and in the Clerk's Office provided for entering Plaints; and the Fees on every Proceeding shall be paid, in the first instance, by the Plaintiff or Party on whose Behalf the same shall be taken, on or before such Proceeding, and the Fees upon Executions shall be paid into Court at the Time of the Issue of the Warrant of Execution, and shall be paid by the Clerk of the Court to the Bailiff upon Return of the Warrant of Execution, and not before.

XVIII. And be it enacted, That the Treasurer of the said Court, Treasurer, and all other Officers and Servants employed in or about the said &c. to be paid Court, exclusively of the Judge, Clerk, and Bailiffs as aforesaid, by Salaries. shall receive Salaries for their respective Services, such Salaries to be fixed from Time to Time by the Judge of the said Court, and to be paid out of the said General Fund herein provided as aforesaid.

XIX. And be it enacted, That the Clerk and Treasurer of the said Fees and Court shall from Time to Time, as often as they respectively shall monies recovered to be be required so to do by the Judge of the said Court, deliver to him accounted a full Account in Writing of the Fees and Monies received by them for to Jusrespectively under the Authority of this Act, and a like Account tices. of all Fines paid to the Court under this Act, accounting for and deducting the reasonable Expences of levying the same, and any Allowance which the Judge may have made out of any such Fine in pursuance of the Powers herein-after contained, and a like Account of the Monies paid into and received out of Court by the Defendants and Plaintiffs in the said Court, under any Orders or Decrees of the Court, or under any Levy made under Process of the said Court, and of the Balance then remaining in Court belonging to the Plaintiffs or Defendants in the said Court; and shall also, on or before the Thirty-first Day of January in every Year, deliver into the Office of the Clerk of the Peace of the said County a like Account, verified by a Declaration of the Accuracy thereof taken before some Justice of the said County of Lancaster, of all such Fees, Fines, and Monies as aforesaid, after making such Deductions as aforesaid, as shall have been received or paid into Court between the First Day of January of the preceding Year

Year and the Thirty-first Day of *December* of the same Year; and such last-mentioned Account shall be laid before the Justices of the said Hundred of West Derby, in Quarter Sessions assembled, at the first Quarter Sessions after the said Thirty-first Day of January, and shall be examined by them; and in case it shall be found that the said General Fund is more than sufficient for defraying all Charges upon it, or the Fees hereby given to the Judge, or the Clerk, Bailiffs, or Crier of the Court, shall appear to be more than sufficient, it shall be lawful for such Justices to lessen the Amount of the Sum of Money to be paid for raising the said General Fund, or of the Fees to be taken in the said Court, in such Manner as to them shall seem fit; and it shall be lawful for the said Justices, in case such Fund or Fees, or any of them, shall be found to be insufficient for the respective Purposes to which the same are applicable, again to increase such Sums of Money or Fees, so that the Scale of Fees given in the Schedule to this Act be not in any Case exceeded.

Jurisdiction

XX. And be it enacted, That after the Appointment of a Judge of of the Court. the said Court under this Act all Actions for the Recovery of Debts (except such as are herein-after mentioned) where the Sum sought to be recovered does not exceed the Sum of Fifteen Pounds, and is claimed from any Person liable to be summoned as a Defendant under the Provisions of this Act, may be heard and decided by the Judge of the said Court, wherever the Cause of Action may have arisen or the Plaintiff may reside: Provided always, that the said Judge shall not decide or determine any such Action in which the Title to any Lands or Hereditaments, or to any Tithe, Toll, Fair, Market, or Franchise, shall be in question, or arising out of or relating to any Will or Settlement: Provided also, that all such Actions shall be determined according to the Laws and Statutes of that Part of the United Kingdom of Great Britain and Ireland called England for the Time being, except in so far as such Laws and Statutes are altered or varied by this Act.

Processes of the Court to be under Seal.

XXI. And be it enacted, That there shall be made a Seal of the said Court, and all Summonses and other Processes issuing out of the said Court shall be sealed or stamped with the Seal of the Court; and every Person who shall forge the Seal or any Process of the said Court, or who shall attempt to serve or enforce any such forged Process, knowing the same to be forged, or to take the Body or Goods of any Person maliciously under any false Colour or Pretence of the Process of the said Court, shall be guilty of Felony.

Suits to be by Plaint.

XXII. And be it enacted, That it shall be lawful for any Person who now hath or hereafter shall have any Cause of Action over which the said Court has Jurisdiction under this Act against any Person residing, trading, or dealing within any of the several Townships or Places aforesaid, to enter in the Office of the Clerk of the said Court a Plaint in Writing, stating the Parties to and the Substance of the Action intended to be brought, and thereupon a Summons shall be issued under the Seal of the Court, which shall be in Substance according to the Form in the Schedule to this Act annexed, according to the Nature of the Plaint, and shall be served

on the Defendant Fourteen Days before the Day on which the Court shall be holden at which the Cause shall be tried; and Delivery of such Summons to the Defendant, or Delivery thereof to his Wife or Servant or any Inmate at his Dwelling House or usual Place of Abode, trading, or dealing, shall be deemed good Service; and every such Summons shall be read over or explained, at the Time of the Service thereof, to the Defendant or other Person on whom the same shall be served as aforesaid.

XXIII. And be it enacted. That no such Summons shall be issued Clerk not to unless the Plaintiff shall, at the Time of entering his Plaint, deposit with the Clerk of the Court, for every Claim not exceeding Twenty Deposit is Shillings, the Sum of One Shilling, and for every Claim exceeding made. Twenty Shillings, One Twentieth Part thereof, omitting any Sum less than Sixpence in estimating such Twentieth Part; and if upon the Day of the Return of any such Summons, or at any Continuation or Adjournment of the said Court, or of the Cause for which the said Summons shall have been issued, the Plaintiff shall not appear, either in Person or by some other Person on his Behalf, or appearing shall not make Proof of his Demand to the Satisfaction of the Court, it shall be lawful for the Judge to award to the Defendant a Part or the Whole of such Deposit Money by way of Costs and Satisfaction for his Trouble and Attendance, with such further Sum as the Judge in his Discretion shall think fit, and to order and compel the Plaintiff to pay such further Sum by such Ways and Means as any Debt ordered to be paid by the said Court can be recovered; and so much of the said Deposit Money as shall not be awarded to the Defendant shall be returned, on Demand, to the Plaintiff.

XXIV. And be it enacted, That it shall not be lawful for any Demands not Plaintiff to divide any Cause of Action into Two or more Suits, for to be split. the Purpose of bringing the same within the Jurisdiction of the said Court, but any Plaintiff having Cause of Action above the Value of Fifteen Pounds, for which a Plaint might be entered under this Act if not above the Value of Fifteen Pounds, may abandon the Excess, and thereupon the Plaintiff shall, on proving his Case, recover to an Amount not exceeding Fifteen Pounds; and the Judgment of the Court upon such Plaint shall be in full Discharge of all Demands in respect of such Cause of Action.

XXV. And be it enacted, That it shall be lawful for any Person Minors may under the Age of Twenty-one Years to prosecute any Suit in the sue for said Court under this Act for any Sum of Money not exceeding Wages. Fifteen Pounds which may be due to him or her for Wages as a menial or other Servant, in the same Manner as if he or she were of full Age.

XXVI. And be it enacted, That no Privilege shall be allowed to No Privilege any Person on account of his being an Attorney or Solicitor of any allowed. of Her Majesty's Courts of Record at Westminster or of any other Court, to exempt him from the Jurisdiction of the Court hereby established.

XXVII. And

One of several Persons liable may be sued.

XXVII. And be it enacted, That where any Plaintiff shall have any Debt or Demand recoverable under this Act against Two or more Persons, Partners in Trade, or otherwise jointly answerable, it shall be sufficient if One of such Persons be served with the Process as herein-before directed; and Judgment may be obtained and Execution issued against such Person, notwithstanding others jointly liable may not have been served or sued; reserving always to the Person against whom Execution may issue any Right which he may have to demand Contribution from any other Person jointly liable with him.

WhatActions alone.

XXVIII. And be it enacted, That the Judge of the said Court shall shall be tried be the sole Judge to determine all Actions brought in the said Court, by the Judge and all Matters and Questions of Fact and Law relating thereto, except where the Amount claimed shall exceed the Sum of Five Pounds and either of the Parties shall require a Jury to be summoned as herein-after mentioned.

In Actions for Sums exceeding Five Pounds, either Party may require a Jury.

XXIX. And be it enacted, That in all Actions where the Sum of Money sought to be recovered shall exceed Five Pounds it shall be lawful for the Plaintiff or Defendant to require a Jury to be summoned to try the said Action, and in every such Case a Jury shall be summoned according to the Provisions herein-after contained to try the Action: Provided always, that the Party requiring a Jury shall, Five Days at least prior to the holding of the Court at which the said Cause shall be tried, give Notice to the Clerk of the said Court that he requires a Jury to be summoned, and the said Clerk shall cause such Notice, given either by the Plaintiff or Defendant, to be communicated to the other Party to the said Action, either by Post or by causing the same to be delivered at his usual Place of Business or Residence.

Parties requiring a Jury to make a Deposit.

XXX. And be it enacted, That every Party requiring any Jury to be summoned shall, at the Time of giving the Notice hereby required, and before he shall be entitled to have such Jury summoned, pay to the Clerk of the said Court such Sum of Money as the Judge shall by any General Order of the said Court direct, for or towards the Payment of the Expences of the said Jury, and the same shall be considered as Costs in the Cause: Provided always, that each Juror shall not receive less in respect of each Day's Attendance than the Sum of Five Shillings; and if the Sums of Money paid by the Parties requiring Juries shall not be sufficient for that Purpose the Deficiency shall be made up out of the said General Fund of the said Court.

Notice to be given of special Defences.

XXXVI. And be it enacted, That all Defendants in the said Court shall be allowed to set off any Debt or Demand claimed to be due to them from the Plaintiffs, or to set up by way of Defence and to claim and have the Benefit of any Statute of Limitations, or any Discharge under any Statute of Bankruptcy or any present or future Act for the Relief of Insolvent Debtors: Provided always, that no such Defence shall be admitted on the Hearing or Trial of any Cause under the Jurisdiction given by this Act unless Notice thereof in Writing shall have been given to the Clerk of the said Court, or left at his Office, Five Days at least previous to the Hearing of the said Cause; and the said Clerk shall communicate the same to the Plaintiff by the Post, or by causing the same to be delivered at his usual Place of Abode or Business.

XXXVII. And be it enacted, That if any Bailiff or Officer of the Remedies said Court, acting under colour or pretence of the Process of the against said Court, shall be guilty of Extortion or Misconduct, or shall not Bailiffs and duly pay or account for any Money levied by him under the otherOfficers. duly pay or account for any Money levied by him under the Authority of this Act, it shall be lawful for the said Court, at its Sitting, if the Party aggrieved shall think fit to complain thereto. to inquire into such Matter in a summary Way, and for that Purpose to summon and enforce the Attendance of all necessary Parties, if resident within any of the Townships or Places aforesaid, or within Twenty Miles of the Place where the said Court is holden, and to make such Order thereupon for the Repayment of any Money extorted, or for the due Payment of any Money so levied as aforesaid, and for the Payment of such Damages and Costs to the Parties aggrieved, as the Court shall think just; and in default of Payment of any Money so ordered to be paid by such Bailiff or Officer within the Time specified for the Payment thereof in such Order, it shall be lawful for the Judge of the said Court, by Warrant under his Hand and Seal, to cause such Sum to be levied by Distress and Sale of the Goods of the Offender, together with the reasonable Charges of such Distress and Sale, and in default of such Distress to commit the Offender to any Common Gaol or Prison in the said County of Lancaster for any Period not exceeding Three Calendar Months.

LXII. And be it enacted, That if any Clerk, Bailiff, or other Officers Officer employed in putting this Act or any of the Powers thereof taking any in execution shall exact, take, or accept any Fee or Reward what- the Fees soever, other than and except such Fees as are or shall be appointed allowed, to and allowed respectively as aforesaid, for or on account of any thing be disdone or to be done by virtue of this Act, or on any Account what- charged. soever relative to putting this Act into execution, every such Person so offending shall, upon Proof thereof before the said Court, or upon Verdict or Judgment had against him in such Action as next herein-after mentioned, be for ever incapable of serving or being employed under this Act in any Office of Profit or Emolument, and shall also be liable for Damages as herein provided.

Fees besides

LXIII. And be it enacted, That if any Claim shall be made in Provision for respect of any Goods or Chattels taken or intended to be taken in the Protec-Execution under any Process of the said Court, or in respect of the Officers of Proceeds or Value thereof, by any Person not being the Party against the Court whom

whom such Process has issued, and if the Claim so made shall not exceed the Sum of Fifteen Pounds, it shall be lawful for the Judge of the said Court, upon Application of the Officer charged with the Execution of such Process, and as well before as after any Action brought against such Officer, to summon before the said Court as well the Party issuing such Process as the Party making such Claim, if resident, trading, or dealing within any of the several Townships or Places aforesaid, and thereupon to adjudicate and determine upon such Claim, and to make such Order between the Parties in respect thereof, and of the Costs of the Proceedings, as to the said Judge shall seem fit, and to enforce such Order in like Manner as any Order made in any Suit brought in such Court; and if the Amount of the Claim made as aforesaid shall exceed the Sum of Fifteen Pounds, or if the Party making such Claim shall not be residing, trading, or dealing within any of the Townships or Places aforesaid, it shall be lawful for such Officer, if any Action has been brought in any of Her Majesty's Superior Courts at Westminster, to apply to such Court, or to one of the Judges of such Court, and if no such Action has been brought, then to apply to any one of Her Majesty's Superior Courts, or to any Judge of the said Courts; and upon such Application being so made the Court or Judge to which or to whom it shall be made shall use all the Powers for the Adjustment of such Claim, and for the Relief and Protection of such Officer, as on the Application of any Sheriff or other Officer in the Case of Process issuing out of such Court by virtue of an Act passed 1 & 2 W. 4. in the Second Year of His late Majesty, intituled An Act to enable Courts of Law to give Relief against adverse Claims made upon Persons having no Interest in the Subject of such Claims: Provided always, that if it shall appear to such last-mentioned Court that the Value of the Goods or Chattels claimed as aforesaid, or of the Rights of the Party making any Claim in respect thereof, do not exceed the Sum of Fifteen Pounds, and that the Party making such Claim was, at the Time of making the same, residing, trading, or dealing within any of the Townships or Places aforesaid, the Court to which such Application as aforesaid shall be made, or any Judge thereof, may order the Party so claiming to pay the Costs of all the Proceedings had as aforesaid in the Superior Court.

Concurrent Jurisdiction with the Courts at Courts.

LXIV. And be it enacted, That all Actions and Proceedings which before the passing of this Act might have been brought in any of Her Majesty's Courts at Westminster, or in Her Majesty's Westminster Court of Common Pleas at Lancaster, or in the County Court of and the other the Sheriff of Lancaster or Chester, or in any Hundred Court, Court Leet, Court Baron, Manor Court, or other Court whatsoever having any Jurisdiction within the Limits of the Court constituted by this Act, may still, notwithstanding this Act and the Powers hereby granted, be brought and determined in any such Court, at the Election of the Party suing or proceeding, in the same Manner as if this Act had not been passed.

For the Recovery and Application of Penalties.

LXV. And be it enacted, That all Penalties, Forfeitures, and Fines by this Act imposed or authorized to be imposed (the Manner of levying, recovering, and applying whereof is not hereby otherwise particularly

particularly directed) shall, upon Proof before any Justice or Justices of the Peace having Jurisdiction in the County or Place where the Offender shall reside or be, of the Offence by him committed, either by his Confession or by the Oath of any credible Witness or Witnesses, be levied, together with the Costs attending the Information and Conviction, by Distress and Sale of the Goods and Chattels of such Offender, by Warrant under the Hand and Seal of such Justice or Justices; and the Overplus (if any), after such Penalties, Forfeitures, and Fines, and the Charges of such Distress and Sale, are deducted, shall be returned, upon Demand, unto the Owner of such Goods and Chattels; and the Monies arising by such Penalties, Forfeitures, and Fines respectively, when paid and levied, and by any other Penalties and Fines by this Act inflicted or authorized to be imposed, when paid and levied, (if not otherwise directed to be applied by this Act,) shall be from Time to Time paid to the Clerk of the said Court, and shall be applied in aid of the General Fund of the said Court; and in case such Penalties, Forfeitures, and Fines respectively shall not be paid forthwith upon Conviction, then it shall be lawful for such Justice or Justices to order the Offender so convicted to be detained in safe Custody until Return can be conveniently made to such Warrant of Distress, unless the said Offender shall give sufficient Security, to the Satisfaction of such Justice or. Justices, for his, her, or their Appearance before him or them on such Day as shall be appointed for the Return of such Warrant of Distress, such Day not being more than Eight Days from the Time of taking any such Security, and which Security such Justice or Justices is and are hereby empowered to take by way of Recognizance or otherwise, as to him or them shall seem right and proper; but if upon the Return of such Warrant it shall appear that no sufficient Distress can be had thereupon, or in case it shall appear to the Satisfaction of such Justice or Justices, either by the Confession of the Offender or otherwise, that he hath not Goods and Chattels within the Jurisdiction of such Justice or Justices sufficient whereon to levy all such Penalties and Forfeitures, Costs and Charges, such Justice or Justices may, at his or their Discretion, without issuing any Warrant of Distress, commit the Offender to the Common Gaol or Prison of the County or Place where such Offender shall live or reside, there to remain for any Time not exceeding Three Calendar Months, unless such Penalties, Forfeitures, and Fines, and all reasonable Charges attending the Recovery thereof, shall be sooner paid and satisfied.

LXVI. And be it enacted, That in all Cases in which by this Act any Penalty or Forfeiture is made recoverable by Information Summons in before a Justice of the Peace, it shall be lawful for any such Justice as the Recovery aforesaid to whom Complaint shall be made of any Offence against of Penalties. this Act to summon before him the Party complained against, and on such Summons to hear and determine the Matter of such Complaint, and on Proof of the Offence to convict the Offender, and to adjudge him to pay the Penalty or Forfeiture incurred, and to proceed to recover the same, although no Information in Writing shall have been exhibited-before-him; and all such Proceedings-by-Summonswithout Information in Writing shall be as valid and effectual to [Local.]

Form of Conviction.

LXVII. And be it enacted, That in all Cases where any Conviction shall be had for any Offence or Offences committed against this Act the Form of Conviction may be in the Words or to the Effect following; (that is to say,)

BE it remembered, That on this to wit. Distress not to be unlawful for Want of Form. LXVIII. And be it enacted, That where any Distress shall be made for any Sum of Money to be levied by virtue of this Act, the Distress itself shall not be deemed unlawful, nor the Party or Parties making the same be deemed a Trespasser or Trespassers, on account of any Defect or Want of Form in the Information, Summons, Conviction, Warrant of Distress, or other Proceeding relating thereto, nor shall the Party or Parties distraining be deemed a Trespasser or Trespassers from the Beginning, on account of any Irregularity which shall afterwards be done by the Party or Parties so distraining, but the Person or Persons aggrieved by such Irregularity shall or may recover full Satisfaction for the special Damage in an Action upon the Case.

Plaintiff not to recover after Tender of Amends, &c.

LXIX. And be it enacted, That no Plaintiff shall recover in any Action against any Person for any thing done in pursuance of this Act if Tender of sufficient Amends shall have been made before such Action brought, or if after Action brought a sufficient Sum of Money shall have been paid into Court, with Costs, by or on behalf of the Defendant.

This Act to cease on the passing of any general Act.

LXX. Provided always, and be it enacted, That at the Expiration of Six Calendar Months next after any general Act shall be passed for the Recovery of Small Debts, and the Operation of which General Act shall be inconsistent with the Powers given by this Act as to the said several Townships or Places in this Act mentioned, every Clause, Matter, and Thing in this Act contained which shall extend or be construed to extend to give the said Court or Judge any local or separate Jurisdiction shall cease and determine; and no Judge or Officer of the said Court appointed under this Act shall be deemed to be entitled to any Compensation for the Loss of his Office by the reason of the passing of such general Act.

LXXI. And

LXXII. And be it enacted, That in construing this Act the Construction Word "Person" shall be taken to comprehend a Body Politic, of certain Corporate, or Collegiate, as well as an Individual; and that every Words in Word importing the Singular Number shall, where necessary to this Act. give full Effect to the Enactments herein contained, be deemed to extend and be applied to several Persons or Things as well as one Person or Thing; and that every Word importing the Masculine Gender shall, where necessary, extend and be applied to a Female as well as a Male; and that where the Word "Partner" shall be used the same shall be held to apply only to Partnership in the usual Business of the Parties referred to, and not to Shareholders in any Joint Stock Undertaking.

LXXIII. And be it enacted, That this Act may be altered or Act may be repealed during the present Session of Parliament, either by any Act altered passed for the express Purpose of altering or repealing the same, during the or by any Act of which the Provisions shall be inconsistent with Session. the Provisions herein contained.

LXXIV. And be it enacted, That this Act shall be deemed and Public Act. taken to be a Public Act, and shall be judicially taken notice of as such by all Judges, Justices, and others,
