# The Fylde Marine Conservation Zone Designation Order 2013

Made 21st November 2013

Coming into force 12th December 2013

The Secretary of State thinks it desirable to make this Order for the purpose of conserving the marine habitat specified in article 4(1).

The Secretary of State has had regard to any obligations under EU or international law that relate to the conservation or improvement of the marine environment in accordance with section 123(5) of the Marine and Coastal Access Act 2009(a).

The Secretary of State has—

- (a) published notice of the proposal to make this Order in accordance with section 119(2) and (3) of that Act; and
- (b) consulted persons who are likely to be interested in, or affected by, the making of this Order in accordance with section 119(4) of that Act.

The Secretary of State makes the following Order in exercise of the powers conferred by sections 116(1), 117(1), (2) and (7), 118(1) and (6), and 123(1) of that Act.

### Citation and commencement

**1.** This Order may be cited as the Fylde Marine Conservation Zone Designation Order 2013 and comes into force on 12th December 2013.

#### Interpretation

2. In this Order—

"co-ordinate" means a co-ordinate on the World Geodetic System 1984(b); and

"the Zone" means the area designated by article 3(1) as a marine conservation zone.

#### Area designated

- **3.**—(1) The area described in paragraph (2) is designated as a marine conservation zone.
- (2) The area is the marine area enclosed by the 14 boundary lines which are described in Schedule 1, in each case by reference to—
  - (a) the co-ordinates of the points joined by the line; and
  - (b) a topographical description of the line.
  - (3) In paragraph (2), "marine area", in relation to the area designated, means—
    - (a) any area of seabed or other land (whether or not covered by water) within that area; and
    - (b) all of the water covering any part of that seabed or other land.
  - (4) The Zone may be referred to as "the Fylde Marine Conservation Zone".

### Protected feature and conservation objective

- **4.**—(1) The protected feature of the Zone is the broadscale marine habitat subtidal sand.
- (2) The conservation objective of the Zone is that the protected feature—
  - (a) so far as already in favourable condition, remain in such condition; and
  - (b) so far as not already in favourable condition, be brought into such condition, and remain in such condition.
- (3) In paragraph (2), "favourable condition" means that, within the Zone—
  - (a) the extent of the protected feature is stable or increasing; and
  - (b) its structures and functions, its quality, and the composition of its characteristic biological communities are such as to ensure that it remains in a condition which is healthy and not deteriorating.
- (4) In paragraph (3)(b), the reference to the composition of the characteristic biological communities of the protected feature includes a reference to the diversity and abundance of species forming part of or inhabiting it.
- (5) For the purposes of paragraph (3)(b), any temporary deterioration in condition is to be disregarded if the protected feature is sufficiently healthy and resilient to enable its recovery.
- (6) For the purpose of determining whether the protected feature is in favourable condition within the meaning of paragraph (3), any alteration to that feature brought about entirely by natural processes is to be disregarded.

### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order designates an area as a marine conservation zone (which may be referred to as "the Fylde Marine Conservation Zone"). The area designated is defined in article 3 and Schedule 1. The protected feature of that Zone is the broadscale marine habitat specified in article 4(1), namely subtidal sand. The conservation objective of that Zone is set out in article 4(2) to (6).
