Advisory bodies

[^{F1}38 Composition etc. of advisory committees.

[^{F2}(1) ^{F3}.....

(1A) The chairman and other members of each regional advisory committee shall be appointed by the appropriate forestry authority.

(1B) A chairman or member appointed under subsection ^{F4}... (1A) shall hold and vacate office in accordance with the terms of the instrument by which they are appointed.]

(3) Each regional advisory committee shall consist of not less than seven nor more than [^{F6}twelve] members, and of those members (other than the chairman) not less than four shall be persons appointed by the [^{F7}appropriate forestry authority] after consultation with organisations appearing to them to represent the interests of owners of woodlands and timber merchants respectively and organisations concerned with the study and promotion of forestry.

(4) ^{F8}... [^{F9}The appropriate forestry authority may pay to the members of a regional advisory committee,] such allowances as they may with the consent of the Treasury determine.
