- 7 The court by which a person is convicted of an offence under section ^{F1}[^{F2}21A,]^{F3}[^{F3}22(4), 23(1)]^{F2}[^{F2}21A(1), 21A(1A), 22(3)]^{F4}. . .]^{F5}, 24(4) or 24ZA(1)] of this Act may make such order as it thinks fit as to the forfeiture or disposal of the air weapon or ammunition in respect of which the offence was committed.
