45 Promotion by local authorities, of the welfare of old people. E+W+S

- (1) A local authority may with the approval of [^{F3}the Secretary of State], and to such extent as he may direct shall, make arrangements for promoting the welfare of old people.



- (1) The powers exercisable in relation to a patented invention under section 46 of the ^{M6}Patents Act 1949 by a government department or a person authorised by a government department shall include power to make, use, exercise and vend the invention for the production or supply of drugs and medicines required for the provision of pharmaceutical services, general medical services or general dental services, and prescribed for the purposes of this section by regulations made by [^{F19}the Secretaries of State respectively concerned with health in England, in Wales and in Scotland] acting jointly; and any reference in that section or in section 47 or 48 of the Patents Act 1949 to the services of the Crown shall be construed accordingly.
- (2) In the foregoing subsection references to pharmaceutical services, general medical services and general dental services shall be construed as referring to services of those respective kinds under [^{F20}Part II of the ^{M7}National Health Service Act 1977], Part [^{F21}II] of the ^{M8}National Health Service (Scotland) Act [^{F21}1978] or the corresponding provisions of the law in force in Northern Ireland or the Isle of Man.
- (3) The power conferred by subsection (1) above to make regulations shall be exercisable by statutory instrument which shall be subject to annulment in pursuance of a resolution of either House of Parliament.




