Provision of general Application

59 Extension of power of user by Crown of patented invention to user for certain health services.

- (1) The powers exercisable in relation to a patented invention under section 46 of the ^{M1}Patents Act 1949 by a government department or a person authorised by a government department shall include power to make, use, exercise and vend the invention for the production or supply of drugs and medicines required for the provision of pharmaceutical services, [^{F1}local pharmaceutical services,]^{F2}primary medical services, [^{F3}general medical services, personal medical services, [^{F4}primary dental services,] general dental services or personal dental services], and prescribed for the purposes of this section by regulations made by [^{F5}the Secretaries of State respectively concerned with health in England, in Wales and in Scotland] acting jointly; and any reference in that section or in section 47 or 48 of the Patents Act 1949 to the services of the Crown shall be construed accordingly.
- (2) In the foregoing subsection references to pharmaceutical services, general medical services and general dental services shall be construed as referring to services of those respective kinds under [^{F6}Part II of the ^{M2}National Health Service Act 1977]^{F7}(in the case of pharmaceutical services)] , Part [^{F8}II] of the ^{M3}National Health Service (Scotland) Act [^{F8}1978]^{F9}(in the case of pharmaceutical services or general dental services)] or the corresponding provisions of the law in force in Northern Ireland or the Isle of Man.

(3) The power conferred by subsection (1) above to make regulations shall be exercisable by statutory instrument which shall be subject to annulment in pursuance of a resolution of either House of Parliament.

(1) If the sheriff (acting, if he deems it necessary, ex parte) is satisfied, on a written certificate issued by the [F125designated medical officer] for any district—

- (a) that there is reason to believe that some person in the district is or has been suffering from an infectious disease, or, though not suffering from such a disease, is carrying an organism that is capable of causing it, and

 - (b) any person to whom by reason of his official position any information obtained as aforesaid is communicated, discloses that information to any person,
- he shall, unless such disclosure was made in the performance of his duty, be guilty of an offence against this section.
