

# Northern Ireland Constitution Act 1973

## **1973 CHAPTER 36**

### PART V

#### MISCELLANEOUS AND SUPPLEMENTARY

#### 35 Crown Solicitor for Northern Ireland.

- (1) As from the appointed day there shall be a Crown Solicitor for Northern Ireland appointed by the [<sup>F1</sup>Advocate General for Northern Ireland after consultation with the Attorney General for Northern Ireland].
- [<sup>F2</sup>(1A) A person is not qualified for appointment as Crown Solicitor unless he is—
  - (a) a member of the Bar of Northern Ireland of at least ten years'standing; or
  - (b) a solicitor of the [<sup>F3</sup>Court of Judicature] of at least ten years' standing.]
  - (2) The Crown Solicitor shall hold office on such terms and conditions as may be determined by the [<sup>F4</sup>Advocate General for Northern Ireland].
  - [<sup>F5</sup>(3) The Crown Solicitor—
    - (a) must make his services available to any Minister or department of the Government of the United Kingdom; and
    - (b) may make his services available to any Northern Ireland Minister or Northern Ireland department or any other public body or holder of public office.]
    - (4) The remuneration of, and other expenses incurred in connection with, the Crown Solicitor shall be defrayed out of moneys provided by Parliament.
