#### PART I

#### GENERAL

##### *Establishment of Tribunal*

6 [F1(1)] [F2Subject, in the case of the president of a tribunal, to sub-paragraph (2) below]The members of a tribunal shall hold office for such period as may be determined at the time of their respective appointments and shall be eligible for reappointment but, notwithstanding that the period for which a member was appointed has not expired,

- (a) a member may, at any time by not less than one month's notice in writing to his appointor, resign his office;
- (b) the appointor of a member may declare the office of that member vacant on the ground that he is unfit to continue in his office; and
- (c) if any member [F3is the subject of a bankruptcy restrictions order [F4or an interim bankruptcy restrictions order, or a debt relief restrictions order or interim debt relief restrictions order under Schedule 4ZB of the Insolvency Act 1986]] or, in Scotland, if sequestration of a member's estate is awarded [F5..., his office shall thereupon become vacant.

[F6(2) No appointment of a person to be the president of a tribunal shall be such as to extend beyond the day on which he attains the age of [F775].]
